## THE OPPOSITION WAXED ELOQUENT

### On The Inspiring Subject Of Dredging In The Lakes But Were Checked By A Point Of Order By Dr Pugsley

OTTAWA, April 14—(Special)—With Easter adjournment day not distant the Commons heard much oratory today. Mr. Borden was in New York and Dr. Sproule led the Opposition. Mr. Bennett claimed the prices paid for dredging in the great lakes was too large and asked for certain original tenders. Mr. Pugsley asked if the matter was before the public committee could it be discussed before reported to the House, and the Speaker ruled in the negative. Mr. Bennett said prices were far too high at certain points and objected to

the extension of contracts on the present basis. Mr. Pugsley regretted the department did not have dredging plants of its own on the Lakes as a great deal of dredging had to be done by contracts. The integrity of the inspectors had to be relied on to look after dredging contracts and it was unfortunate that some of these men had acted improperly, however they had been dismissed as soon as found out. Mr. Pugsley explained at length certain points in connection with dredging.

## ACTRESS REFUSED TO DON TIGHTS

### New York Managers Must Pay Miss Lee \$4,700 for Dismissing Her

NEW YORK, April 13—A verdict of \$4,700 was awarded by a jury in the supreme court today to an actress who was discharged by a theatrical manager because she refused to appear on the stage in tights. The plaintiff was Henrietta Lee Morrison, who is known to the stage as Henrietta Lee and the defendants Hurlig & Seamon, proprietors of a Harlem burlesque theatre. Miss Lee and her husband, Charles P. Morrison, were engaged by Hurlig & Seamon for a season in a musical comedy under a contract which provided that they were to receive \$8,950. At the end of three months the manager directed Miss Lee to make certain changes in her costume, which would necessitate her appearance on the stage in tights. When she refused to make the changes directed, she and her husband were discharged. They brought suit for breach of contract and a jury after fifteen minutes deliberation, awarded them damages to the full amount sued for, minus the amount they earned after their discharge.

## PROVINCIAL LEGISLATURE

### The House Occupied Yesterday Chiefly With The Passing Of Estimates

Yesterday in the Legislature, was nearly all devoted to the passing of the estimates. In the morning, it is understood that before the doors were opened there was some discussion over the manner in which the previous days proceedings were entered in the Journal. Mr. Mathieson objected, that although mention was made of the Newbery incident, it was not stated that the Speaker refused to allow cross-examination. The journals were confirmed by a party vote. The Premier when the House met in the afternoon, as Chairman of the Committee appointed to present the regarding grants to land to those who fought in South Africa, presented to the House the address to the Lieutenant Governor requesting His Honor to present the address to the Federal Government. After this the House went into Committee of the whole and resumed the consideration of the estimates. All afternoon and until after midnight was the House engaged in passing various estimates. On the sums appropriated for Public Works there was a vigorous assault by the Opposition, who seemed to have an endless list of questions for the Commissioner of Public Works to answer. By slow degrees the estimate was at last got through but similar resistance was encountered on the other items—ferries, bridges, roads, etc., coming in for an avalanche of questions that nearly buried the estimates out of sight. There was a rumor at the first of the week that the House would probably prorogue before this week ended but this rosetate hope appears to be in imminent danger of being dispelled. It is now exactly seven weeks since the House met. House stands adjourned till 10 a. m. today.

## ANARCHIST IS FOUND GUILTY

### And Sentenced To Death For Attempting To Kill King Alfonso In Madrid

BARCELONA, April 14—(Special)—Jean Rull and three of his accomplices, who had been on trial here for complicity in the recent series of bomb explosions and Anarchist outrages, were yesterday found guilty and sentenced to death. Evidence adduced showed that Rull and his associates were the authors of attempts to assassinate King Alfonso at Madrid and Paris and of various outrages in different parts of Spain.

## NEW HEAD FOR ROTHESAY COLLEGE

### Rev. W. R. Hibbard Coming from Quebec Province to Be Head Master

ST. JOHN, April 13—Rev. W. R. Hibbard of Montreal, at present head master of the grammar school at Berthier-en-haut (Que.), will be the new principal of Rothesay College, the educational institution carried on at Rothesay under the Church of England synod. A telegram has been received from Rev. Mr. Hibbard accepting the position. He will succeed Principal Moore and will arrive in June to take charge at the close of the summer term. Rev. Mr. Hibbard is a native of Montreal, and is about thirty-eight years of age. He was educated at Bishop's College, Lennoxville (Que.), and graduated from there with B. A. in 1895, also taking first class mathematical honors and winning the General Nicholls scholarship. After a divinity course, Mr. Hibbard took the degree of D.D., and later M.A., from the same college. He was assistant master at Bishop's College school from 1899 to 1901, and then was senior mathematical master in Trinity College school Port Hope (Ont.), until 1905. In that year he was appointed head master of the grammar school at Berthier-en-haut, and leaves there to come to Rothesay. Rev. Mr. Hibbard comes very highly recommended by the Bishop of Toronto, and the Bishop of Montreal as one well fitted to carry on educational matters. He is also regarded as generally well qualified for the position at Rothesay.

## HON JOHN LOVITT OF YARMOUTH, N.S.

### Died On Monday After A Long Illness Of Cancer

YARMOUTH, April 14—(Special)—Hon. John Lovitt, Senator, aged 76 died yesterday afternoon after an illness of several months of cancer. He came here from Ottawa about a month ago and has since been confined to his residence. Although it was generally felt that his death could not long be deferred yet the end came suddenly at 3.30 o'clock. During the past years he had been operated upon several times, but without allaying the seriousness of his malady.

## ONE FINLANDER KILLED ANOTHER

### At Railway Camp And Escapes To The Woods, The Result Of A Quarrel

QUEBEC, April 14—(Special)—Word has been received to the effect that a murder has been committed at one of the construction camps on the Transcontinental. Two Finlanders, engaged on construction work in the vicinity of La Tuque, became engaged in a quarrel and shots were exchanged, with the result that one received such injuries he died from the effects shortly after. The man who fired the fatal shot escaped to the woods and at latest accounts had not been captured.

## GAVE WIFE FIVE DOLLARS A YEAR

### William Adams Acknowledges That It Was Not quite Enough

MONTREAL, April 13.—Five dollars, in three instalments, represents what William Adams, waiter, during the past twelve months has contributed towards the support of his wife and four children—the oldest of whom is nine years and the youngest eighteen months. William pleaded guilty before Recorder Weir to the charge of non-support, and had been remanded for sentence. March last year the furniture in the Adams house was seized for rent. In August Adams paid \$3 to his wife and several weeks later paid two sums of \$1 each. Since then he has paid nothing—in fact, has rarely been seen by his wife or children. He has shifted from restaurants to restaurants, apparently unable to hold a job as waiter in any. The four children have been kept alive by the combined efforts of their mother and grandmother. The latter sixty-five year old, works by the day and the former obtains work now and again through the medium of the day Nursery, with whom she leaves two of the children. The youngest child is kept in the Sheltering Home. Very seldom has he combined income of the two women for a week reached more than \$6 to \$7 and out of this they had to pay \$3 for lodgings.

## GOVERNOR WAS ASSASSINATED

### While Receiving Delegation Of Students Who Openly Rejoice Over The Bloody Deed Which Causes Great Excitement

VIENNA, April 14—(Special)—The whole of Galicia is in a state of feverish excitement over the assassination at Lemberg, April 12, of Count Andreas Potocki, governor of that province, by Ruthenian students while the Count was giving an audience to delegation of young Ruthenians in the Austrian Parliament. They declare that such crimes are of national necessity in order to put a stop to Polish oppression, while the Ruthenian students of Vienna openly rejoice over the assassination. Last night thousands of Poles participated in the Anti-Ruthenian demonstrations.

## PIRATES HOARD FOUND IN VILLAGE

LISBON, April 13—Treasure trove secreted by Portuguese buccaners in the seaside village of Paradelha in a remarkable manner. The village is being slowly washed away by the action of the sea and buildings have been undermined from time to time. A storm of more than usual severity swept the coast on Thursday, and portion of the foreshore at Paradelha was washed away. According to the Secolo, treasure of various kinds was thus exposed to the astonished fishermen, who first believed that it had been sent to them miraculously. There were many ancient gold and silver doubloons, jewelled crosses, finger rings of quaint antique pattern ear-rings, gold and silver medallions, portions of silver censers, and other fragments of church plate. All the people in the region hurried to the spot, armed with picks and spades, and have since been digging feverishly for treasure. Some of them have been rewarded with further discoveries. One man secured gold coins valued at nine hundred dollars. All the male inhabitants have deserted their work, and none of the fishermen has left port since the first discovery was made.

## CONFERENCE TO ALLOW DANCING

NEW YORK, April 13—Young men and women of the Wesleyan faith may one day be permitted to dance if their consciences permit, for yesterday the New York Methodist Episcopal Conference adopted a resolution memorializing the highest body of the church, which meets next month in Baltimore, to repeal the famous section 248, which prohibits terpsichorean and other amusements. Section 248 has been assailed again and again, and early in the proceedings of the present conference it was proposed that the section be referred to the general conference as a subject for abolition. There remains a chapter of advice which advises young people against dancing, card playing, thestregroing and the like, and leaves the question in their own consciences. If the general conference adopts the suggestion of the New York body, which is the most influential in the church, the younger generation probably will have more leeway in amusements. Under the present conditions class meetings, Sunday school strawberry festivals and church socials are about all the diversions permitted under the canon. The resolution to put an end to section 248 of the Book of Discipline was abollished, seven members dissenting, although many of the ministers did not vote one way or the other.

## STERN LESSON TO ALL DIRECTORS

### The Monetary Times Says The Yarmouth Bank Decision Should Frighten Them Into Doing Their Duty

TORONTO, April 13—The Monetary Times, discussing at length editorially the Yarmouth Bank decision, says: "Once upon a time the director was cartooned as a gentleman of excessive avordupois with facial features of the jovial kind. Before many years he will be portrayed as a mighty hard working business man. The time-worn wall concerning directors who do not direct has other homes than Canada, a cry which girdles the world. It reaches ears wherever men get together with capital. The average director has been educated upon the fashionable etiquette of directorates. Directors' names for use on a prospectus are secured too easily. The man whose name is worth anything at all is often the man to loan it with the least persuasion. A halo of false modesty surrounds the director. He seldom looks into affairs because he might be labelled inquisitive. His reputation would be inquisitive. His reputation would be unenviable amongst his colleagues. If a few directors must be dummy figures, the majority must be in form for active service. They will have to do the work of the figureheads. If the crash comes, the whole board will share the bitterns. The decision of the Supreme Court may frighten a thousand directors into doing their duty. Now that the result of the appeal is known, it is the duty of the committee of five in charge of the Ontario Bank affairs to proceed with the prosecution against the former directors of that Bank."
