

VOTERS OF ONT. GO TO POLLS TO-DAY

(Canadian Press) TORONTO, Oct. 22.—Whether the Ontario Temperance Act, passed in 1915, under which it is illegal to import or purchase intoxicating liquors for beverage purposes, is to continue or whether the comparatively open sale of intoxicants under provincial government control shall be established is the question that citizens of Ontario will decide through the ballot box tomorrow when a plebiscite of the province will be taken. Tomorrow's plebiscite will make the eighth time in the past thirty years that the citizens of the province have been called upon to express their approval or disapproval of liquor prohibitory legislation. The present law was introduced eight years ago as a war measure and was confirmed in 1919 by a plebiscite which gave a dry majority of 407,289 in a total vote of 1,147,785. Two years later another plebiscite was taken on the private importation of liquor and by a majority of 168,874 out of nearly a million votes cast the amendment to prohibit importation from wet provinces and states was adopted. A spirited campaign has been conducted by both the wets and dries and heavy polling is expected tomorrow. At present Ontario is surrounded by wet provinces, British Columbia, Alberta, Saskatchewan and Manitoba having all returned to sale of liquor under government control, as well as the province of Quebec to the east of Ontario. The ballot paper will ask two questions. "Are you in favor of the continuance of the Ontario Temperance Act" and "Are you in favor of the sale as a beverage of beer and spirituous liquors in sealed packages under government control." The system which the provincial government is expected to introduce should the O. T. A. be defeated is similar to that now existing in five other provinces in Canada.

P. C. CAMPAIGN FOR ORPHAN-AGE OPENS

Prince County wing of the Province wide campaign to raise \$50,000 in one week for Prince Edward Island Protestant Orphanage opened its activities last night with an enthusiastic meeting in the Y. M. C. A., Summerside. The Alberton Division and the O'Leary Division, headed respectively by William C. Lawson, and A. J. Matheson, opened their work in those communities simultaneously with the Summerside Division. Six teams of five women each, under the chairmanship of Miss Carrie Holman, and five teams of five men each headed by Charles R. Rogers, Vice Chairman commanding the Prince County, and nine members of the executive committee for Summerside attended the opening supper. The meeting started at six-thirty o'clock and before it closed the names of more than five hundred prospects had been taken by the volunteer workers. Vice Chairman Rogers was the principal speaker. In addition to a prayer by Harold Lee Stephens, of Fredericton, Courtenay Barber of the executive committee spoke briefly. Mayor Johnson, Summerside, L. A. Moore, and A. C. Saunders, Mr. Stephen advised the volunteer corps as to the best means of procuring subscriptions. Mr. Rogers and the other speakers urged Summer side Division to procure more subscriptions and more money than its Charlottetown divisions. The Rev. G. S. Mitchell, of the Presbyterian Church, J. J. Inman, editor of the Summerside Journal, and H. H. Simpson, Secretary of the Y.M.C.A., were interested guests of the executive committee. The first rally supper of the Summerside Division will be held tonight in the Y.M.C.A., the supper being arranged by the women volunteer workers. The Prince County campaign will continue until next Thursday, the thirtieth.

ONTARIO BOND SCANDAL CASE IS COMMENCED

Prosecution Opens With Evidence of Chief Investigator Into Alleged Crime FORMER HOME BANK WITNESS HEARD Compares Coupons Cashed by Smith With Those Deposited by Defendant. TORONTO, Oct. 22.—Evidence given by Major A. E. Nash, chartered accountant, of the firm of Clarkson, Gordon & Dillworth, who has come into prominence in connection with his investigation for the Crown into the affairs of the Home Bank was the feature of today's hearing of the Smith-Jarvis Peppall trial before Chief Justice Meredith and jury in the criminal assize court, the major part of which was the chief expert investigator for the Crown into the alleged provincial bond scandal. Mr. Nash submitted to the court a statement showing coupons of bonds cashed by Peter Smith, Ontario, and alleged by the Crown to have been shipped by Brown Brothers of New York to A. H. Peppall, of the firm of Jarvis & Company, bond brokers of Toronto. In previous evidence it had been shown that the head of the Jarvis firm, Aemilius Jarvis, had deposited with the Brown Brothers part of the profit obtained from the sale of duty free bonds to the Ontario government. The witness stated that he had examined the list of securities contained in a letter under date of June 3, 1920, from Brown Brothers to A. H. Peppall and had compared the securities with the coupons attached to Peter Smith's deposits in the bank at Stratford, the result he found that a large number of the bonds enumerated in the letter agreed with the numbers of the bonds from which the coupons had been taken. The par value of the bonds from which the coupons had been cashed was \$184,978.94. The market value was \$146,362.19. This analysis by Major Nash was produced by the Crown as one of the fresh links in the chain of evidence by which it is seeking to establish the alleged connection between the securities that were left by Aemilius Jarvis & Company with Brown Brothers & Company of A. H. Peppall and the bond coupons claimed to have been cashed by Peter Smith in Stratford.

LAW WILL TAKE ITS COURSE

Montreal Bandits Have Small Chance of Life—Riot is Feared. (Canadian Press) OTTAWA, Oct. 22.—Unless stay of execution is granted by the courts the five Montreal bank bandits will be executed on Friday morning. Hon. George P. Graham acting Prime Minister announced today that an Order in Council had been passed providing that the law take its course. MONTREAL, Oct. 22.—Shortly before noon today it was ascertained that 70 additional guards had been sent to the jail as an added precaution against a possible riot or raid by underworld forces to rescue the five bandits who will be hanged on Friday. It was announced that those permitted to attend the executions must enter the prison not later than six o'clock on the preceding night. Rumors were in circulation today that a conspiracy was on foot to kidnap Arthur Ellis official hangman. In case of such an event the duty of executing the condemned men would fall upon the shoulders of the sheriff according to law. All available police reserves were called out and the officers succeeded in forcing back a crowd of several hundred persons who were said to be preventing persons from entering the building. The subject of Black's address had been announced as "The Ku Klux Krazee." Tear gas bombs were used by police to disperse the mob and shortly after 8 o'clock the crowd had been driven into side streets. They think that by taking the appeal to the country in a hurry they may have a better chance. "The Prime Minister is in the hands of the desperadoes of his party. The country is revolting against this form of government, as it is not government by the better men of the party, but by men in the background who pull strings and dictate the policy and hold the Prime Minister in bondage." Marquis Curzon said that in all the horizon he saw trouble impending. He did not accuse the Labor Government with producing this condition of things, though in some cases the government had accelerated it, but the present government was incapable of solving the impending difficulties. The country would now insist on having a strong government which would set British interests before everything else, remembering that it was the pivot and centre of the British Empire, and would not allow the claims of the citizens of any part of the Empire to be harked away in return for the embraces of the Bolsheviks of Moscow. Continuing Marquis Curzon said: "In practice it comes to this, they pursue a policy apart from the interests of the Dominion, contemptuous of the Dominion and inconsistent with the whole Imperial scheme which is the mainspring and life of our whole position throughout the world." Many Civil Servants to Retire (Canadian Press) OTTAWA, Oct. 22.—Hundreds of civil servants throughout the country are retiring this month under the provisions of the Calder Act, which expires at the end of October. The terms of this enactment are considered to be more liberal than those of the Superannuation Act because, in addition to a retiring allowance, civil servants may withdraw in full their payments into the retirement fund. A great many who are nearing the age of retirement figure out that it will be to their financial benefit to leave under the Calder Act before it goes off the statute. 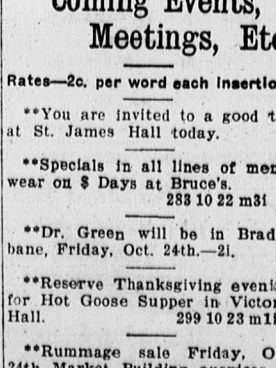

He admitted that he had returned without realizing these aspirations but declared he was ready to sacrifice his life if necessary for his country's independence. The British had replied to his request "with a refusal without proof or justification." It had been demonstrated that the Egyptians must remain solidly grouped under the banner of "Complete independence for Egypt and the Sudan." "We will never admit, nor will those who come after us, that a single foreign soldier shall remain on Egyptian soil," the Premier declared.
