Resignation Of Rev. W. Bruce Muir



The Rev. W. Bruce Muir, who has just resigned the charge of St. James Presbyterian Church, is a native of Scotland, where he was born sixty-two years ago. His father was one of the old parish-school teachers whose system of education has been the admiration of the world. Mr. Muir received his primary education at his father's school, from which he passed to the University of Edinburgh. Here he took his Arts and Theological courses under some professors whose fame has become world-wide, notably Professors Charteris and Flint. After completing his Arts and Theological curriculum he was licensed to preach the Gospel by the Presbytery of Linlithgow in 1892. Thereafter he became assistant to several of the leading ministers of the Church of Scotland, including in succession the Rev. Dr. Carruthers of Falkirk, the Rev. Dr. Graham of Bathgate, the Rev. Dr. Wetherston, Outlands, Glasgow, and the Rev. Dr. MacLean Watt, then of Alloa, now of Glasgow Cathedral. In 1906 he became minister of Trinity Parish, Aberdeen, where he learned all about the Independent Labor Party and their methods of dealing with their constituents. During this period the Canadian curlers toured Scotland under the captaincy of the Hon. Dr. C. Fraser, Lieutenant Governor of Nova Scotia. Through his influence Mr. Muir was induced to visit Canada and has remained ever since as one of the leading Presbyterian ministers of the Maritime Provinces. It is to be hoped that Mr. Muir will yet be long spared to give the benefit of his long experience for the good of the Presbyterian Church in Canada.

THE SUBSIDY QUESTION

(Continued from page 1)

"A conference was convened in Ottawa in the month of November last by the Dominion Government and the Governments of all the Provinces of Canada. As a result of this meeting the Dominion Government... is undertaking in the very near future to make a complete revision of the financial arrangements as recommended by the Duncan report. We confidently anticipate that when such a revision is made we will receive a very material increase in our subsidy."

MACKENZIE KING'S DENIAL

On February 18, 1929, nearly a year afterwards, Premier King, on the floor of the House of Commons, in reply to a query as to why, when the western provinces were being dealt with in the matter of subsidy claims the other provinces were ignored, said:

"FOR SOME REASON OR OTHER THE CLAIMS HAVE NOT BEEN PUT FORWARD BY THE PROVINCES."

One month later, (March 19, 1929), the following statement appeared in the Speech from the Throne at the opening of the Legislature:

"During the year my Government HAS BEEN VIGOROUSLY PRESSING OUR CLAIMS for a further increase in the subsidy which we receive from the Dominion, and has stressed the fact that in view of the apparent intention to transfer to the Western Provinces the natural resources within their boundaries, equitable treatment to all the Provinces would appear to call for some corresponding concessions to our own Province."

A DEFINITE PROMISE

On March 21, (two days later) in a letter to the Secretary of the Teachers' Federation, Premier Saunders wrote:

"AT A RECENT CONFERENCE IN OTTAWA, THE PRIME MINISTER AND THE MINISTER OF FINANCE AGREED TO ARRANGE FOR AN ACCOUNTING BETWEEN THE PROVINCES AND CANADA, AT WHICH TIME OUR PROVINCE WILL BE ENABLED TO MAKE A FURTHER DETAILED PRESENTATION OF OUR CLAIMS. THIS ACCOUNTING WILL TAKE PLACE NEXT FALL BEFORE A BOARD OF EXPERTS. We are hopeful that, after this Board will have submitted its findings to the Federal Government, we will receive a substantial increase in subsidy AT THE NEXT SESSION OF PARLIAMENT."

On March 25, four days later, Hon. J. D. Stewart, leader of the Opposition, placed on the order paper in the Legislature the following question:

1. Have there been any negotiations between the Government of this Province and that of Canada during the recess of this Legislature regarding the final adjustment of provincial subsidies, or with a view to obtaining additional subsidy for this Province.
2. Table all correspondence re same.

And the following reply was tabled by Premier Saunders, March 26th:

"The subject matter is still in process of negotiation and I do not consider it in the public interest to publish the correspondence at this time."

HON. MR. ROBB'S ASSURANCE

On October, 1929, (according to correspondence read by Premier Saunders in the Legislature during the session of 1930) Premier Saunders wrote to Hon. J. A. Robb, Minister of Finance, in part as follows:

"When I saw you in Ottawa last spring in company with Messrs. Sinclair, Jenkins and McLean, we discussed this matter (of readjustment of subsidy claims) 'AND YOU ADVISED ME TO COME TO OTTAWA THIS FALL AT WHICH TIME YOU WOULD APPOINT A COMMITTEE OF EXPERTS FROM YOUR DEPARTMENT TO HEAR OUR REPRESENTATIONS. In the

House of Commons last session the Prime Minister in reply to a question as to why a final adjustment had not been made with the Provinces said that claims had not been presented by the latter. This statement of the Prime Minister has often been referred to by the Opposition members of our Legislature last session, and although I refused in reply to table questions to divulge all that had passed between the Federal and Provincial Governments on the subsidy question on the ground of public interest, in justice to myself and in view of the Prime Minister's statement, I announced the arrangement suggested by you, namely, that I was to go to Ottawa this fall and present our case before a committee of experts to be appointed by you. YOU FURTHER SUGGESTED LAST SPRING THAT THIS PROVINCE COME ALONE RATHER THAN IN CONJUNCTION WITH THE OTHER MARITIMES."

MORE CONFUSION

On January 25, 1930, following the return of Premier Saunders from Ottawa, the Patriot newspaper announced that a special audit board had been appointed and was now engaged in adjusting Island claims. A FEW DAYS LATER IT WAS ANNOUNCED THAT THE ADJUSTMENT WAS BEING MADE, NOT BY A SPECIAL BOARD BUT BY THE DOMINION BOARD OF AUDIT OF THE CLAIMS OF ALL THE MARITIME PROVINCES AND THAT THE REPORT OF THIS BOARD WOULD NECESSARILY BE PRELIMINARY TO AN INTER-PROVINCIAL CONFERENCE AND SUBSEQUENT RATIFICATION BY PARLIAMENT.

CONTRADICTORY CLAIMS

During the Session of 1930 two memorials on our subsidy claims were tabled in the Provincial Legislature. One, signed "Albert C. Saunders, Premier, Walter M. Lea, Minister of Agriculture, J. O. C. Campbell, Counsel," was for a subsidy claim of \$408,796.94. THE OTHER, ISSUED UNDER THE AUTHORITY OF "HON. W. M. LEA, ACTING PREMIER," WAS FOR A SUBSIDY CLAIM \$3,372,166.57 plus \$200,000 CASH PAYMENT FOR DAMAGES ARISING FROM EXPROPRIATION OF THE DALTON SANATORIUM AND FOR MAINTENANCE AND IMPROVEMENTS IN PUBLIC LANDS.

NO DELAY SUGGESTED

AT NO TIME SINCE THE SAUNDERS GOVERNMENT CAME INTO POWER WAS IT INTIMATED, EITHER BY PREMIER SAUNDERS OR ANY MEMBER OF THE PROVINCIAL OR FEDERAL GOVERNMENTS, THAT IT WOULD BE NECESSARY FOR THE MARITIME PROVINCES TO WAIT UNTIL THE CLAIMS OF THE WESTERN PROVINCES HAD BEEN SETTLED. On the contrary, it is obvious from the statements in the Speeches from the Throne in 1928 and 1929 that in accord with the recommendations of the Duncan Commission, "immediate consideration" of the whole question of Maritime subsidy claims was expected. The interim subsidies were first paid to the Maritime Provinces in 1927. HAD PREMIER SAUNDERS BEEN INFORMED BY THE PRIME MINISTER IN THE FALL OF 1927 THAT IT WOULD BE ADVISABLE TO WAIT UNTIL THE QUESTION OF THE NATURAL RESOURCES OF THE WESTERN PROVINCES HAD BEEN DEALT WITH, HE WOULD CERTAINLY NOT HAVE INSERTED IN THE SPEECH FROM THE THRONE IN 1928 THAT "THE DOMINION GOVERNMENT... IS UNDERTAKING IN THE VERY NEAR FUTURE TO MAKE A COMPLETE REVISION OF THE FINANCIAL ARRANGEMENTS AS RECOMMENDED BY THE DUNCAN REPORT." YET EITHER PREMIER SAUNDERS HAD FULL KNOWLEDGE THAT THIS STATEMENT WAS ERRONEOUS AND MISLEADING AND THAT THE DOMINION GOVERNMENT HAD NO INTENTION OF DEALING WITH OUR SUBSIDY CLAIMS UNTIL THE WESTERN PROVINCES WERE SATISFIED, OR PREMIER MACKENZIE KING DELIBERATELY MISLED HIS AUDIENCE IN CHARLOTTETOWN WHEN ON JUNE 21 OF THIS YEAR, HE STATED:

"I remember AFTER WE HAD GIVEN THESE INTERIM GRANTS" (recommended by the Duncan Commission in 1926 and paid for the first time in 1927) "that the former Prime Minister of this Province, Mr. Saunders, came to Ottawa on two or three occasions and wanted Mr. Robb and myself to settle the financial terms so far as the Island was concerned there and then. I said: 'MR. SAUNDERS, DON'T PRESS US AT THIS TIME. You won't do as well in the end... We have dealt with the Maritime Provinces to begin with; let us now get settled with Manitoba, Saskatchewan, British Columbia and Alberta. When we get through with them and if as a result of those agreements something more should come to Prince Edward Island, you will be in a better position to see that something more is granted. You will then stand a better chance. HOWEVER, THE AUDIT BOARD WAS PUT TO WORK AT ONCE AND THE FINANCING OF THAT WORK OF NECESSITY HAS BEEN GOING ON EVER SINCE."

KING'S REMARKABLE STATEMENT

If this conversation between Premier Saunders and Premier King took place in 1927, or even in 1928, when the second annual interim payment recommended by the Duncan Commission was made, WHY DID NOT MR. SAUNDERS ANNOUNCE THE PRIME MINISTER'S REFUSAL TO TREAT WITH HIM AT THAT TIME? WHY DID HE NOT ANNOUNCE THAT "THE AUDIT BOARD WAS PUT TO WORK AT ONCE ON THE FINANCING" FOLLOWING THAT CONVERSATION? Mr. Saunders was being hard pressed to excuse his failure to implement his promise to secure an early readjustment, AND HE WOULD GLADLY HAVE AVAILED HIMSELF OF SUCH AN ARGUMENT IF IT WERE TRUE. THE OBVIOUS ANSWER IS THAT NO SUCH CONVERSATION TOOK PLACE IN 1927 OR 1928. Nor could it have taken place up to October 1929, when Mr. Saunders wrote to Hon. Mr. Robb reminding him of the advice given by the Finance Minister that the Province was to present its claim "alone" and that a board of experts would be appointed in the fall of that year. FOR UP TO THAT TIME THE CLAIMS OF THE WESTERN PROVINCES HAD NOT BEEN DISPOSED OF. If this mysterious conversation ever took place, it must have occurred sometime during the present year, but Premier King says it was when Mr.

MONTREAL, Que., July 2.—Produce prices of butter, cheese and new potatoes exhibited a lower trend today in Montreal. Old prices were slightly higher, while eggs held steady. The butter market was generally 1/4 cent per pound lower in wholesale channels. Sluggishness in demand and plentiful supplies were given as reasons for the decline. Prices to retailers were unchanged. Receipts were 52 boxes. The cheese market also eased about 1/4 cents per pound. The market was quiet. Receipts were 10,460 boxes. On the egg market trading was quiet and firm. Receipts were 4,109 cases. New potatoes were reduced, prices now being No. 1 grade, \$6.25; No. 2 grade, \$5.00, and culls \$4.00 per 160 pound barrels; old potatoes on the other hand were 10 cents dearer, being \$1.85 per 90 lbs. in bulk. FORMER LIBERAL

Power Corporation question. "It is a wonder that we, as honest citizens and, above all, Canadians, with the welfare of our country at heart, should tolerate the disgraceful doings of the Liberal Prime Minister and his Government," Mr. Calder said. As he delivered his address, he stood near R. S. White, ex-M.P., for Mount Royal, his old political opponent.

CHANGE NOT WRONG

He first stressed that if Canada was a more democratic country, his action in abandoning the ranks of the Liberal party, joining up with the Conservative party, and supporting its policies and programme, the while he denounced those of his old party, would not be criticized, nor would he be condemned as a traitor and a renegade by the Liberals. In England many great statesmen, including Lord Balfour and Winston Churchill had deserted one party for another during a lifetime of politics, and had done so because they thought it best. Their action excited no unfavorable wave of criticism. It was understood that they were doing so after having independently thought over the situation, and considered which party had the best programme for the country's welfare and prosperity. As had British

statesmen, so had he, Mr. Calder said, and today he was with the Conservative party because he was of the firm belief that their policies and programme favored Canada, whereas the policies and programme of the Liberal party—past and present—were not in Canada's favor, and offered nothing constructive to bring a stop to the present economic depression and ills, including unemployment, adverse trade balances, etc.

"I have made the change fearlessly," Mr. Calder emphasized, "and as an independent-thinking Canadian citizen who desires, above all, to see a Canadian government with Canada's interests at heart."

He had been a Conservative until 1904, he admitted. Then, as he had now, he had changed and embraced Liberal policies because he thought they were the best for Canada at the time, and he was sure that he had acted as wisely then as he had acted wisely now. After having run as Liberal candidate in Mount Royal in 1926, he had made the resolution to remain inactive in politics, but now, for certain developed tendencies, not so much on the part of the Liberal party as on Mr. King's part, he was active again, and he was nauseated at three things which, he declared, demonstrated clearly Mr. King's stand as regards Canada and her welfare.

Shameful Campaign

The present campaign conducted by the Liberals under Premier King was one of shameful prejudices and boogies, Mr. Calder held, particularly in Quebec, where the Liberal ministers, especially the Hon. Fernand Rinfret, Secretary of State, were getting away from the principal questions of the day and grossly insulting their opponents. The conscription bogey was being raised. "If you vote for Sir George Perley, your sons will have to go to India and fight!" the Liberals cried. And, furthermore, the Secretary was wont to cry out that the main question before the electorate was as to who will represent Canada at the Imperial Conference. If you elect Premier King and the Liberal Government, they will go to London and obtain for the Dominion greater autonomy, they cry, adding that if Mr. Bennett and the Conservatives went into power, Canada would be reduced to the status of the old colonial regime. And King accentuates these preposterous utterances by warning the electorate that Canada's status was greatly endangered by the Conservative imperialistic policy.

"Ridiculous! Shameful!" Such did Mr. Calder label these boogies, and he expressed wonder that any intelligent, independent, thinking Canadian citizen would believe them. This endangered autonomy bogey of Mr. King's is nauseating, Mr. Calder said, particularly in view of the fact that Canada never will be in danger of losing her autonomy. For what autonomy she has, the credit cannot go to Mr. King who makes of it a play which he always cherishes, especially at election time. It is King's continentalism and lack of Canadianism that is behind it, and this continentalism is nauseating. He is always afraid that some minion from Downing street will bludgeon him and rob him of what little autonomy he has given Canada.

And it is, strange yet true that we find him begging on his knees whenever Uncle Sam whistles loud enough to attract a few of our Canadian Government going to London and sacrificing one iota of Canada's autonomy," Mr. Calder said, to the rousing cheers of the audience.

"These are the bogey politics of King alone, and he is always springing them at election time. All of Canada's great premiers of the past—premiers both Conservative and Liberal—have been autonomists, striving tirelessly and endlessly to secure greater and greater freedom and autonomy for the Dominion, and they always have and always will adhere to the line of Canadian autonomy given us by Kinging—Daughter, Mrs. Penzie MacEwen, Administrator, 5075-7-3-11.

I in my Mother's house, but mistress in my own."

Mr. Calder soundly flayed the Premier for his "five cent speech," declaring that Mr. King, confronted by the awful spectacle of thousands of suffering and miserable unemployed workers in Canada seeking relief, turned his head and told them he would not give them five cents unless he knew how they voted in 1928. This was a gross insult to Canadian citizens, Mr. Calder said, and one they should not forget. It was a most disgusting and shameful statement to make, and one that serves to show up the Premier in the light of one who would give no relief to any elector who had cast a Conservative vote.

In the Beauharnois Power Corporation project, the King Government, and especially the Premier, showed marked apathy towards the whole affair, Mr. Calder charged, stating that the fact that it was permitted to proceed without a signed order-in-council, and with only the permission of the House of Commons, showed that the Government was not acting in the best interests of Canada. The corporation, he alleged, was going over the development of a limited amount of horsepower, and when the Conservative leader had brought the question up in the House, the Government had evaded explanations. The entire project, as well as the charter, should be investigated, he said, whether it hurts Liberals or Conservatives.

It was for these and the general reason that the Government had not the best interests of Canada at heart, that he deserted the Liberal party, Mr. Calder said, affirming that the policies and constructive programme for the development and welfare of the Dominion and its peoples, as laid down by the Hon. R. B. Bennett for the Conservative party, would, in a great way, enable the Dominion to recover from her numerous economic ills of the present and continue on her march to greater development and prosperity.
