W. E. DARBY, S. H. BROWN AND R. H. MACLEOD WILL MEET CAMBRIDGE DEBATERS

HALIFAX, N. S., Nov. 3.—Walter Eric Darby, B. A., of Abrams, P. E. I.; Sterling Henderson Brown, of New Glasgow, and Roderick Henry MacLeod, B. A., of New Glasgow, have been chosen as the debating team which will represent Dalhousie University at the debate with the Cambridge University debaters, at Stedley gymnasium on Monday, November 22.

Announcement of the personnel of the team was made last night by the intercollegiate committee consisting of Dean Reed, Dr. Clarence MacKinnon, Dr. Wilson, and Prof. A. L. MacDonald.

Mr. Darby, the team leader, is considered one of the most experienced inter-collegiate debaters in the province. He led the Dalhousie team against U. N. B. in 1925 and was chosen to represent Dalhousie against the Imperial debating team last year, but was unable to do so owing to injuries received in a railroad accident. He is a third year law student and a graduate from the arts faculty.

Mr. Brown is well and favorably known in debating circles. He led the inter-collegiate debating team against Mount Allison last year. He is a senior arts student.

Mr. MacLeod is also a well known Dalhousie debater. He was a member of last year's Dalhousie intercollegiate team. He is a graduate in arts and is now in his first year law.

The subject of the debate is, "Whether Latin and Greek should be continued as essentials in modern liberal arts course."

Problem of Wrecked Ship Settled In Law Courts

VANCOUVER, B. C., Oct. 30.—When is a wrecked ship a total loss?

The problem was settled in Vancouver law courts recently when the case of Captain J. A. Gates Tug and Warpage Company, Limited, versus the Franklin Fire Insurance Company of Philadelphia, was considered in the court of appeal.

Plaintiff had been awarded in the supreme court a judgment for \$40,000 on two policies which insured the tugboat Radius against loss. The defendant insurance company appealed and the appeal was allowed by three judges who heard it.

The Radius towing a scow, was sunk in collision with a steamer on the morning of August 26, 1925 in English Bay.

The court of Appeal's judgment is to the effect that all an insurance company has to do is repair a vessel in a good, workmanlike way, and that it is not expected to provide a new ship.

The following clauses were quoted from authorities, bearing on the same point:

"A sixpence dropped into the water which you can see lying at the bottom at a depth of twenty feet, in clear water is totally lost because it would cost much more than the sixpence to get it up."

"That would be a constructive total loss. It is quite different where a sunken vessel can be raised at a cost less than its value. True if the margin was comparatively small a different result might follow. That is not this case. The insurers might take possession of the wreck for the purpose of repairing it and proceed to make full repairs and if at a cost of less than the value tender it in this condition to the owner, and unless he can object to the sufficiency of the repairs, he cannot contend that it is a constructive total loss or regard the action of the insurers as an acceptance of abandonment."
