reached here Friday night. When it came a report that a vagrant eskimo named Teteluk was suspected of the double killing. Mounted police in all sections of the Arctic are working to find Teteluk, who was reported last seen three months after the probable date of the murders with a rifle. Both Olsen and Bode owned rifles but none was found with the bodies.

Police at Fort Reliance first received word of the trappers' deaths last Dec. 23, more than a year after the two northlanders had been murdered. H. C. Price, another trapper, first discovered the bodies last September and he sent a report to police at Reliance by Indians.

Inspector Gagnon found the decayed bodies of Oslo and Bode lying in the bunks of the Queen cabin, where they had lived. The shack was walled and floored with logs, but the roof was made of canvas and caribou skins.

Chained outside the rude hut were the bodies of seven of the trappers' ten dogs. The killer apparently had tied them up and left them to starve. Three probably escaped.

ST. JAMES CHURCH

The Sacrament of the Lord's Supper was celebrated at St. James Church yesterday forenoon, when there was a large congregation, and the attendance of communicants was the greatest for many years. The minister, the Rev. R. Moorhead Legate, B. D., preached and presided at the service. In the absence of Mrs. Rogers, organist, Mr. Horace McEwen acceptably presided at the organ.

At the evening service the usual monthly address to young men was given by the minister, who gave timely advice with regard to the place of pleasure and amusement in the people's lives. A duet was rendered by Messrs. Mosher and McKenzie.

Y. M. C. A. SERVICE OF SONG

The usual weekly after church service for students and young people was held in Zion Church last night and was attended by over 500 young men and women. Rev. R. Moorhead Legate was the speaker of the evening. Mr. Legate departed from the usual procedure of giving an address, but read an article entitled, "The Young Man and the Church," written by a world famous author of books on young peoples work, Frederick A. Atkins.

Mr. Legate presented this topic in a most masterful way, and was listened to with keen delight by all.

The story was interspersed with some amusing and helpful incidents. In closing, the speaker recommended this address to those present and stated there were many ways for young men and young women too to be benefited by a loyal and earnest church affiliation.

Two very lovely solos were rendered by members of the Zion Choir, Miss L. Sempie, who sang One Sweetly Solemn Thought, and Miss J. Lawson sang, God Who Madest Earth and Heaven.

This service was greatly assisted by the members of Zion choir, most of all of whom stayed for the special service.

Prof. L. D. Thompson presided at the organ for the solos and the congregational singing.

Mr. Roy Vessey was chairman, and was kindly assisted by Rev. G. C. Webster, pastor of Zion Church.

At the close of the meeting, the chairman extended the hearty thanks of the people present to all those who so willingly assisted in the service.

Next Sunday being Easter, and most of the students being home, there will be no meeting. The following Sunday the service will be held in St. James Church.

Lest We Forget

At 4 a. m. fourteen years ago today Ludendorff opened his great offensive against the fog enveloped British front line of over sixty miles from Lens in the North to below St. Quentin in the South. The British north front was held by the III. Army under Sir Julian Byng, consisting of 15 Infantry Divisions, while the southern half of the line was held by the V. Army, under General Gough, and consisted of 14 Infantry and 3 Cavalry Divisions, which like Byng's Divisions were all terribly under strength and tired out from long service. The V. Army front had just been taken over from the French and no defence lines had been completed, although they were under construction. Against this portion of the line the Germans threw 49 fresh Divisions, trained for open warfare.

Britain had 100,000 less fighting men in France at this time than she had in 1917, and these were not trained for open warfare, as they had long been engaged in trench warfare.

Under this overwhelming attack the V. Army cracked and the British armies were rolled back to Albert, which was captured on the 27th March. This however, was the high water mark of the German success. The line held and prevented Ludendorff from gaining his objective, the capturing of Arras and so separating the British and French armies and his determination to then defeat the British army and push it back to the channel ports and then turn south and defeat the French.

Those were anxious days. Days never to be forgotten. Days when the French civilians aged and young, were forced from their homes to become refugees seeking rest at night on the roadsides and fields.

The spirit of the British army was not broken. It accepted Halg's message of 11th April and with his back to the wall it fought on until 28th April when the great German attack had spent itself, notwithstanding that Ludendorff had by this time thrown no less than 141 Divisions against the British who could only muster 65 Infantry and 3 Cavalry Divisions, which for the most part were almost worn out from long and continued service.

The British Army was then re-organized and trained for open warfare and prepared for the great and final advances of the following August which ended in victory on November 11th, 1918. T.E.M.

A Proposal To Establish County Academy At S'Side

A proposal to establish a County Academy at Summerside will be submitted to the Provincial Government today by a delegation representing the Summerside School Board, the Town Council and Board of Trade. The brief to be submitted proposes:

(1) That the Summerside High School makes provision for the teaching of Grades 11 and 12, submitting to the scheme of common leaving examinations for the Maritime Provinces acceptable for University Matriculation, as outlined by the Carnegie Advisory Committee, or the standard of examinations set for 1st and 2nd year Prince of Wales College Students.

(2) That the School Board undertakes to employ an additional staff of not less than three nor more than five qualified instructors to carry on the work.

(3) That the Town will do the necessary construction work.

The following requests are made in the brief:

(1) Will the Government and Board of Education recognize the standard?

(2) Will the Government of P. E. Island make the Summerside High School the Academy for Prince County, and the County the student constituency for the Academy?

(3) Will the Government pay the salaries of the Professors so engaged by the Summerside School Board as is now done at Prince of Wales College?

(4) Will the Government pay the cost of construction that will be required to make Summerside High School an Academy for the said County of Prince, in whole, or if the Town does the work, in part?

If the Government approves the above proposals, legislation will have to be passed enabling the Summerside School Board to spend more than \$10,000 annually as allowed under the present act.

The Passing Of T. J. Dillon

Mr. R. E. Spillet is informed by letter from a son of T. J. Dillon that his father passed on the 16th inst. in Toronto. It appears that the deceased had a stroke early in the month and evidently did not recover from it.

To the many friends in this Province of the late T. J. Dillon this comes as sad news.

He came here in 1892 to take charge of the new dairy movement promoted by the late Dairy Commission, Jas. W. Robertson being put in charge of the New Perth Cheese Factory. In addition to that position he was required to render assistance in the starting of cheese factories in many other sections, particularly in King's County, and later in all parts of the Province.

Mr. Dillon was well equipped for such work, as he was an expert cheese and butter maker and was a gifted platform speaker. Being of an ardent, enthusiastic temperament he soon boomed dairy farming on the advanced co-operative plan. True, he had valuable assistance, but he was the real dynamo of the movement. He continued in the Dominion Government Service till 1896 when he started the export business of cheese and butter and shortly after formed a partnership with Mr. Spillet under the name of Dillon and Spillet. Later Mr. Dillon moved to Ontario but continued his interest in the firm. As he became interested in several enterprises in Ontario, he gave up his intention of returning here and then sold out to Mr. Spillet who has continued the business under the same firm name. Time flies. It does not seem like 40 years since Dillon, as he was known to us, came on his mission among us, and although his impetuosity made us tired sometimes, we soon found that he was the soul of honour and kind to a fault. Honest, why Dillon could not commit a dishonest act "even if he tried to." The sympathy of his many friends in this Province goes out to his estimable life partner and family in their trying bereavement.

Samuel Kennedy, President of the Charlottetown Board of Trade.

A telegram was also sent to Mr. W. Chester B. McLure, M. P., asking that he and the other members urge the request.

Mr. G. J. Tweedy reported that his committee had interviewed the Premier relative to the reply received from the Board of Railway Commissioners in the matter of the Charlottetown Board's application for the restoration of double train service, and understood that no further action would be taken at present.

The Secretary was asked to write for a copy of the proposed new time table and to find out when it would become effective.

The Secretary read a copy of the presentation made by Mr. C. L. McKay on behalf of the Board to the Premier and Government opposing the passing of the Workmen's Compensation Bill. On motion of Mr. R. E. Mutch and Mr. G. J. Tweedy the presentation was approved by the Council. A letter from the Summerside Board regarding this Bill had already been replied to by the Secretary.

Mr. Tweedy reported he had interviewed the Provincial Engineer regarding the widening of the driveway of Hillsboro Bridge while replanking it and had been advised that this would be done.

Letters were read from the Halifax Board, from Mr. A. E. McLean, M. P., and a copy of the letter from the Minister of Interior to Mr. McLean re Historic Sites and National Parks.

On motion of Messrs. Mutch and Crockett the matter was referred to Mr. R. L. Cotton for his consideration and suggestion to the Council as to future action.

Letters from Mr. J. D. Palmer, Director C. N. R. Fredericton and the Moncton Board of Trade re car ferry accounting were read and on motion of Messrs. Mutch and Tweedy the President was asked to telegraph the local members of Parliament asking what progress had been made relative to having the system changed. The Secretary was asked to telegraph the Summerside Board asking them to cooperate and send wires also.

Mr. R. E. Mutch reporting for the Committee on Electric Power Rates stated the Board had gone about as far as it could in the matter, as the Board could not bring it before the Commission of Public Utilities. The users of power have the matter in hand and intend to meet Monday evening to consider future action.

A letter was read from the Summerside Board regarding a proposed small debts account. On motion of Mr. R. E. Mutch and Dr. J. A. Clark the correspondence was referred to President Kennedy, Mr. Tweedy and Mr. S. A. MacDonald for their consideration, they to report back to the Council.

A letter from the Canadian Chamber of Commerce regarding their Empire Trade Enquiry was referred to the Empire Buying Committee. They to report to the Council.

On motion of Mr. S. A. MacDonald and Dr. Clark the Entertainment Committee were asked to arrange for a 6 o'clock luncheon for the quarterly meeting, April 13, at one dollar per person. Also to arrange a tentative program and report back to the Council.

On motion the meeting adjourned.

Former Islander Dies In Montreal

BATHURST, N. B., March 19.—Word received here about noon today announced the death at Montreal of Mr. L. R. Howard. The late Mr. Howard was for over twenty years connected with the business and fraternal life in Bathurst, coming here from Port Egiz in April, 1910 he conducted a tailoring business until last August, when illness obliged him to retire. Later in the fall he went to Calais, Maine to spend some time with a daughter. A few weeks ago he went to Montreal where other members of the family are, and entered a hospital for treatment, where he passed away unexpectedly this morning. While in Bathurst he was for many years a member of the volunteer fire department an enthusiastic curler and a member of Lodge Saint John No. 27 A. F. and A. M. Besides his wife, who is now in Montreal, there are five daughters, Mrs. Frank Elthorn, Mrs. Gilbert Landry, Bathurst; Mrs. K. G. Weed, Calais, Maine; Misses Gladys and Evelyn Howard, Montreal, and one son, Basil, also in Montreal; also one sister, Mrs. Cowan, of Norfolk, Mass. The deceased was born in Kensington, P. E. I., January 24th, 1871. The remains are being brought to Bathurst for interment and it is expected the funeral will be Saturday afternoon, although final arrangements have not been completed.

Chamberlain in which the Chancellor of the British Exchequer said "any suggestion that the obligations (or agreements) of the Irish treaty solemnly entered into by the two governments could be repudiated or changed by either side" would be viewed by the British Government with "the gravest concern." Any such suggestion, Mr. Chamberlain added, "would undoubtedly revive the bitterness and differences which it was hoped had been removed forever."

"At this stage," President De Valera told his interviewers, "I shall only say that if the bitterness and differences are revived, the fault will not lie with the Irish people."

The annuities which Mr. De Valera would withhold from the British Government are worth approximately \$15,000,000. They are collected under the terms of the Irish treaty from Free State farmers in repayment for loans advanced to enable them to secure freehold of their land from their former landlords. The President's attitude is that the annuities are the property of the Free State and that the Irish treaty does not bind the people of the State to swear allegiance to the British Crown.
