HEAVIEST TAX-PAYER IN N. Y. STATE

ALMOST \$13,000 COLLECTED IN ORPHANAGE CAMPAIGN

NEW YORK, Oct. 26.—The Metropolitan newspapers today printed under large headlines details of income tax payments by the country's wealthiest citizens.

Immediate protests were made by some of those whose returns were printed, on the ground that such publicity would work an injury to their businesses.

The publication of the figures followed a ruling from the Treasury Department at Washington throwing "open to public inspection" the income tax lists. Later a clause was discovered in the revenue act forbidding the "printing" of such statistics and some papers withdrew the lists from their columns.

The list as carried by the papers revealed the fact that John D. Rockefeller, Jr., son of the oil magnate, had made by far the largest individual return in New York state. His income tax payments in 1923 amounted to \$7,435,169.41.

This reflected the announced policy of John D. Rockefeller, Sr., to turn over his fortune to his son before his death. The elder Rockefeller paid a tax amounting to \$124,266.47.

A dispatch from Detroit showed that the Ford family had paid almost \$19,000,000 in taxes. Henry Ford himself paid \$2,467,946.10; E. B. Ford \$1,984,264.83; Henry Ford II, \$554,650; Benson Ford \$553,000 and the Ford Motor Company \$14,449,673.09, making a total of \$18,902,981.50.

Controversy over the publication of the returns was continued throughout the day there evidently being a difference of opinion on the part of officials of various government departments in Washington on the subject.

The "warning" to the newspapers declaring the law provided for a fine for those publishing the returns. The Department of Justice issued a statement saying that the question would have to be studied before a definite ruling could be made and in the meanwhile papers publishing the list would do so at their own risk.

Tells How Trade Is Lost To Canada

OTTAWA, Oct. 26.—F. C. T. O'Hara, Deputy Minister of Trade and Commerce gives in his annual report some pointed illustrations of how trade is lost to Canada. He cites a recent case where a ship was required to carry coal from Sydney to Montreal, two Canadian ports. The ship happened to be of Canadian registry but the charter was made and the commission paid to a foreign broker resident not 400 miles from Montreal.

Again, an officer of the Department of Trade and Commerce saw at a pier in New York a number of large packing cases stamped "made in Canada". They were awaiting consignment to South America just eight days prior to the advertised sailing of a direct ship with half a cargo.

Mr. O'Hara comments: "The services and facilities of a foreign country are frequently sought perhaps because it is the line of least resistance, because of inertia or a dulled sense of what is due to Canada."

He urges that all possible supplies should be bought in Canada and if not obtainable in Canada, of lower rates on cattle. He has just returned to Ottawa.

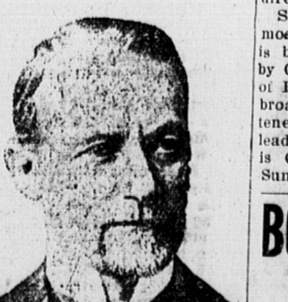
Kept His Word To Bride's Parents

MUST SERVE PRISON TERM AND PAY A \$600,000 FINE

Smith and Jarvis Found Guilty of Conspiracy To Defraud Government—Largest Fine On Canadian Record.

TORONTO, Oct. 26.—Peter Smith, former Provincial Treasurer in the United Farmers of Ontario government and Aemilius Jarvis Sr., Toronto broker, who on Friday were sentenced respectively to three years in Portsmouth penitentiary and six months in jail for conspiracy to defraud the government and to pay between them a fine of \$600,000 were brought Saturday to the City Hall in a provincial police car after a few minutes in the cells, where they were taken upstairs and their photographs and finger prints taken. Afterwards they returned to the jail in a police van. Two other men and a woman were taken to the jail in the same car.

Owing to a misunderstanding, Chief Justice Meredith was not in Assize Court Saturday for the arraignment of Peter Smith on the remaining charge of conspiracy and theft of which there are twelve counts. These charges are in connection with his Home Bank transactions and include one for fraud in failing to account for \$15,000 in money and securities paid to him by the Home Bank in relation to the sales of bonds to the province.

The sentences of the Chief Justice made the speculators who crowded the big court room almost held the breath. It had been anticipated, but there had been no thought of the imposition of such a huge fine as \$600,000.

An almost incredulous smile crossed the face of Aemilius Jarvis as he was led to the cell. Almost with a touch of irony, he reached his hand into his trouser's pocket and jingled the loose coins that were there.

But the elder Jarvis had not a word to say about forgiveness. He very plainly resented both the verdict and the Chief Justice's "petty" services as deserving of a profit of half a million dollars, Jarvis replied with some show of spirit that his services were by no means "petty," that he had staked his whole fortune on the deal and stood to lose it if the province had failed to stand behind him.

'DRY' MAJORITY MAY REACH 50,000

Result of Cleavage Between Urban and Rural Electors is Talk of Local Option

TORONTO, Oct. 26.—With prospects of a 50,000 "dry" majority in the plebiscite held on the liquor question in Ontario and with announcement of the Provincial Government that the Ontario Temperance Act will be strengthened and enforced, it became manifest tonight that Ontario has not followed the lead of the four western Provinces of Canada in liquor legislation. Something over a million citizens of the province sent to the polls and while the urban population was overwhining against prohibition, the farming districts remained true to form and proved as emphatically "dry." The result is that the O. T. A. of 1916, confirmed in 1919 by a majority of 407,000 in the plebiscite held in connection with the provincial elections, has been again upheld, though the majority vote is apparently cut to about one eighth of that figure. Returns are still very incomplete, but missing polls are not sufficiently large ones to affect the result materially. The result of the cleavage between city and farm is that the discussion has arisen in the urban centers on the possibility of some form of local option to give to separate communities their chosen system of liquor restrictions. The attitude of the provincial Government, however, as reflected in a statement issued by Premier Ferguson to the effect that the present liquor legislation has been upheld by popular vote and the government intends to carry out its previously announced policy of abiding by that vote.
