keep her afloat. The leak was not sustained in the capture, Burke Coast guardsmen stressed that the Nova Scotia boat was anchored inside the 12-mile limit when picked up by the searchlights of the patrol cutters.

The Popocatepetl carried a crew of eight. She is a swift craft of about 153 tons gross, and is registered by Lloyds as owned by West-N.S. The boat is equipped with diesel engines.

The prisoners were herded onto the government reservation. The regular brig was too small to hold all of them and temporary quarters were made.

Customs officials from Philadelphia hurried to the air base to participate in the questioning.

### Shackled

Captain Michael Pettit of the Canadian ship and the skippers of the three launches were questioned first. They wore leg irons when they were led from the brig to the room where the questioning took place. Lt. Burke said George Chapman of Point Pleasant commanded the "Nanapan" (Chapman spelled backwards).

Names of the other 18 prisoners were given out by Burke. He did not say which ships they were from.

Those held are: Ronald Walsh, Albert Foote, Gordon Sweeney, Irvin Spindle, Clayton Welsh, James Hardy, Fred Clayton, Ceazon Amro, Joseph Gorman, Michael Potts, Charles Adamson, Joseph Warner, Jr., Thomas Allen, Edward Marable, Alfred Munson, Henry Butler, William Wright and Robert Walsh.

The sacks of expensive liquor were left in the holds of the four vessels which were run in to the air base and put under heavy guard. Coast guardsmen were posted on the decks.

Strong guards were also employed when the prisoners were taken to eat. They were brought from the brig ten at a time and ate under the watchful eyes of their captors.

Many of the men looked as though they had slept little in several days and a number had at least a week's growth of beard. Burke said there have been no formal charges placed against any of those held as yet.

### NEW SOCIAL PLAN ARISES IN WEST

WINNIPEG, Sept. 8.—Harboring a vision of a short-cut to the millennium, Josh Hodgkinson, Kewwood, Man. real estate dealer and former police magistrate, visited this city seeking support for his "Industrial Collective Farms" project. He plans an experimental community which, he said, will provide every man with a standard of living equivalent to \$4,000 a year.

The scheme is to place 100 families on a huge, collective farm in some fertile and productive part of Manitoba. Besides producing all their food, the members of the group would build their own homes, make their own clothes and provide themselves with almost every necessary of life and many luxuries.

Initial cost of starting an I. C. F., Mr. Hodgkinson said, would be \$1,500 per family for 100 families. After that the whole community would become self-supporting, trading excess production for whatever goods they could not produce themselves.

The originator of the scheme claims he has received commendation from Premier Bennett for his zeal as a Canadian citizen and his enterprise in suggesting the project.

### TAKES ISSUE WITH KING ON TRADE QUESTION

Stevens Taunts Liberal Leader With Not Daring To Lower Tariffs On Articles Made By His Party Friends.

(C. P. By Guardian's Special Wire) FREEDONTON, N. B., Sept. 8.—Notwithstanding what Liberal leader Mackenzie King says, increase of Canada's external trade is not the solution of this country's problems. Hon. H. H. Stevens, Reconstruction leader, said here last night. Also if the Liberal leader attempted to increase trade with other countries he would find himself hampered by almost prohibitive duties against Canadian products as well as by the terms of 22 favored nations treaties negotiated by the last King administration.

In a voice husky from persistent speaking—he addressed three meetings today—the Reconstruction party leader warned his audience not to be deluded by a pitch-and-toss tariff game between Messrs Bennett and King.

Mr. King does not dare to lower the tariff on commodities made by those who are friends of his party. Mr. Bennett won't offend his friends either.

Mr. Stevens laid down the principle tariff should be based on protecting the Canadian workers passed on to them.

Germany made a type of farm to be established in Canada. It might be possible to effect an arrangement whereby Canadian wheat and fish were exchanged for German farm tractors.

Canadian farmers would never be reestablished by "Prime Minister Bennett and Japan snarling at each other over tariff matters," Mr. Stevens said the Prime Minister "in his last vaudeville address" indicated that he was going to announce measures for assisting farmers, and then "went on for seven paragraphs to discuss his row with Japan." That was useless. The way to reestablish the farmer was to see he got fair prices for his products from peckers, cannery, dairy companies. The Reconstruction party, if returned to power proposed to set up boards to do this.

Sees Possibilities

"Farmers in this country should be prosperous, but they're not," Mr. Stevens said in referring to the wonderful possibilities of New Brunswick as a dairying and cattle finishing province. Owing to activities of financial interests in merging individual dairies into huge corporations, the Canadian dairy farmer was today unable to get a decent price for his butter fat. One organization alone had a "strange hold over many of Canada's farming sections." They are selling milk today on the farms of Canada at prices which will not permit farmers to survive except in misery," he said.

"In Canada there is greater concentration of wealth than in any country of the world and it is going steadily on Mr. Stevens told his St. Stephen audience. A tremendous redistribution of wealth had been carried out in Great Britain through the so-called "rationalization of industry." A dozen men control half the wealth of Canada. Did they ever get together during these past five years of distress and try to evolve a plan to help the people out of their troubles? Not much. The more I see of these so-called great men, the more I realize they have feet of clay."

only registered formal abstention from the resolution appointing Britain and France as members of the five-power conciliation committee.

Before Council

The whole dispute has been placed before the Council yet Italy has given no sign she intends to quit the League.

Are these concessions delegates are asking, an indication Mussolini is preparing to negotiate reasonable terms or is he playing for time till the rainy season ends in Ethiopia? At any event, it is intimated the conciliation committee intends to push ahead with all speed.

Sir Samuel Hoare, British Foreign Secretary, arrived in Geneva this afternoon by special airplane. The plane will remain here until Thursday, when Sir Samuel expects to return to London. He brought with him from Prime Minister Baldwin and the cabinet a message to Anthony Eden, British delegate to the Council of full support for the line Eden has taken in the Ethiopian dispute.

The British here have received no advice regarding the rumored three-power conference in northern Italy. The British view is that the dispute is before the League and should remain before the Council and the committee appointed to consider it.

Italian quarters are stressing more strongly than ever economic necessity as justification for Italian expansion in Ethiopia.

Premier Laval is generally expected to return from Paris bearing concrete plans for a settlement of the East African controversy.

Comment on Report

British delegates commented today on reports affecting the railway from Addis Ababa to Djibouti as a possible neutral area by saying Premier Laval had not officially and concretely presented a recommendation for neutralization to the committee studying the Italo-Ethiopian situation. They said the project had been submitted by the manager of the railroad and that they understood it was supported by Laval.

If traffic were interrupted Ethiopia could not import medicinal supplies nor certain food essentials.

The suggestion was advanced that the railroad might be placed under the protection of the Red Cross to which Emperor Haile Selassie pledged his adherence.

The French delegation said it had no knowledge of a London report that Premier Mussolini had given assurance to Premier Laval he would not resort to hostilities while the dispute is in the hands of the League.

(Associated Press Foreign Staff) (A.P. By Guardian's Special Wire) ROME, Sept. 8.—Premier Mussolini told 30,000 fascist youths today, "we will march straight on."

Appearing before a vast crowd for the second time during the rally, Il Duce addressed the young Italians from the balcony of his offices at the Palazzo Venezia.

Earlier, in a brief address to 15,000 Great War veterans assembled from every part of the world for a convulse, Mussolini proclaimed that Italy wants peace "provided it is accompanied with justice."

"Comrades, I know what you are expecting to hear from me. 'We will march straight on.'"

"Is that what you wanted?" A cry of "yes" welled up from the crowd in response.

To The War Veterans, Il Duce Said:

"I hope that when you return to your countries you will preserve an agreeable memory of the Italian people, who want peace provided it is accompanied with justice."

"The people of Rome have received you with great pleasure since you are former soldiers who have demonstrated your courage in battle, because you are Catholics as well as patriots."

### RELEASE OF TWO STUDENTS IS SOUGHT

(A. P. By Guardian's Special Wire) NANKING, Sept. 8.—Release of a Canadian and an American student held at Kansu Province was ordered today in a telegram sent authorities there by the foreign office.

The telegram asked the Kansu officials to explain the circumstances of the detention of H. Desmond Martin, 24, of Montreal, and John de Francis, 24, of New Haven, Conn. It was sent after officials at the United States legation asked foreign office help in having de Francis released.

The two youths were detained as they sought to proceed toward Lanchow, a Communist stronghold. Reports from the province said their students' travellers' passports had been taken from them.

PEIPING, Sept. 8.—An investigation was under way today into reports of the detention by provincial authorities in Northwest Kansu of two students, a Canadian and an American.

Foreign advisers said H. Desmond Martin of Montreal, 24, and John de Francis, also 24, of New Haven, Conn., were detained when they sought to proceed toward Lanchow, a Communist stronghold. Their students' travellers' passports were said to have been taken from them.

Martin and de Francis were language students, attached to the British and United States embassies at Kiuchuan (Hsuehchow), Kansu Province.

(Officials of the department of external affairs in Ottawa said they were not inclined to take a serious view of the incident. No official report on the case has been received. (Martin was graduated from McGill University in 1934, and was interested in the Chinese language.)

### Escape Injury In Driverless Automobile

(C. P. By Guardian's Special Wire) KENTVILLE, N. S., Sept. 8.—Four persons left helpless in a moving automobile early today, after their driver jumped out at the sight of a constable, escaped injury when the driverless machine crashed into the police car on the highway near Berwick.

Royal Canadian Mounted Police Constable Frank MacGowran chased the fleeing driver after the collision but was unable to overtake him.

Returning to the scene, he arrested Elmer Guest, owner of the car, on a charge of drunkenness.

Few details of the incident were disclosed tonight as the police continued their search for the missing driver, but it was learned that the car he abandoned was occupied by two men and two women.

OFFERED CONCESSION

LONDON, Sept. 8.—(A. P.)—A Reuters News Agency dispatch from Cairo said it was learned there today the concession obtained in Ethiopia by Francis M. Ricketts for United States interests was offered first to Premier Mussolini.

Proposal Rejected

A French proposal that an Italian protectorate be placed over Ethiopia, similar to that of Britain over Iraq, was rejected by Government officials. They pointed out Haile Selassie has consistently turned down all suggested solutions of the crisis involving any kind of domination over his Empire.

A suggestion that Ethiopia be policed by an international force as the Saar once was, aroused lively interest, but in the absence of details officials maintained an attitude of reserve.

Some sources suggested such a formula might be the basis for the solution if it does not give Italy political and economic domination over the Empire. These sources expressed a conviction that if Premier Mussolini were given any kind of supremacy under international auspices, he soon would make Ethiopia an Italian colony.
