AVYSHIRE BREEDERS MEET.—A very successful demonstration and judging class was held at the farm of Messrs. Easter Bros, Central Row on Friday Feb. 25th. A large number of farmers and breeders being present. Two classes were judged one a class of two year old heifers and a class of mature cows. Mr. W. R. Shaw, who conducted the judging, commented on the very fine quality of the animals in both classes. After all present had an opportunity of looking over the animals Mr. Shaw called on some of the boys and some of the older breeders to place them and give their reasons. On account of the uniform high quality of the animals there was considerable difference of opinion which elicited much helpful discussion. The mature class included such animals as Lady Spot of Spruce Row 16,040 lbs milk and 377 lbs butter fat and Lady Afton of Spruce Row 13,587 lbs milk and 612 lbs fat at a four year old. At the close of the judging Mr. J. A. Clarke gave some interesting information on the feeding methods followed by the Experimental Farm. Mr. Easter gave a description of the system of herd management followed at Spruce Row placing particular emphasis on the necessity of liberal feeding of dairy cows if satisfactory results are expected. Mr. Shaw gave some very instructive figures taken from contesting records showing the greater profit over feed cost made by well bred cows. After some further discussion on feeding problems taken part in by the breeders a hearty vote of thanks was tendered Messrs. Easter Bros for the use of their fine herd and barns for this demonstration. This is the first of a series of meetings planned by the Avyshire Breeders for the promotion of the dairy industry the time and place of the next meeting will be announced through the press in a few days.

FRIDAY
The annual meeting of the Sheep Breeders Association was held yesterday morning in the League of the Cross Hall. President W. H. McGregor occupied the chair. Mr. J. W. Boulter, Secretary, read the minutes of the previous meeting, and were adopted as read as was the financial report which showed the Association in a good financial condition.

A general discussion was opened by Mr. Oliver Saunders relative to the killing of sheep by dogs, also the collecting of dog tax, sheep insurance, etc. Mr. Saunders said there were only about 270 sheep insured and it would be better to have all insured or none. Dog taxes said were not being collected as they should be and that countless numbers throughout the country were running free and easy. Mr. J. A. Thompson of the Live Stock Branch, Ottawa who was present cited instances in Ontario where all dogs must be tied up between sun set and sun rise. He thought that if this were adopted on Prince Edward Island the killing of sheep by stray dogs would be very much curtailed, because the most depredations occurred between sun set and sun rise. The suggestion met with great approval. After considerable discussion on the question the following resolution to be presented at

the next meeting of the Legislature was passed: Resolved—Whereas That under the present system all farmers authorize that a resolution favoring the payment by the Government on all sheep killed by dogs or wild animals without the paying of any insurance fee.

Moved by W. B. McLellan, and seconded by T. J. Emman.

Mrs. James T. McLeod passed away on January 30th, 1927, at the home of her daughter, Mrs. (Senator) S. J. Crowe, at the advanced age of ninety-five years.

Until about two months before her death she was able to enjoy life and to take an interest in all that was going on around her.
