Georgetown and Vicinity

Mr. John Hogan, agent for R. E. Mutch & Co. and Mr. Ralph Boates, representing Royal Sales were interesting spectators at the opening night activities of the new rink.

Mr. and Mrs. Alec Arsenault of Charlottetown and Mr. and Mrs. Herbert Stewart also of Charlottetown attended the opening of the new rink and Recreational Center in Georgetown last week.

The Georgetown-Lower Montague ferry is continuing to make her daily trips to Lower Montague. Although the harbour is partially caught over by ice formed during the past few days, the boat continues to operate and was on her job on Friday, January 30th. In conversation with Captain Henry Larsen, he stated that the final crossing last winter was on January 26th.

Frederick J. Jenkins died Tuesday Jan. 10th, at the Faulkner Hospital in Jamaica Plains after a short illness. Mr. Jenkins was born in Prince Edward Island but moved to the U.S.A. forty years ago and has made his home in Brookline, Mass. for about 33 years. He leaves a widow, one son, W. Wallace Jenkins and three daughters, Mrs. Frances Adams, Mrs. Frederick Davidson and Mrs. Priscilla Jenkins. Services were held Thursday at the Bell Funeral Home and burial was in Walnut Hills Cemetery. The late Mr. Jenkins leaves to mourn a brother, A. E. Jenkins, Georgetown, two sisters, Mrs. R. E. Foss of Peabody, Mass. and Mrs. E. C. Rogers of Maine, also a half brother, Mr. W. R. Jenkins, Charlottetown, and a half sister, Mrs. Joseph Holmes of the U.S.A., also several other relatives.

Many friends in Georgetown and vicinity were shocked to hear of the sudden death in Boston of Mr. J. Wesley Gordon, formerly of Georgetown Royalty, a son of the late Mr. and Mrs. Walter Gordon. The late Mr. Gordon a prominent business man of Boston left here as a young man and was one of our successful islanders. As a boy he attended the Royalty School winning a Kings County scholarship. After a course in Prince of Wales College, he entered the service of the Bank of Nova Scotia, where he worked for a few years. He resigned his position in the Bank and shortly after went to Boston and rose rapidly in the business world. He became president of the Metropolitan Federal Savings and Loan Association of the Gordon-Dawson Co., and a member of the Board of Directors of the Boston Flour and Grain Exchange. He leaves to mourn a widow, formerly Miss Frances Bingham, an adopted son, Holmes, and two sisters, Annie (Mrs. N. D. MacDonald), Cambridge, Mass., and Miss Inez Gordon of the National Bank of Boston, a brother, Heber, predeceased him a few years ago. The late Mr. Gordon usually spent his summer vacation on the Island. Deep sympathy is extended to the bereaved relatives.

The third meeting of the Georgetown Home and School Association was held in the Council Chambers on Thursday, January 20th at 8:15 p.m. with 31 members present. The meeting was opened by the singing of "O Canada", after which the minutes of the previous meeting were read and after some discussion adopted. Following the reading of the minutes some discussion took place on the water supply for the school. Various speakers gave their views on the best solution to the problem. Among the suggestions offered were: a bored well on the school property, or tapping the line from Griffiths pump to the station. It was finally decided that it would be necessary to obtain expert advice on this matter and a committee of three to be appointed by

the president and secretary, was instructed to inquire into the project. This was moved by Rev. S. J. Boyce, seconded by Mrs. Florence Jenkins. Roll call was then held and each one present indicated his or her desire to become a member by paying a membership fee of 25c. The guest speaker for the evening, Cpl. Green of the R.C.M.P., was then introduced. Cpl. Green's remarks under the heading of "The Control of Youth in the Small Communities" were enjoyed by all present. He stressed the need for organized youth clubs at which both social and educational programmes could be carried out. In his remarks he stated that juvenile delinquency was the result, not of riches or poverty, but of faulty environment and abnormal discipline. Discipline, he said, should be maintained through respect, not fear. In conclusion he offered to answer any questions which the meeting might ask, if he were able to do so. On the question regarding a Curfew Law he stated that he did not think this was a solution to control of youth. This question started a general discussion and various speakers expressed their opinions on how best to solve the disciplinary problems in the home and outside the home. Mr. J. A. B. MacConnell remarked on local problems and that the co-operations of the various organizations was required. Such as the controlling of open nights for school children at the various entertainment places. Cpl. Green suggested that the officials of the Home and School Association meet with the officials of the various entertainment projects, to agree on arrangements of attendance of school children at such places. Rev. O. Kiggins expressed his disapproval of a Curfew Law and was of the opinion that the restrictions imposed on the children should come from sources other than the authorities. Miss Rita Wright and Mrs. William Murphy discussed the problem of home study and the difficulties encountered by the parent and teachers with regard to this point. With regard to curbing the social entertainment of the pupils during the school week it was decided to appoint a committee to meet with the officials of the Recreational Center and the League to determine suitable arrangements. Rev. S. J. Boyce then moved that the following be appointed to that committee: Miss Rita Wright, Mrs. Agnes Murphy and Mrs. William Murphy. Motion seconded by Mrs. Henry Larsen. A vote of thanks was then extended to Cpl. Green of the R.C.M.P., for his assistance and address. On motion by Rev. Sidney J. Boyce, seconded by Mrs. Marion George, Mrs. J. A. B. MacConnell moved that a letter of thanks be forwarded to Inspector Anderson of the R.C.M.P., for his co-operation and assistance to us, seconded by Miss Janie Batchelder. The meeting then closed with the singing of the National Anthem.
