The snow storm was quite heavy in Souris yesterday and quite a heavy sea running in the harbor. The Montague market prices which appear itemized in another column of this issue are the same as when last published. Thomas McDonald, Georgetown, was in Souris yesterday. He intends leaving today for East Point where he is going to fish lobsters this season for Stiers Bros. The roads are nearly impassable in East King's County, as many of the long hills and deep hollows are still unbroken and the sleighs making their ways in and out among the fields and fences. The inhabitants of Red Point are intending to complete the hall over the school this summer. Another hall is to be built near the southern end of the Baltic Road, not far from the residence of Wallace Stewart. Capt. John Dicks, George Currie, James Poltan, Charles Thistle and George Keenan of Georgetown, arrived in Souris by last night's express. They will proceed today to East Pt. where they intend lobster fishing this season. A thunder storm unusual in its severity for this season of the year passed over the eastern part of the Island at noon on the 11th inst. A tree, in the grove in the rear of John C. Campbell's buildings, Red Point, was shattered by the electric fluid. A meeting of the town council was held in the town hall, Souris, Monday evening, the full board being present. YESTERDAY IN THE LEGISLATURE

(Continued from page 1.) He did not think it in the public interest to give names or further particulars. MR. MATHIBSON called the attention of the House to the report of a debate in the House of Commons recently on the question of federal and provincial control of the fisheries, in which Hon. Mr. Brodeur had stated that an agreement had been reached with the Governments of the Maritime Provinces in regard to the oyster fisheries. THE PREMIER replied that no agreement had been definitely made. All the information in his possession on the subject had been submitted to the House. The House resolved itself into Committee, Dr. Warburton in the chair, to consider the bill to amend the Land Assessment Act. THE PREMIER explained that the object was to exempt cheese and butter factories from assessment. The bill was agreed to and reported without amendment. MR. WYATT moved the House into Committee on the bill to incorporate the Summerside Racing and Breeding Club. Mr. McKinnon in the chair. The petitioners are Arthur C. Rogers, H. W. B. Staver and Gilman N. Reid and their associates. Capital \$5,000 in ten dollar shares. After considerable discussion the Premier moved an addition to clause ten, to the effect that the company should not go into operation until one third of the capital stock is subscribed.

AFTERNOON SESSION.

FEARFUL END OF THE DRUNKARD.

Rev. Fr. Hubert, of the Passionist fathers, conducting the mission for men at the Hotel de la Holy Cross, Boston, spoke upon the sin of drunkenness. He pointed out that from this evil much suffering and hardship resulted, and urged the men to do what they could to prevent men from being guilty of drunkenness. He drew a strong picture of the situation that would confront a priest were he called to the dying bedside of a drunkard, one who had been robbed of his senses. The priest would be absolutely unable to help one in such a state. Fr. Hubert said: "There is in the sin of drunkenness an especial malice because it ties the hand of God's mercy and refuses to allow him to exercise that most prized of his attributes. 'Do you believe this? Listen! Here is the priest of God called from his bed in the dead of night. Someone is seriously ill. The priest goes and finds a man on the brink of time about to make that terrifying leap into eternity. Dying from drink, that man has been repeatedly warned and has ever despised all good advice—gone back to the glass, well knowing the evil consequences. He has therefore knowingly and willingly put himself into that desperate position. 'O, verily, brethren, the priest is an angel of peace in human form, deputed to bring to the departing soul pardon, strength and consolation. But what can the priest do for the dying drunkard? Nothing. He is helpless. He sees a man under his very eyes about to go and stand before the judgment seat of God, his soul in mortal sin, and he cannot absolve him. His hands are tied. 'If the Pope of Rome were at that bedside in all the plenitude of his apostolic power, he could not absolve him. Yes, though the arm of God's mercy is long, infinite, it is not long enough to touch the soul of that dying drunkard. 'God Almighty cannot absolve that man. Brethren, even more. It is a terrifying statement, but it is true: If on the first Good Friday that man in his wretched condition were placed beneath the cross, if the precious blood of Jesus Christ were to trickle down upon him it would not take away his sins. Drunkenness has placed him beyond the reach of God's mercy. 'This desperate state of things may seem exaggerated, but it is not. Look at the reason. The first absolutely indispensable condition for pardon of sin is repentance or sorrow of the soul that grieves because it knows it has been guilty of a grave wrong. Does the drunkard lying there grieve because he has done a grave wrong? He does not. Nor even does he know that he has been guilty of any wrong. 'He knows nothing of right or wrong, any more than a brute beast. His intellect is dead for the time being, drowned in the food of alcohol. He is incapable of rational repentance, and therefore incapable of pardon, entirely beyond the reach of God's mercy. The reverend speaker closed with an appeal for righteous living, shunning the occasions of sin and safeguarding the soul.

PREMIER AND ALLIANCE

(Continued from page 1.) G. E. Full was the next speaker, beginning with a reference to previous appearances before the Government. He made extended reference to the search warrant clause and said that the clause at present in force had been looked upon as drastic yet it had injured no one. He said Charlottetown Club was aimed at in the new clause. In concluding he said the temperance people were willing to let the government pass the act as presented by the Provincial Temperance Alliance with the same provisions as in the case of Scott Act—subject to a vote of the people. Dr. J. H. Ayers then spoke briefly in support of the new measure emphasizing the sincerity of the delegation in presenting a bill tending to improve the moral and material welfare of the province. R. C. Goff made a short reference to the search warrant clause and said that it could be modified. Remarks were made by Henry Rackham and Inspector Jenkins and the Premier then rose in reply to the delegation. The Premier said that the arguments in favor of the proposed bill were advanced as strongly as he thought they could be. He could not agree, however, with the previous speakers that the measure was not too drastic. He had read the bill carefully many times and so far was not able to convince himself that the Government would be justified in passing it. He thought it more radical than any bill of its nature on the face of the globe. He said that a man's home was supposed to be his castle and should not be devastated except in extreme cases; but this was not shown to be the case in this bill. By it citizens would be deprived of their rights when people were allowed to enter under the provisions of the search warrant clause, it might be on the spiteful information of outside parties. In this way it was the most radical measure suggested in any part of the world. He pointed that no remedy was arranged for any who might be wrongfully searched and also showed that under this act the accused must prove his innocence, and not the accuser the party's guilt. This was in violation of all British law which assumes a man innocent till proved guilty. He challenged the delegation to state a case where a similar law existed. One of the delegation said the State of Georgia had a more stringent act, but the Premier did not think it as severe. He made reference to the power of the Government in restricting the importation of spirituous liquors and then went on to speak of the provisions in the new act respecting doctor's responsibility. He said their power was not a plaything to be operated at the will of the people nor was there to be any discrimination of persons. He said this part of the law as referred to by a previous speaker left open a gate for transgression. Speaking of the present prohibition act, he thought it was effective and working properly and thought this bill would be an injury to the present working of the act. In fact the greatest blow to prohibition that it had yet received, he said that he knew his sentiments in opposing the proposed act were the sentiments of the whole Government and closed by saying that the proposed bill, if passed, would surprise the world. MR. MATHIBSON pointed out that no declarations had so far been received except from those who thought they were taxed too high. Those whose taxes were low did not make declarations. He thought the salaried class, teachers, clergymen and civil servants whose incomes are known need not be expected to attest to their income. There was great difficulty in ascertaining the true amount of income in many cases. Experience had shown that declarations received could not always be relied upon. HON. MR. RICHARDS pointed to the difficulty of ascertaining what a man's income is, especially among the mercantile class. Sometimes the taxpayer himself does not know. He thought the best way was for the department to find out from the best sources what an income really is. The object of the bill was to place the income tax payer on the same basis as the farmer, with regard to the amount of his tax and the right of appeal to the court, if he felt he was taxed too high. MR. WYATT said the exemption of \$600 was an improvement on the old law. But the income of a single man and that of the head of a family, both receiving the same pay ought not to be taxed equally. The man of small means felt the tax more than the man of larger income. He favored a graduated tax, low on the first thousand and higher on the remaining part of large salaries. He questioned the power to collect for income derived from investment outside the Province. THE PREMIER had no doubt of the right to tax the income of persons resident in the Province, which income is derived from investments abroad. He did not favor the sliding scale. There were not many who are very rich. There are wide powers given in the bill to enable the Governor in Council to make any necessary regulations to give effect to the law. MR. ARSENAULT thought there was no necessity for any exemption in the case of incomes, say of \$1500 and upwards. Progress was reported shortly before adjournment and adjournment was made till 8 o'clock. EVENING SESSION. The House met at 8.40 o'clock. DR. WARBURTON moved the bill to amend the Game Act, Mr. Inverness in the chair. A main object is to prohibit the use of automatic or pump guns, and make some changes in regard to the close season. MR. MATHIBSON said if the most modern guns were to be prohibited, how far back would they go? The machine gun is more destructive than the double barreled, and that more destructive than the single barreled and so on. He had heard there were petitions against the bill. MR. McLEAN had received petitions against the bill. MR. ARSENAULT said he had received about 100 letters from well known sportsmen against the bill. DR. WARBURTON said the Game Association which had taken this matter in hand, had consulted leading sportsmen in regard thereto and four favored allowing the automatic gun. HON. MR. RICHARDS thought any birds that a man could not get with a double barreled gun ought to be allowed to go. In several states in the west the use of the Northwest these guns were prohibited. He approved the bill. We should protect our game, which is none too plentiful. MR. COX thought we should protect the game. Any man could get all the sport he wanted with the ordinary breech loader, if game was plentiful. THE PREMIER said he was not much of a sport. He had received some letters on the subject. One of these he read telling of the exploits of an American sport who had decimated the ducks in the western part of the Island. He had also a letter or two from the east against the proposed amendment. He thought we ought to do what we can to protect our birds, or they would all be destroyed or frightened away. It had been proposed to limit the number of birds any sportsman should be allowed to shoot. If we did that no one would want a machine gun. He approved of the bill. DR. WARBURTON said it was proposed to make every second year a close season for partridges, beginning with 1912. The discussion was continued by several speakers in a conversational way. The bill was agreed to with amendment at 10.10 o'clock, when the House adjourned till tomorrow morning at 11.
