

SUNSHINE FURNACE And Coal Economy

COMBUSTION taking place in the dome or top chamber of furnace fire-pot is the result of air and heat mingling with fumes. This combustion produces heat-energy, which the radiating surfaces above and around fire-pot absorb or draw in and then deflect or throw off. Incoming cold air receives this heat-energy, the result being heated air. Now, if the combustion takes place at a faster rate than the radiating surfaces can absorb and deflect, the surplus heat-power will pass up the chimney or into cellar—a waste of coal.

There is no waste of coal in "Sunshine" Furnace. Circulating space so large, that every bit of heat-energy is quickly absorbed and quickly deflected on the circulating cold air, which is thus quickly heated and ascends through the hot-air pipes to rooms above.

When check-draft is opened the incoming cold air from the cellar drives all heat particles back into furnace proper. If the grates and fire-pot of furnace are not constructed properly, there's a clogging and gathering of ashes, and fire does not burn up readily. If no provision is made for gas escape, the check-draft must be left closed indefinitely—a waste of coal.

There is no waste of coal in "Sunshine" Furnace. From time to time knowledge of such cases comes to my notice, and after investigation I recommend their suspension. Also, death claims are disallowed now and then owing to death being due directly or indirectly to the too free use of alcohol.

A thing that interferes with a man's success, and shortens his life, is not likely to be popular, and alcohol is less popular every day. While it is gratifying to note the progress that is being made in temperance sentiment and activity not only in our own country, but in the U. S. and in England; yet one is compelled to say that there is great opportunity and need for individuals to live up to their professions when the opportunity comes to express their convictions by means of the ballot. The teaching of total abstinence principles in the schools and the work done in the Sunday Schools is having its effect upon the rising generation. There are still many voters who allow their party affiliations to sway their conduct more than the convictions which they hold and which do them greater credit. It is most important that Christian Temperance men make their influence felt early in the game of politics. They should attend the primary meetings for organization and for selecting the delegates to attend conventions and make their influence felt in selecting the right men as candidates in the constituency in which they are interested. Work of the greatest value can be done at this point as they may thus prevent their fellow electors from being put into the position of being compelled to choose between candidates, neither of whom is entirely worthy of their confidence. It is often too late to do the best work when the candidates have been chosen. Of those who oppose the best interests of our citizenship are not to be allowed to monopolize the field of politics, then the electors who favor the higher tone in citizenship should see to it that they make their influence felt in the early stage of political action. Our cause certainly merits as much activity as any other, and those who have the cause of temperance at heart should be active, wise and prudent at all times to see that the full strength of the friends of temperance is brought out and cast on the side of right. The temperance people need, more than anything else, to cultivate the spirit of freedom and fair play, and they will not accomplish all they should, till this spirit is so urgent that legislators are compelled to sit up and do things and do them justly and with dispatch. Friends! In the present crisis of the temperance movement, it is necessary for the friends of temperance to unite their forces, so that their power will be felt by the parties seeking our support. It is votes that count with political parties. It is our duty and our policy as temperance men to support the party that supports our cause, and to oppose the party that opposes us. We must not vote for any man who will, in our name and as our representative, vote in favor of the liquor traffic. If we let it once be known that temperance supporters are so weak-kneed that they will vote for a candidate who is hostile to our cause, on the ground of party gratitude, then our cause is done for.
