Major G. H. Gordon Dies In Halifax

Major G. Huntley Gordon, a graduate in science of Dalhousie University and vice-president of the Dominion Foundries and Steel Limited, Hamilton, died Saturday morning in the Victoria General Hospital. Death followed an illness of a week.

The youngest son of the late Rev. D. M. Gordon, former minister of St. Andrew's Presbyterian Church in Halifax, Major Gordon served with the Canadian Army overseas in the First World War. A native of Winnipeg, he went to Halifax at an early age and was educated in that city. He graduated in Science from Dalhousie University and later attended Cornell University.

Since the end of the First World War he has been associated with the Dominion Foundries and Steel Limited in Hamilton, Ontario. His father, the late Rev. D. M. Gordon, former minister of St. Andrew's Church, was later a member of the faculty of Pine Hill Divinity College, and principal of Queens University in Kingston, Ont.

Surviving are one brother, Rev. Dr. A. M. Gordon, district Protestant chaplain at Halifax during the second World War, and a sister, Miss Wilhelmina Gordon. Both were with him in Halifax when he passed away. The funeral will be held in Kingston, Ont.

Major Gordon visited the Island only two weeks ago with his brother Rev. Dr. A. M. Gordon and while in Charlottetown they visited their aunt Mrs. A. E. Morrison and Mr. Morrison, and their cousin Miss Katherine MacLennan. R. N. Miss MacLennan was in Halifax for the last week with him in his illness.

An air freight service carrying P.E.I. products to the United States, Newfoundland and other points should be given federal aid. It is suggested that a P.E.I. should be coordinated for better service to the public, with more cooperation among them.

There should be more federal assistance to coastal shipping, particularly that engaged in trade between Prince Edward Island, Newfoundland and the other Maritime Provinces.
