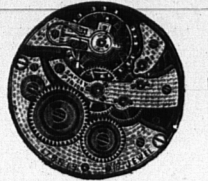

RUSH TO RECRUITS AFTER ZEPPEL RAIDS

LONDON, Aug. 21.—The Chronicle says: "For reasons which will be perfectly well understood by everybody there has been a spurt in the recruiting. It made itself felt in many quarters, and were it not for the loss of lives of helpless women and children we might welcome heartily the efforts of Count Zeppelin to swell the ranks of the British Army. The scenes on the Horse Guards' Parade and at the central recruiting office in Scotland Yard, to say nothing about those in the more remote districts, might, if they were picked up by the German wireless, instruct the Kaiser in the hints that the recruiting officers and children is exactly the way to break the spirit of the British people. The central recruiting office was crammed with men who had responded to the call.

"That voluntary recruiting is not played out was evident, indeed it was hinted that the recruiting officers were becoming slightly more particular about the standard of men they were enrolling, and it was said that as many men were being obtained as clothing are concerned."

NORWAY INDIGNANT OVER SEIZURE BY GERMANS OF THE MAIL TO ENGLAND.

CHRISTIANA, via London, August 22.—The halting yesterday of the Norwegian mail steamship Haakon VII, and the seizure of mails on board by German submarines have been followed by a protest to Berlin and a demand for the return of the mails to Norway. The Haakon VII was bound from Bergen to England.

The Postmaster General reports that the commander of the German submarine ordered the jettisoning of all printed matter and packages. "Despatched from Norway, France, Italy or other countries hostile to Germany. All letters and remittance money are said to have been taken aboard the submarine.

The mail consisted of accumulations since the clearance on Monday of the previous steamship. Included were seven sacks of mail from Denmark.

What the newspapers term the "mail theft" has aroused a storm of resentment. The Aftenposten says: "The news will be received with hot indignation and bitterness by Norwegians from North Cape to the Naes. The injury inflicted on England by seizing the mails is immaterial compared with the damage done to our country. The theft of neutral mails is not decent warfare."

German submarines are said to be watching every inlet to the important ports of Norway.

GERMAN LOSSES HAVE BEEN ENORMOUS.

LONDON, Aug. 23.—Though the German report Field Marshal Von Hindenburg's armies advancing east and south of Kovno and the General von Gallwitz's army is penetrating south of the Narva, across the Bialystock, Brest Litovsk railroad, and that Prince Leopold's army, fighting victoriously, has crossed the Wysock Brest Litovsk railroad the admission is made that the Bavarian armies drove the opposing forces, which had again obtained foothold out of their positions early yesterday, which was an admission that the Russians are fighting desperately, and must have administered a smashing blow to Prince Leopold's troops.

Great battles north of Plesca and northeast of Vidova are still raging. There is no news from the southwestern front of Brest Litovsk.

All the military experts agree that when Germany counts the cost of the invasion of Russia, the losses will not only stagger humanity but Berlin.

TO MY LAST SON AND DOLLAR, MOTHER

TALES TOLD BY MEN IN THE FIGHTING LINES ON LAND AND ON SEA

A CHARGE AT YYPRES.

Sergeant Stanley Turner of the 10th battalion Canadian Infantry, who for some years in the service of the surveying department of the C. P. R. in a letter home to his mother in England, written after the famous attack on the wood to the north of Ypres, says: "Just a hurried scrawl to let you know that I am safe and sound. You have no doubt seen by the papers that we were engaged in the new battle of Ypres, and (I hope you got my postcard) we had a very anxious time. Our battalion opened the assault. The Germans had a position in a wood, and we had orders to get them out. We charged the position and forced the enemy back, but our losses were very heavy. Their machine guns mowed our boys down like grass, but we stayed with it and came out on top. I went through the charge, but, with my proverbial luck, was not touched. Why, I do not know. Men fell all round me. It was a ghastly sight. The front of the wood was beyond description. Our dead and wounded were lying in heaps. We had the satisfaction of breaking the German attack at that particular point, and moreover, we held the position until reinforcements came up. I believe K. of K. thinks quite a lot of us now. Our whole division has had tremendous losses, and I guess we shall rest up and reinforce. But I can honestly say I don't want another time like that again—at least, not yet, anyway."

FROM YPRES.

A Winnipeg man with the 8th Battalion Canadian Infantry writes: "I got wounded on Sunday April 25, about one o'clock, after four days' hard fighting. It was an awful battle, and one I shall never forget. I suppose you heard about the Germans trying to poison us. Well, it did kill some of us. When I saw the gas coming in my mouth and held my nose, and breathed at long intervals until the gas went away. A drink of water afterwards made me all right. The next thing we had to contend with was the German coming right for us en masse. Everyone that was able got his gun, and after a good fierce battle we beat them back. But such a sacrifice of human life—men and horses dead, lying in heaps, and time may never be afforded to get them all buried.

DEATH OR VICTORY.

"One thing, we held our ground against fearful odds. No one ever thought of retiring, and we were pretty well thinned out by shell fire. Before the battle the French retired on our left, which made it worse for us. We were almost surrounded, and but for our Canadian boys in reserve beating them back, they would have been at us on rear and front; and our men saved the situation, but at an awful cost; but then it was either death or victory for us—that was the spirit of every man. We seemed to get stronger every day of the battle, and I had no sleep for five days and nights and very little food. After I got wounded I crawled half a mile to get my wounds dressed. The shells were bursting all around me, and bullets coming in all directions over my head. No matter where you went, you could see nothing but dead bodies.

NO PEACE FOR THE WOUNDED.

"After I had my wounds dressed I lay down for an hour or two in peace, but I got little or none, as the Germans started shelling the dressing station; a little house it was, but luckily they missed it. Next came the news of an order that our army was retreating, and as we were about 800 yards from the firing line, there seemed little hope for us wounded fellows. An officer came in and said that any of the men who could walk had better go ahead at once. I got up along with a few others, and thought I would try it. I did not relish the idea of being done to death by the Germans while lying there. I pitied the poor fellows who could not walk, but I think our comrades would have tried to save them anyhow. I started on my journey with the help of a comrade. I had a walk of two miles to go and during it we got no peace for shells bursting. The whole way down I came across the dead bodies of my comrades killed

HEADQUARTERS SHELLED.

"After being nicely settled down, 'boom, bang' go the shells again for the Headquarters Dressing Station. The shells came pretty close to knocking it down. The building 50 yards away was shattered to pieces. That is what we had to lie and listen to all night long; but thank God for bringing us safely through it. One of our ambulances with six patients was coming along the road when a 'Jack Johnston' burst and blew the driver and all to pieces."
