Like Suburbs Of Hell, Calder Says

MONTREAL, Feb. 22.—In point of squalor mining towns of Nova Scotia are the modern counterpart of the "Copetown" described by Charles Dickens eighty years ago as a horrible example of the results of the industrialization of England. R. L. Calder, K. C., said tonight addressing the members of the Pickwick Club of Montreal on "Hard Times," Mr. Calder is president of the club.

Referring to a recent visit he had made of mining towns of Nova Scotia, Mr. Calder described them as "like a suburb of the Hell which Dante described." He made a passing comment on the last miners' strike there: "I realize how foolish and unjust some of us were when we criticized those miners for their long strike," he said.

The speaker observed that Dickens had left the problem of Labor and Capital unsolved. "But I think we are moving toward a solution," he continued. He thought that nowadays that heartlessness of the relationship between employer and employees which characterized the industrial revolution," was being removed through organization for sport and social endeavor. Better housing conditions were also doing much to improve the situation, he said, with shorter hours, better working conditions and a recognition to a certain extent of the principle of collective bargaining.

MOTION CARRIED

WINNIPEG, Man., Feb. 2.—Premier John Bracken's motion for adjournment of the Manitoba legislature until tomorrow was carried in the legislature this afternoon by a majority of six.

Liberals, Conservatives and Labor members voted solidly against the government. The vote was: For 28; Against 22. There were four absentees three being Conservatives. Tomorrow Mr. Bracken will place a motion for an adjournment of the Legislature for one month when the findings of the Royal Commission investigating charges against the government are expected to be known. The charges followed the leasing of the Seven Sisters Falls Power site to the Winnipeg Electric Company. Lieut.-Col. F. G. Taylor, Conservative leader, preferred the charges.

Promotions in C.N.R. Legal Dept.



With the approval of Sir Henry Thornton, Chairman and President of the Canadian National Railways, Gerard Ruel, Vice-President of legal affairs, has issued the following circular:

"Consequent upon the much regretted demise of William Craig Chisholm (formerly General Counsel) who was an officer of unusual ability, of sterling worth, and a universal favorite, the following changes in staff are made, taking effect immediately: "Reginald H. M. Temple, formerly Assistant General Counsel, is promoted to General Counsel. "Alistair Fraser, K.C., formerly Commission Counsel, is promoted to Assistant General Counsel. "The position of Commission Counsel is abolished." Mr. Temple (left), joined the Canadian Northern Railway, twenty-three years ago as a member of the Accounts Branch of the Construction Department. Later he became Claims Agent and National Railways and Commission Counsel in 1923. Mr. Fraser will continue to deal with Railway Commission matters.



Temple was appointed regional counsel with headquarters at Winnipeg, in May, 1926. Mr. Temple was appointed Assistant General Counsel on the promotion of the late Mr. Chisholm to the position of General Counsel. Mr. Temple is a native of Toronto. On the occasion of the outbreak of the First Canadian Contingent under the then Col. Otter. He served in various capacities and was afterwards Commissioner of the Heidelberg District. Mr. Temple has the South African medal with four bars. Major Alistair Fraser, M.C., K.C. (right), was born at New Glasgow, and is a son of Hon. D. C. Fraser, former Lieutenant-Governor of Nova Scotia. He was called to the Bar in 1911, and created King's Counsel in 1921. He enlisted at the outbreak of the War in 1914, and served with the 17th Battalion, the P.C.L.I., and the 15th Battalion. He was afterwards A.D.C. to General Currie, Commander of the Canadian Corps. In 1919, he was appointed General Solicitor to the Canadian National Railways and Commission Counsel in 1923. Mr. Fraser will continue to deal with Railway Commission matters.
