When the vote was taken the resolution was adopted by five to three. Those voting for it were, Councillors, MacDonald, Blanchard, Butler, Laphorn and Douglas. Those against, Councillors, McKee and Sterns. Councillor McKee was in the chair at the time. Speaking in his resolution, Councillor MacDonald referred to the appointment of the two new constables for temporary service and explained that he used this term because the "power of appointing permanent members rests, not with the Police Committee or Police Commission, but with the entire City Council." He stated that he was going to take advantage of his right as a member of the Council "to nominate any candidate I see fit" he explained that the Council did not appoint them. Councillor Sterns said it had always been a practice to place new appointees on probation. "Gregory was on probation," he added.

Councillor McKee said that at first he had agreed with the others that the action of dismissing the policemen seemed "high handed." However, when he saw that the Council was "going the limit," he continued by reading a statement he had that on Feb. 24, 1941, Const. Gregory had been given one chance. On Feb. 26, 1941, Webster was given another chance and Gregory was included in that also. On Aug. 25, 1941, Webster was again warned. Councillor McKee added that they were not dismissed for drinking but on a more serious charge.

He said the Police Commission had the power to discharge; if the men were re-appointed they could be tried the next day by the commission.

Power of Commission In answer to a question from Councillor Douglas, Recorder J. A. Bentley explained that the police commission had full authority of discipline over the police force with power to suspend or discharge any policeman who failed to meet the qualifications for office. They received their appointment by the Act of Incorporation. Continuing he explained that the power of appointment if and as established by this commission is not vested in the City Council. The said Magistrate is authorized to appoint at the request of the Police Committee extra constables for temporary service.

Councillor Blanchard complained that there was only one Councillor on the Police Commission. He wanted to know if the others were "figureheads." nection with Reconciliation Week. In order to have complete cooperation, he had asked representatives of the various municipalities together, and was gratified by the response. He stressed the importance of the war issues at stake, and that the second anniversary of Canada's entry into the struggle. We have much to be thankful for, no heavy casualty list, no ravaged homes, no bombings at night, no towns and cities destroyed or loved ones maimed and killed. Many people in Canada do not realize the seriousness of the situation and the efforts of community leaders this week should be directed to the reasons why we are what we are facing. He had asked the Department of Education to have appropriate exercises in the schools during the week of Sept. 10-17 and Hon. M. R. McLaughlin had promised his whole-hearted support. The clergy are preaching suitable sermons during Reconciliation Week on Sunday, Sept. 14. The press and other publicity mediums are emphasizing the importance of the program.

Further details were explained by Major O. W. Campbell, Deputy Provincial Secretary. Gasoline Conservation Mayor Campbell, Summerside, said he regretted to note that the appeal for conservation of gasoline did not seem to be meeting with proper response. This he regarded as a serious matter, especially in connection with the re-dedication of our war effort. He outlined the programme arranged in Summerside for the conservation of gasoline during Reconciliation Week and paid tribute to the patriotic work of the Y Men's Club and other organizations. Mayor Campbell's remarks were warmly received by the group. He urged the desire of his community to cooperate in every way in making the week's observance a success. Mayor Campbell, Summerside, endorsed Mayor Campbell's remarks with regard to the need of conserving gasoline. Apparently those who have made a wrong start in this campaign, The Government should, he believed, take the matter in hand, and if other measures fail, he would not hesitate to call for a referendum on the issue. He said that he should have been shown the statements made by the two men. Councillor Sterns said that there had been no application made to the Police Commission for another chance. He admitted that there was a feeling abroad that the men had been hurriedly tried and convicted. However, it could be shown that they had numerous chances. The chairman of the Police Committee told of giving a personal warning to one of the men and added that a week before the offence in question the Police Commission had definitely warned one of the constables. He said the Police Commission had the power to discharge; if the men were re-appointed they could be tried the next day by the commission.

Major O. W. Campbell suggested that the various municipalities in that section of the province could arrange to hold joint functions in connection with Reconciliation Week. from Spitzbergen which would be used mainly for war transport to the far north. This source of fuel has now been denied to the Germans.

An immediate result of the Spitzbergen landing is that a considerable number of Norwegian miners with their families have now arrived in Great Britain to play a part in the allied war effort. Most of them will be joining the Norwegian forces or the Norwegian merchant service.

The archipelago has a total area of 25,000 square miles and is only 750 miles from the North Pole. The island, West Spitzbergen, is a plateau, many of its peaks are high. Pack ice prevents access to most of the islands except for a few months in the year. However, vessels can approach the western coast during most months. The fjords are frozen from October to May.

The coal mines have been worked by both Russian and Norwegian miners. In 1936 they had a combined output of 707,117 tons but this has been considerably increased. The islands' inhabitants totalled 466 in 1936, of whom 654 were Norwegians.
