Nothing is too good for the boys of the nice little, tight little island. (Signed) Sam Hughes."

WAR SOUVENIRS.—In the Great George Street window of the McKinnon Drug Company store there is now displayed several souvenirs of the European war. They comprise a German helmet taken from the trenches during the battle of Festaubert on May 10th, also a German forage cap, dum-dum bullet, piece of shrapnel and bandolier—all German. These were sent to Mrs. A. P. Large, of Bayfield street, by her son, Heber, who is a signaller on active service in France and one of the first to volunteer from this Province.

AT BONSHAW.—Mrs. Dunbrack accompanied by Miss Sterns and Miss McFarlane held a public meeting at Bonshaw on the afternoon of the 23rd June and organized an Institute at that place with the following officers:—Pres., Mrs. R. N. Stewart, Bonshaw; Vice Pres., Mrs. C. W. Crosby, Bonshaw; Secretary, Miss Blanch Beaton, Bonshaw; (the directors to be elected at next meeting). Regular day of meeting second Wednesday in month at 2 p. m. The first place of meeting to be in Court House on the afternoon of July 14th when one of the Supervisors will be present and give a demonstration in Home Nursing.

"INTERESTING MEETING."—A well attended meeting was held in the Parish Hall at Rollo Bay on the evening of June 24th when Mrs. Dunbrack addressed the ladies and gentlemen of that section. The result of the meeting will be the organizing of two Institutes at a special meeting at 2.30, July 9th, Parish Hall, Rollo Bay, to which all ladies of the districts of

Rollo Bay, Rollo Bay East and South Bear River are specially requested to attend when the election of officers will take place for the two new Institutes to be formed at that time. It was also requested that a speaker be in attendance on the same evening to organize an Institute in Souris West, the meeting to be held in the school-house at that place at 7 o'clock.

TOBACCO FUND.—Hon. Mr. Arsenault, who has been taking up a subscription for tobacco for the Island boys at the front, informs the Guardian he has now over fifty dollars. He is making arrangements for the expedition of the tobacco through the agency of the Overseas Club, England. This club, by arrangement, for the sum of one shilling, forwards a packet containing four ounces of tobacco, fifty cigarettes and a supply of matches. The names of the contributors are forwarded at the same time and each soldier receiving a packet of tobacco and cigarettes will also receive a postal card addressed to the donor so that every contributor will probably in time receive a postal card from some soldier at the front. The following receipt of the tobacco and cigarettes: The Overseas Club forwards the tobacco to any British, French, Belgian or Colonial Contingent serving at the front and in the present case in so far as it is practicable to do so to the Island boys at the front. Any person who has not already subscribed and who wishes to do so can leave or forward his subscription to the Hon. Mr. Arsenault on or before the third of July as the money will be sent forward on the fourth.

The Trinity Term of the Supreme Court opened in Charlottetown yesterday morning, the Chief Justice, Sir W. W. Sullivan, and Messrs Justices Haszard and Fitzgerald on the Bench. The Grand Jury were:—W. H. Aitken (foreman), Charlottetown.

In his charge to the Jury the Chief Justice said that there were two criminal cases. The first was against E. L. Harrington, who was charged on two counts, with first, shooting with intent to murder; and second, shooting with intent to do grievous bodily harm. His Lordship reviewed the evidence in the case, which he said was a serious one. He stated that it was not clear that persons who used firearms indiscriminately and that others should do so with impunity. The next case was that of the King v. John Sherry, who is charged with the theft of \$100 from a man named Burge, of St Peter's, in March last in Victoria Park. His Lordship read the statement of Burge and remarked on the folly of simple country folk becoming intoxicated and allowing unscrupulous men to rob them. Remarkable on the escape of Sherry from jail, he said there was no indication that the man had been granted bail and the inference was that he had gone abroad. The Jury must examine the jail closely and particularly to ascertain whether the men in charge were competent and the jail in proper condition or not. They should fearlessly place the responsibility upon the prisoners' escape on the party whom they considered responsible, whether jailor, sheriff or any other officer. They were on their oath and must do their duty. It had been brought to his attention that the jailor was a man against whom there was an outstanding conviction in respect to the Prohibition Act. They must say whether he was fit or not for his position.

At 5.45 p. m. the Grand Jury returned and submitted their report. In regard to the jail they stated that some of the locks were not as they should be and recommended that other locks be placed on the doors. The Chief Justice then addressed them briefly, remarking on the absence from their report of any reference to the jailor. He thought there should be a fence around the jail so that persons would not be able to pass things one to another as at present through the open iron bars. He had called the attention of Juries to this matter, but nothing had been done. The Grand Jury were then discharged.

DRIVING CLUB MEETING.—A meeting of the Charlottetown Driving Club will be held Friday evening, to make arrangements for the next meeting, which will be held in connection with the Orange Tea, July 12th.

COD FISHING.—Messrs. Ed. Duff, David Jay and Lorne Jay, Mt. Stewart, went out fishing cod on Monday and returned with a barrel of fine fish. They report the fishing on the North side the best of any past year. They hooked them as fast as they could haul them in.—L.

SUPREME COURT.—The Supreme Court met again yesterday morning and after the disposal of some ordinary routine business, three judgments were given against G. L. Poole by consent. The Court then adjourned until Monday morning, when the Pettit Jury will be in attendance.

TRAINS CROWDED.—Yesterday afternoon the outgoing trains from this city were taxed to their utmost, some having to take on extra cars to accommodate the passengers. This was largely due to the Big Dollar Day in this city and excursionists going to the rural districts to spend Dominion Day.
