"I have been in a few scraps." Witness was questioned as to his actions on previous occasions and admitted having trouble with neighbors and his family. On one occasion he was fined \$5 for hitting a man. On Saturday evening previous to the present quarrel he had left home to do some business in Kensington. He had had a good drink of liquor and two very little ones out of three half-pint bottles shortly after his arrival at Kensington.

"Are you employed by the town of Kensington to keep the peace?" "No, sir." "Do you make it a habit of interfering in quarrels when you see them going on?" "I want to see friendship always. Was it any of your business?" "Did not want to see them fighting." "Did you want to see yourself fight?" "No, sir."

Witness lived five miles from Kensington. Going home he passed Robertson Mann's place a mile and a half out of Kensington and continued on his way to Jas. Campbell's, about a mile from his own home. After the quarrel with Robertson Mann on the road he had chased Mann until he got over the wire fence, two or three hundred yards from Mann's gate. It was a pretty dark night. He was not sure whether he followed him over the fence or not.

When Campbell was being attacked at his own home he had a stick too—a hardwood stick about fifteen inches long which he picked up from the wood box in the course of the fray. He did not have it when he went to the door first, but went back and got it. He came out with the stick to protect his place.

Witness did not know whether he hit anybody with the stick, or how long he had possession of it. He swung it around and smashed the windshield of the car. He lost the stick after that.

"You have no recollection of hitting anybody with it?" "No, I don't think I did. I wasn't lucky enough."

Witness possessed a double barrel gun and some No. 10 shot. After the Manns had left he hitched up the horse, put the gun in

the wagon and went to Kensington to see Mr. Profit, J. P. He called first at his uncle's (Jas. Campbell) and proceeded to Kensington unaccompanied. Leaving Kensington he drove to Clifton and returned home just after daylight. He had ammunition for the gun with him but could not say whether the gun was loaded or not. He admitted to some family quarrel about seven years ago.

DR. S. R. JENKINS testified that plaintiff had come to his office for treatment on Monday. He had had bruises about the face. His right ear was badly bruised, swollen and discolored. The injuries to the shoulder appeared to have been caused by a blow on the head or possibly to falling on some hard surface. The man appeared to have been badly beaten up. (To Mr. Inman). Did not know whether plaintiff suffered from rheumatism or not, he had never treated him before. There were no actual cuts on his body, only black and blue bruises. The marks on the left arm might have been caused by the grip of fingers.

Keir Mann sprang out of the car and opened the outside door. Campbell opened the inside porch door and they met in the porch. They clinched and went outside.
