nounced that treaty," the Reichsfuehrer declared in an explanation of events of the last few days. "It drew from this fact the only logical consequence—namely, the re-establishment of its sovereignty."

The Nazi leader said he had "tried to apply the same principles that guided the Polish-German relations also to our relations with France."

"Perhaps this was the first time a German nationalist has asserted that continuity of the hereditary enemies between the two nations was senseless."

He drew a colorful picture of the centuries-old conflict between France and Germany and expressed his personal opinion that "dispassionate consideration of our mutual interests must lead us to understanding."

**Bitter Attack**  
The Reichsfuehrer turned from the appeal from European peace to a bitter attack on Russia.

"While Russia is not on the German border, still through pacts she has been brought, through a third state, to Germany's frontier," he said referring apparently to the Franco-Soviet mutual military assistance treaty.

Critics of Nazi Germany have taken the appeal for mutual national co-operation in a questioning attitude. Hitler declared, asking "is not this too ideal?"

Eden suggested that Germany withdraw all but a "symbolic" number of troops and promise not to fortify the zone until a treaty had been negotiated and the international situation "regularized."

Although Eden told the German Ambassador, Leopold Von Hoesch, it would be difficult to exaggerate how gravely Britain views the situation, Hitler answered that Germany could not enter into any limitation of her sovereignty in the Rhineland, but promised neither to increase the strength of certain garrisons nor to move troops closer to the French and Belgian borders.

Hitler meeting the British appeal about half-way also appended it with a blunt indication that France and Belgium would have to take similar steps in order not to menace Germany.

Seek Conciliatory Gesture

LONDON, March 12.—Significance was attached by informed quarters tonight to the fact that the Foreign Office communicated to the French, Belgian and Italian representatives here the reply of Germany to Britain's appeal for some conciliatory move on the part of Chancellor Hitler in the Rhineland.

The German answer, submitted by Leopold Von Hoesch, the Reich's ambassador here, made clear Germany would not withdraw any of her troops from the Rhineland, as requested, nor undertake not to fortify that area. But it did not

**Murder Doctor Tells Fantastic Story**

**PIN-BALL MACHINES BANNED**

Operators in City Given Until Saturday To Do Away With Games.

Pin-ball machine operators in Charlottetown yesterday were given until Saturday to do away with the games in a ban issued by police. Acting upon instruction of Attorney-General Thane A. Campbell, police warned that machines found in operation after Saturday would be confiscated and the parties on whose premises they were found would be prosecuted.

Attorney-General Campbell said last night he had been contemplating action against the operation of the machines for some time and he had discussed the question of banning them with Charlottetown police authorities on several occasions.

Operation of machines used for gambling purposes was contrary to Section 229 of the criminal code, he said.

A delegation from Prince Edward Island Ministerial Association waited upon the Attorney-General Wednesday carrying complaints against operation of the pin-ball games in this city.

Rev. J. W. Barbour, leader of the delegation, said last night pastors of Charlottetown churches had received numerous complaints from parents whose children spent a great deal of time and money playing the pin-ball boards. Police reported some children were using money taken from home without permission to play the machines, Rev. Mr. Barbour added.

He stated the slot games had been done away with in Nova Scotia, New Brunswick and Ontario.

They were banned in Summerside last month.

**Italy Adopts Passive Role**

Italy, adopting a passive role because of sanctions against her, was solely represented by Dino Grandi, the Italian Ambassador to London.

The talks were continued informally tonight at a dinner given by Eden, which seven Frenchmen, six Belgians and 13 Britons attended.

Details of what occurred when Foreign Minister Flaminio Piccoli, Premier Van Zeeland of Belgium, and Grandi met Eden and Viscount Halifax, Lord Privy Seal, alone, were not disclosed except that they found Germany guilty and the French emphasized their original position that Hitler must absolutely withdraw troops from the Rhineland.

There was no indication that the British are withdrawing from their position that Hitler is entitled to a hearing. This withdrawal may come swiftly, however, if Hitler's answer to Eden is his last word.

It was authoritatively stated the British position of trying to follow the middle road and avoid action which might culminate in war becomes increasingly difficult unless Germany cooperates and accepts Eden's suggestions.

**Ex-Convict To Speak On Crime**

"Silent Bill Biddle" lectures and radio talk, who believes that the home is largely to blame for cases of juvenile delinquency, will lecture in the Strand Theatre on Sunday afternoon and evening. "Does crime pay?" is the striking title of the speaker's talk which has impressed many groups in his wide-spread campaign from coast to coast. His mission is "evangelistic and uplifting—an attempt to tell the youth of today that crime does not pay."

A most interesting lecturer, Mr. Biddle stated that he had voluntarily decided to devote the remaining years of his life to the education of youth against crime. One of the outstanding points of the speaker's talk concerned the segregation of juvenile offenders from hardened criminals in prison life. He explained how the older "men" could influence the younger toward a worse life; how they could lose the benefit of the lessons taught them by association with the hardened offenders. Mr. Biddle's appearance here Sunday is his second. His case, which has been mentioned in magazine articles and radio programs, concerns his 16 years' experience in Sing Sing. This talk by Mr. Biddle, ex-convict and gangster, is very timely in view of present interest in the crime situation and prison conditions.

Although Eden told the German Ambassador, Leopold Von Hoesch, it would be difficult to exaggerate how gravely Britain views the situation, Hitler answered that Germany could not enter into any limitation of her sovereignty in the Rhineland, but promised neither to increase the strength of certain garrisons nor to move troops closer to the French and Belgian borders.

Hitler meeting the British appeal about half-way also appended it with a blunt indication that France and Belgium would have to take similar steps in order not to menace Germany.

Seek Conciliatory Gesture

LONDON, March 12.—Significance was attached by informed quarters tonight to the fact that the Foreign Office communicated to the French, Belgian and Italian representatives here the reply of Germany to Britain's appeal for some conciliatory move on the part of Chancellor Hitler in the Rhineland.

The German answer, submitted by Leopold Von Hoesch, the Reich's ambassador here, made clear Germany would not withdraw any of her troops from the Rhineland, as requested, nor undertake not to fortify that area. But it did not
