Councillor Reardon enquired if the searches referred to in the police report were all searches of different premises, or if they were some of the same premises.

The Chief of Police explained that the latter was the case.

The report was adopted without further discussion.

Councillor Dougan, for the fire committee had nothing to report at the present meeting.

Councillor Holman felt that a meeting of the fire committee should be held in the near future, and a special meeting of the Council held later to deal with any special matters that might come up.

Councillor Kennedy, for the light committee had nothing to report. He felt that everything was running smoothly.

Councillor Holman expressed some doubt that everything was running smoothly. He had heard on the best of authority that the light committee was discriminating between citizens. And he had heard too, that even councillors who voted for the new lighting contract were not satisfied with their bills. If the light company were making special concessions to certain citizens, then things were unsatisfactory, and should be investigated.

Councillor Kennedy however felt that, if one went out looking for trouble he could find it. But, on the whole, he thought the citizens were well satisfied with the new rates and there were very few complaints. He thought that surely the light committee would get some of these complaints, which were all news to him.

Councillor Holman then asked the chairman of the light committee if anything was being done to secure better rates for the tenants and owners of small offices.

Councillor Kennedy replied that he had assurance that, in time proper adjustments would be made.

Councillor Reardon of the health committee had nothing to report.

The following resolutions were then read by the city clerk and duly carried:

That the tender of the Irving Printing Company for printing the city reports, at a cost of \$1.40 per copy, be accepted.

That tenders be called for nine pairs of trousers for the police force.

The usual resolutions in reference to asphalt streets and concrete sidewalks were also read and adopted.

On motion, the meeting was then adjourned.

COLLISION

Last night about 11:30 p. m. a collision occurred between two taxi drivers at the corner of Hillsboro and Water Streets. One of them driving a Dodge sedan was going west on Water St. with three passengers. The other driving a McLaughlin sedan, was coming south on Hillsboro. As a result of the collision, both cars, it is reported, were quite badly damaged. One of the passengers in the Dodge was slightly bruised about the arm, otherwise no one was hurt.

The total cost of the year's work was \$52,522.80. In regard to the culvert on Brighton Avenue, he stated that the street committee decided to get the balance of some \$25.58 to the contractor for the work Mr. Trainor, although he had failed to complete the contract on time the city could have kept the money if they wished.

With reference to the drainage of water from the street in front of Clarke Bros. establishment at the foot of Prince Street, Councillor Foster said the matter would be attended to next spring.

Councillor MacLeod for the tender and public property committee stated that they had tenders from three different parties with reference to hose.

As regards the petition praying for the removal of bill boards at the corner of Euston and Felling Streets he stated that the city could take no action in the matter, if the bill board was on a private property. If it was on public property he thought it would be well for the city to look into the matter, and, if necessary, pass a by-law to take care of the situation.

As to the fire-escapes on the market building, Messrs. Bruce Stewart and Company had been commissioned to install them. They would be stated, he would erect them by the last of the week.

Councillor Prowse with reference to the bill boards, said he had had many complaints from the residents near Euston and Felling about the bill-boards. He did not understand how the city could have control over signs but not over bill boards, as Councillor MacLeod said.

Councillor MacLeod explained that a sign board means a board overhanging the city property. There was a law governing these, and indeed he had been advised by the recorder that perhaps 90 or 95 per cent of the sign boards already erected did not comply with the law. The bill board, on the other hand was on private properties, usually leased for the purpose to a bill board company. There was only one way in which bill board people could be got to do their duty, and that was by adjoining their properties within three hours after snow fell on them.

Councillor Prowse then agreed with Councillor MacLeod that some by-law should be passed to govern the erection of these boards.

Councillor MacLeod then said that he felt a revision of the city's by-laws was necessary. He complained of the non-enforcement of many of these.

His Worship agreed with him in this.

Councillor MacLeod except for some small disagreements with certain of the tenants of the Market Building had nothing to report on behalf of the market committee.

The police report was then read by the City Clerk. It is as follows:

To His Worship the Mayor and City Councillors of the City of Charlottetown.

Your Worship and Gentlemen: The undersigned has the honor to submit the City Police Report for month ended November 30th, 1928.

During November there were forty three arrests made within the City limits for offences stated in the following brief summary:

Operating Motor Vehicle while intoxicated: Arrests: 3; convictions: 3.

Drunk and disorderly: Arrests: 7; convictions: 7.

Drunk and incapable: Arrests: 27; convictions: 26; dismissed or withdrawn: 1.

Keeper of Disorderly House: Arrests: 1; dismissed or withdrawn: 1.

Immature of disorderly house: 1; dismissed or withdrawn: 1.

Shop-breaking and theft: Arrests: 2; convictions: 2 (Suspended sentence).

Theft by conversion: Arrests: 1; convictions: 1.

Vagrancy: Arrests: 1; convictions: 1.

In addition to the above there were two cases of operating motor vehicles while intoxicated, and both were convicted. One offender was sentenced to thirty days and the other to ten days imprisonment without the option of fine. Another offender charged with the theft of a shot gun from a parked motor vehicle was sentenced to thirty days imprisonment without the option of a fine. There was one conviction for reckless driving, one for disorderly conduct, three for breach of sanitary by-law, one for non-payment of tax, one under the Customs Act. Two parties in a case of common assault were both bound over to keep the peace. Two cases of speeding were dismissed.

During November we assisted the Prohibition Officers in twenty-three searches of premises within the city limits suspected of the unlawful sale or possession of intoxicating liquors. Thirteen prosecutions were entered under the Prohibition Act, resulting in ten convictions and three dismissals. Four of the offenders paid the fine of \$200, and costs imposed in such case, and five were committed to the County Jail, the sentences in three cases being six months imprisonment without the option of a fine. Three convicted offenders have absconded.

On November 21st and 28th the force collected a total of forty-five samples of milk from Store-keepers and the samples were delivered to the City Analyst, for test.

Other duties performed by the Force during November are as follows: Prisoners escorted to County Jail 28; Summons served 24; Subpoenas served 13; Dwelling houses quarantined 2; Dwelling houses released from quarantine 1.

The amounts collected in fines during November are as follows:

OTAWA DELEGATION

In addition to the matter of the car ferry, Premier Saunders reports that the recent Ottawa delegation took up with Hon. Mr. Euler, Minister of National Revenues the question of additional protection around our coasts, as a safeguard against smugglers. Mr. Euler assured the delegation that the province would have very reasonable protection; that in the early spring two additional automobiles would be provided for the preventive officers in connection with the land service, and that an additional boat, much superior to anything now in the service, would be used around the coasts of Prince Edward Island and New Brunswick. Owing to the fact that Hon. Mr. Robb, Minister of Finance, was absent from Ottawa, engaged in a bye-election in British Columbia, the Premier and other members of the delegation were unable to take up the subject of additional subsidy for the province. The Premier was told, however, that Mr. Robb would be very glad to discuss with him this very important subject on his return. Other matters of minor importance in connection with provincial affairs were also discussed with some of the heads of the various Departments.

their call for tenders. J. M. Robinson and Sons, Limited were then awarded the tender on resolution as they had submitted the highest bid, viz. \$5.29 and accrued interest for \$20,000.00 worth of 4-1/2 per cent bonds.

Councillor Foster for the Street Committee presented a summary of the year's work on the streets, 32,322 yards of street surface had been gravelled, costing in all \$593,52, or 26.5 cents per sq. yard. To keep these streets in proper condition it would be necessary to increase the street plant. A power leveller and roller, which would cost about \$3500 would suffice to keep them in shape. Of concrete sidewalks, 1716 square feet had been laid down this year at a total cost of \$52,25.

Of asphalt wearing surface, 9,473.3 square yards were laid at a cost of \$3.44 per square yard. Of concrete wearing surface, 3,784 square yards

GYROS

Previous to its organization, there were a few branches in this city of the Navy League of Great Britain in Toronto, Kingston and St. John. This league is itself, not so very old. It came into being in 1895—organized by some of the leading citizens of Great Britain, who went into the great cities and the countryside of the navy, necessity as the result of these efforts, through parliament, and Britain faced successfully the ordeal of the great war.

Canada came into line in 1917. Her Navy League was sponsored by some of the leading citizens of Montreal. The programme of the Navy League of Canada differs somewhat from that of the parent body. The Navy League has been criticized for this departure. It has been told it should interest itself in the navy alone and not the Merchant Service.

Capt. Morris went on to explain the necessity of the programme of aiding the merchant service and seamen generally, in view of the fact that, in this country, no other organization was carrying on this work. Particularly laudable—and necessary—was the work done by the Navy League of Canada on behalf of the widows and dependents of seamen killed by German submarines. It was also a wise decision by which the Navy League undertook to organize Naval Brigades (now Sea Cadets) so that the Canadian Merchant Service, might be named by Canadians.

Another object, of course, was to create an interest in naval and marine affairs.

At present the Navy League has over 10,000 members in the country, and, except in Prince Edward Island, is progressing favorably. The speaker went on to describe the changed attitude of the press—how many newspapers, which had been hostile to the Navy League, were now its most self supporting. It is something, he said, which the Gyros boys might well get behind and help.

He felt it would be a good thing if a committee of Gyros could be appointed to co-operate in the management. The Navy League would soon be very much alive and very prosperous, if it had a live organization like the Gyros behind it.

At the close of the meeting, a hearty vote of thanks to the speaker was moved by Gyro Frank Clark, the President of the Club, and seconded by Gyro Stewart Jones, the Secretary. This was duly received, with an assurance of the club's support.

Mr. Slater, who has had considerable farm and railway experience, and who has worked in Charlottetown as well as in country districts throughout the Province, is well pleased with the Island. He is willing to come here on the representations of Rev. J. A. Winfield, whom he met in the shipping office at Derby, England, and he found conditions here favorable to the right kind of settlers. He has since visited Western Canada, but returned to the Island again, convinced that on the whole this Province offers as good opportunities as any part of the country. He is now returning to England, but hopes to visit this Province again.

Mr. Slater, who is a member of St. Paul's choir and of the Masonic Lodge in this city, has made many friends here. He is carrying back to England very pleasant recollections of his stay, and will be in a position to advise prospective settlers from his part of the country as to the advantages for farm settlers which Prince Edward Island has to offer. "Only let them know, when they arrive here, just what the conditions are, how they can best provide for themselves," he urged. "You need a bureau of information in the worst way."
