

Will Be Guests Of Lady Senator

(Canadian Press) BATHURST, N. B., July 12.—Rt. Hon. W. L. Mackenzie King, former Prime Minister of Canada, and Rt. Hon. Ernest Lapointe, who are motoring through New Brunswick en route to St. Andrews, where they will be the guests of Hon. Cairine Wilson, member of the Canadian Senate for some days, reached Bathurst last night at 9.15. A number of friends in this vicinity including Hon. P. J. Veniot, former Postmaster-General, met them and a conference was held last night, and this morning they continued their run intending to reach Fredericton this afternoon and to reach St. Andrews this evening.

Continued from page 1 with the present position because the British government has never unequivocally declared it would not take hostile action if the people of the Free State decided to sever their connection.

"Let's get that declaration from the British government and we will take up the challenge. Britain has no right to take hostile action, because we are exercising our natural right."

Fitzgerald Kenny, who was Minister of Justice in the former Cosgrave government, declared, "Canada cannot remove the oath from its constitution, and why should we?"

Mr. De Valera retorted, "Canada cannot break its oath because it does not want to. We can, because we want to."

Mr. Kenny replied, "Canada wants to keep her word—and we don't."

The galleries joined volubly in the turmoil at another point in the debate when President Eamon De Valera charged the opposition with dishonesty.

Desmond Fitzgerald, former Minister of Defence, leaped to a heated point of order and shouted, "The President has accused us of dishonesty. I accuse him of being a liar."

The speaker quieted the situation by explaining that President De Valera did not mean personal dishonesty and both sides withdrew the offending remarks.

President De Valera declared he opposed all the Senate's amendments to the oath bill. The bill rejected the amendment which threw out section two of the bill, this being the section that provided for deletion of the part of the Free State constitution act which gives the Anglo-Irish Treaty the force of law.

The bill will send the oath bill, after rejecting the Senate's other amendments, back to the Upper House. The Upper House has an opposition majority and is highly unlikely to accept the bill, put back into its original form. In this case the measure may be suspended for 18 months, after which time it can become law despite anything the Senate may do, or a general election may intervene.

President Eamon De Valera declared the Free State government was anxious to arbitrate the dispute over the land annuities, the half-yearly payment of which was defaulted on June 30. He said he would be glad to hand over the dispute to a board of arbitration as quickly as possible—if the two governments could reach an agreement about the constitution of the arbitral tribunal.

As the President however failed to announce the Free State would agree to a tribunal composed of persons selected from within the British commonwealth, which principle is insisted upon by the British government, the declaration did not alter the state of affairs.

So the troubled Irish scene is no calmer. There was no sign of any approach towards settlement of the dispute between the Governor-General, James McNeill, and the government, which is accused by His Excellency of studied discourtesies towards him. At the same time, word comes from Britain that the British government is implementing its threat to recoup the defaulted land annuities by fresh duties on Free State goods, effective Friday.

Empire trade and tariff comes first. There are other matters to be discussed but this is what is crucial. The problem is to organize the resources of the Empire for the benefit of the inhabitants of the Empire and there is no other way this can be done but by tariffs."

LONDON, July 12.—Hope that nothing would be said at the Imperial Economic Conference at Ottawa to prejudice the prospective world economic conference was expressed in the House of Commons tonight by George Lansbury, Parliamentary Labor Leader, during debate on Lausanne and Geneva.

Mr. Lansbury expressed wholehearted support of the "magnificent work" of the government for the nation and the world in pushing forward to agreement on reparations at Lausanne. "Unless we get real co-operation in Europe and the world, as well as in the commonwealth," he added, "I do not see much chance of recovery."

David Lloyd George said he did not anticipate any great results from the Ottawa conference. He would be very relieved, indeed, to see the delegates come home "without having committed Britain to anything that would deprive us of the initiative in dealing with world trade," the foreign minister said.

Strange Actions Of Demented Man

(Canadian Press) NORTH BAY, Ont., July 12.—The man, supposed to be of unsound mind, who was arrested at Eau Claire, Calvin township, yesterday after terrorizing the natives by running through the woods nude but for a pair of trunks and emitting blood-curdling yells, has given his name as Chisholm and his home in New Brunswick. He is lodged in the district jail for examination.

After terrorizing residents of Eau Claire, in Calvin township, the man was taken into custody. He carried a long stick with a piece of logging chain on the end, with which he said he was going to fight elephants and tigers.

According to information received by the police, the man arrived in the district Saturday. Divesting himself of his clothing and donning a scant pair of trunks, he proceeded to re-enact prehistoric life. Bits of clothing stuck on trees were intended, he said, to advise his phantom followers of his course through the woods.

Sunday evening, he requested food from a farmhouse. He was quite docile when police arrived, and greeted officers with: "I expected you would be looking for me. I might have sent you word earlier." He accompanied them peacefully after being re-clothed.

No Change In Beer Percentage

WASHINGTON, July 12.—The first prohibition test in the United States Congress since the party conventions today showed little change from past overwhelmingly dry sentiment.

The Senate turned down a bill to legalize beer of higher alcoholic content by a vote of 50 to 35, stopping the beer movement for this session.

The vote sent the Bingham Bill to modify the Volstead Act back to committee.

Three senators who previously had opposed the change voted this time with the advocates.

The Bingham Bill was designed to write 3.45 percent into the Volstead Act in place of the present one-half of one percent limitation of alcoholic content in beverages.

The vote was on a motion by Senator Robinson, of Arkansas, Democratic leader, to refer it to the judicial committee for a determination of the question of what constitutes an intoxicating beverage.

CURRENT SWEEPS FISH INTO POND

ST. JOHN'S Nfld., July 12.—(By The Canadian Press)—For years Peter Cowan has been trying to prove to doubting Thomases his theory that a swift current sweeps fish through a narrow channel into Holyrood Pond, a salt water lagoon for which he claims his theory has been demonstrated by the movement of a scaled bottle which has travelled 100 miles in 15 days.

Having invited a friend to view the place, Mr. Cowan was at Holyrood Pond on June 14, when one of the bottles was found. It was the first morning after their arrival, and they were watching fishermen at work when Mr. Cowan saw a bottle floating in one corner of the "pond". It had been caught in a cod trap. On opening it he found records of the biological station and he held it out to his friend as practical proof of the current drift and another link in his theory. Examination showed that the bottle had been dropped overboard three miles east of Bay Bulls by members of the biological station staff, on May 30. That gave it 15 days to travel 100 miles into the pond.

ORANGE TEA WAS VERY SUCCESSFUL

The annual Orange Tea, held yesterday at Bradalbans was very successful, and was very largely attended. A number of addresses were delivered, and a large parade held at 2.30 p. m. 500 Orangemen and about 100 ladies took part in the latter feature. The usual sporting events were keenly contested, and the tables and booths well patronized.

Presiding at the formal part of the afternoon's proceedings, was the Grand Master, Mr. W. W. Muttart, Summerside. The address of welcome was given by Rev. Mr. Palethorpe, and was responded to by Mr. P. M. MacCaull, Grand Secretary. The speakers were Rev. W. S. Loring, Rev. M. O. Brinton, Rev. G. T. Spriggs, and Mr. W. W. McPhee, Toronto. On the platform in addition were Rt. Grand Mistress McLean, Rt. Grand Treasurer, Mrs. Grace Sharpe, and Dep. Grand Master Moore.

The tea was put on under the immediate direction of the local lodge at Bradalbans. The pipe band provided music during the afternoon.

U. S. Authorities May Take Action

SARNIA, Ont., July 12.—(By the Canadian Press)—No definite action has yet been taken to interfere with Canadian-born employees of the Canadian National Railway operating into the United States from this terminal, but the matter was considered at a recent conference of U. S. authorities, it was learned today. The matter was brought to the attention of the City Council and this body decided to refer the subject to the federal immigration authorities.

M. A. Boykenthal, Chief U. S. Immigration Officer at Port Huron, was reported here as authority for the statement that the matter had been considered but that no definite action had been taken. He was said to have declared that on July 6 a meeting was held at Port Huron and was attended by C. N. R. officials from Toronto, representatives of the Grand Trunk Railway offices at Chicago and the district immigration inspector. The meeting was called for the consideration of dining car crews, composed of Canadians who were operating on passenger trains between Toronto and Chicago. It was pointed out by the U. S. authorities that there were 40 Canadian employees of the C. N. R. who were running into Chicago. It was also pointed out that with the discontinuance of the New Yorker, fast east and west bound flier, no American dining car crews were operating in Canada. The C. N. R. was said to have laid off its American employees and maintained Canadianians and it was this action that was being questioned. It was also mentioned that the United States crews travelled about 180 miles in Canada while the Canadian employees covered about 334 miles in the U. S. Nothing was accomplished at the conference according to the reports, officials decided to meet again at Detroit on July 15.

Australia's delegation, headed by Stanley Melbourne Bruce, Assistant Treasurer, and H. S. Gullett, Minister of Trade and Customs, includes Dr. A. E. V. Richardson, Director of the Waite Agricultural Institute; E. Abbott, Deputy Comptroller-General of Customs; J. F. Murphy, Chief Investigation Officer of the Development Branch; A. C. Moore, of the Trade and Customs Department; L. E. Stevens and C. B. Carter, of the Department of Commerce and Mrs. F. M. Grant, Private Secretary to Mr. Gullett.

In addition are the following representatives of industry and commerce acting as advisors: R. W. Knox, Melbourne Chamber of Commerce; H. W. Osborne, Western District Co-operative Insurance Company; F. Toot, of the Graziers' Association and M. B. Duffy, of the Commonwealth Bank Board.

Miners Agree To Reduction

(Canadian Press Cable) WELLINGTON, New Zealand, July 12.—The Northern Coal Miners' Unions of New Zealand voted by a four to one majority to resume work tomorrow on the basis of the agreement reached at a round-table conference with the government and the coal mine operators, by which proposed wage reductions will be considerably moderated.

Big Decrease In Grain Exports

(Canadian Press) OTTAWA, July 12.—Exports of Canadian wheat during the eleven-month period ended June 30 last totalled 163,183,158 bushels valued at \$98,335,625. Of these total shipments, 89,705,365 bushels went to the United Kingdom, 4,473,293 went to the United States, and 69,004,502 to other countries.

These figures compiled by the Dominion Bureau of Statistics indicate an appreciable falling off from the corresponding eleven-month period a year ago. During that period, total exports were 216,475,588 bushels valued at \$153,580,657. Total shipments to the United Kingdom during that time were 127,187,880 bushels, to the United States, 8,930,525 bushels, and to other countries, 80,857,183 bushels.

Exports of wheat flour during the eleven-month period just concluded totalled 4,937,215 barrels, valued at \$17,122,545, as compared with 6,234,686 barrels with a value of \$25,952,977 in the eleven months ended June 30, 1931.

Of barley, Canada exported 11,849,725 bushels in the eleven months ended June 30 last, as against 16,594,482 in the corresponding period a year ago. Total exports of oats in the period just ended were 13,097,727 bushels, or nearly double the same eleven months a year ago when they amounted to 6,564,774 bushels.

Unsanitary Housing Report

The following report on unsanitary housing conditions was submitted at Monday's meeting of the City Council by Coun. Day, chairman of a special committee appointed to investigate the conditions as reported on previously by the health and sanitary officers. The specific addresses, together with the names of the owners of the properties, which appear in the report are omitted here.

"To His Worship the Mayor and members of the City Council: "With Councillors Holman and Hennessey and Provincial Health Officer Keeping and Sanitary Officer Bradley, I visited a number of homes in the city on the above date and would make the following report:

(a) A two tenement dwelling at the rear of Richmond Street, occupied by two families, is absolutely unfit for habitation and would strongly recommend condemning this house and closing it up.

(b) A six tenement house on Rochford Street. This property is also in a deplorable condition and unfit for habitation. We would strongly recommend that this tenement house be condemned and closed up.

(c) Four tenement houses on Dorchester Street, also another two tenement house in rear belonging to same owner. These six tenants have no water, otherwise in fair condition. Recommend the Water Commissioner be notified and take the matter up with the owner of the properties.

(d) House on Cumberland St., occupied by man, wife and four children. No water, no toilet, no sewer connection. Deplorable condition. We strongly recommend closing this place up as unfit for habitation.

(e) Garbage is being dumped along the approach to Hillsboro Bridge at the east end of Grafton Street on property belonging to the Federal Department. Would recommend that this practice be stopped and that offenders be dealt with accordingly.

would cut or cancel war debts. The "gentlemen's agreement" assumed such a prominent part in the debate that finally steps were taken to make it available to everyone. The Prime Minister intervened in the debate late tonight to announce the government had no objection to publishing all the Lausanne documents, including this agreement.

A little later, Sir John Simon, Foreign Secretary, announced that telegrams had been sent to the other powers at the Lausanne conference asking if they had any objection to the publication of supplementary agreements.

Reporting to the House the Prime Minister stressed his belief that the United States was willing to cooperate in combating the world crisis. Nobody, he said, could blame the United States for its war debts policy.

Mr. MacDonald hit out hard at Winston Churchill, former Chancellor of the Exchequer, who yesterday said Europe had endangered her case for war debts revision by signing the "gentlemen's agreement." The Lausanne agreement, Mr. MacDonald said, could lead to solution of all the economic problems which have afflicted the world since the war.

As for the "gentlemen's agreement," Mr. MacDonald pointed out it was only semi-secret in character. The fact it had been arranged was announced at the final plenary sessions of the Lausanne conference with the press of the world in attendance.

"Mr. Churchill's innocence always surprises me," Mr. MacDonald added, while Mr. Churchill stared blankly in front of him. "He goes through life either as a rhapsodic individual who knows everything, or as a sucking dove, but whether roaring or cooing his innocence always strikes me."

Mr. MacDonald turned directly to Mr. Churchill as he said, "I hope especially that those who have voices which carry across the Atlantic will not use those voices to make it more difficult for America to understand the European situation."

David Lloyd George made one of his infrequent appearances in the house to hear the MacDonald speech. The veteran Liberal leader insisted the public should be fully informed of what took place at Lausanne. He wanted to know whether the "gentlemen's agreement" was a clear-cut link between the reparations settlement and adjustment of the American debts.

Neville Chamberlain, Chancellor of the Exchequer, took up the cudgels. He re-stated the British policy concisely, thus: "If all-around cancellation can be achieved, we shall cancel. If cancellation is not possible we must wait to see what America may propose to us before we can cancel the debts of our European allies."

This seemed to leave the situation so far as Great Britain is concerned just where it was placed 10 years ago by the famous Balfour note which formulated the policy of basing the receipts from Britain's own debtors at a figure just sufficient to balance her outgo in payments to the United States.

A government spokesman explained that in saying yesterday the "gentlemen's agreement" had been reached after consultation with representatives of the United States, Mr. Chamberlain was talking in the heat of debate. His assertion was taken as indicating more than he intended, the spokesman added.

According to the authorized version, members of the British Lausanne delegation discussed world problems with United States representatives at the Geneva disarmament conference solely as a matter of social intercourse during strolls about the hills and along the beaches of the Lake of Geneva.

VICTORY FOR HERRIOT

PARIS, July 12.—(A.P.)—Premier Edouard Herriot, home from the reparations negotiations at Lausanne, rode out a series of storms in the Chamber of Deputies today and emerged with an overwhelming vote of approval for the government finance bill, which is aimed at balancing the budget.

The Premier inferentially raised the question of Adolf Hitler's storm troops at one point in the struggle.

World Fliers Tell Story Of Landing

(By Stanley P. Richardson, Associated Press Staff Correspondent) MOSCOW, July 12.—(A.P.)—Dirty, weary and disappointed James Mattern and Bennett Griffin stepped off a train here today shooed hands with a few fellow countrymen and streaked for bath tub.

A little later, with most of the grime scrubbed off, they told the wreck of their round-the-world flight ambition in a Russian parlor, and of their determination to try it again, if not this summer, certainly next year.

"We got a tough break, that's all," they said. "We're going home as soon as we can, but we'll tackle again this year if it's not too late, certainly next summer if we can get a plane."

It developed that Mattern was piloting when the "Century of Progress," booming over western Russia between Berlin and Moscow, began misbehaving. Something went wrong with the steering gear, but it was not serious.

"So, I looked around," said Mattern, "and I hollered back to Griffin that we were coming down. I knew we could fix things in a couple of minutes, and there was a good spot to land right underneath us."

"I thought it was a good spot, but you can't always tell when it's dark. It turned out to be that peat bog, and if it hadn't been for that, some ground we'd be a long way from here now."

But when they landed the wheel dug into the muck and the "Century of Progress" nosed over with her wheels in the air.

"As soon as she began to sink into the swamp I knew I'd guessed wrong," said Mattern. "I gave her the gun but it was too late. Next thing we knew we'd nosed over, and there I was, pinned in with the motor jammed up two inches from my knees."

"We were both kind of dazed, but Griffin yanked me out and crawled on one of the wings to pull cover from the shock. It seemed like we lay there a couple of hours, but it was really only a few minutes before help came."

"It was a blasted shame the show had to go like that. She was one swell piece of machinery."

The Socialists wanted to kill \$4,800,000 item to pay for the training period of military reservists. Herriot, making the issue a question of confidence, declared: "While we would be hesitating to train reservists, elsewhere there are masses whose numbers cannot exactly be told but whose political power is evident since they impose their will."

His hearers took this as a reference to the Hitlerite army in Germany, and the Socialist amendment was defeated 360 to 179.

"I have encountered immense obstacles during the last few weeks," the Premier said during the debate on the finance measure. "The interests of France have been safeguarded. The fate of my government is of no importance to me."

"We have saved France at Lausanne, and we await your judgment with serenity."

Reports that the parties of the right would fail to uphold the government caused some nervousness, but the vote showed there was no truth in them.

U. S. NOT CONSULTED

WASHINGTON, July 12.—A new outbreak of debate over whether the United States was consulted in the making of the Lausanne reparations agreement, brought the oft-repeated denial of state department officials today forcibly before the Senate.

Senator W. E. Borah, chairman of the Foreign Relations Committee, presented the denial for Henry H. Stimson, Secretary of State. He said he had talked with Mr. Stimson only this morning and that the latter had authorized him to report the substance of their conversation. In an emphatic tone, he added: "The Secretary stated to me explicitly that there had never been any conversation on the part of this government, with the representatives of foreign governments touching the settlement at Lausanne, that we were not consulted and that no way advised with reference to what is called the gentlemen's agreement; that the position of the government had been, throughout the negotiations which had been going on between the government in Europe, that our government regarded the debts and the question of reparations as separate propositions, that we neither by communication nor through representatives which are now in Europe representing this government had anything to do with ever to say or do with reference to the reparations settlement, and no wise is this government bound by any supposed gentlemen's agreement, either expressly or impliedly."
