S' side Man Home After Ordeal In Jap Prisons

Home again after nearly four years in the hands of the Japanese, L. Cpl. Medley Blackmore, accompanied by his wife, a nursing sister in the Canadian Army, arrived in Summerside last night.

Looking well and fit from the good food and treatment he received since his liberation, he carries memories of four years of harsh treatment at the hands of the Japs.

A son of Mr. Archie Blackmore, Notre Dame Street, L. Cpl. Blackmore joined the Army early in 1940 and served in the Royal Canadian Rifles with whom he served eight months in Newfoundland before proceeding to Hong Kong in the fall of 1941.

Nine hundred and sixty-three strong, the Regiment was able to muster only 250 men on Christmas Day when the Island fell. Some of those missing however had made their way to the interior. The rest were either killed or wounded.

After the capture of the City he was kept there till September, 1942, when he was transferred to Nilgiri in Japan, about 200 miles from Tokyo. Here the prisoners were forced to work in the coal yards at the docks until August 15 of this year when work was stopped and they knew there was something up.

They were then taken to a camp and dropped supplies and on August 20 the prisoners pushed out of the camp unmolested by the guards.

They traded parachutes and supplies for food and made their way to Tokyo from where he was flown directly to San Francisco. They were 42 hours in the air. A trip that had taken 21 days by boat on the way over.

Members of apple-growing and marketing cooperatives of the Annapolis Valley are making inquiries as to the possibility of a write-off on the Canada Foods Limited plant at Kentville, N. S., used during the war years for dehydration of potatoes and other vegetables and fruits.

Officers of the cooperatives allege that the finance and supply departments of the Dominion Government have given exceptionally favorable treatment to the owners of the Kentville plant and have aided them greatly in the construction of alterations and improvements on the plant.

This favorable treatment, they claim, is working to the detriment of smaller apple processors and other cooperatives which can get no government help for similar projects of their own.

If unable to secure official figures on the write-offs and depreciation allowed on the Nova Scotia dehydration plant from departmental sources, they will proceed inquiries before the public accounts committee of the House of Commons later in the session.
