Russia and Germany Demand Plenary Session

To Discuss Russo-German Treaty and German Case. French Communique Declares Demand Will Prove Mortal Blow to Conference.

(Special to The Guardian) GENOVA, April 19.—The Russian delegation to the Genoa conference announced today it will ask that the Russo-German treaty be discussed at plenary session and put to a vote. This was the Soviet answer to the Allied protest against the commercial agreement privately signed last Saturday by German and Russian foreign ministers.

At the conclusion of Mr. J. D. Stewart's address in reply to the budget speech of Premier Bell, Mr. A. C. Saunders spoke in support of the work of the government. He paid tribute to his opening remarks to the memories of the late Hon. Mr. Gallant and the late Hon. Mr. McLean.

The speaker supported the road policy of the government and declared that criticism on this work could not fairly be made. Daniel McDonald, Late of Tracadie Found Buried in Gravel Pit. Lawyer is Sought as Important Witness. No Clue Yet as to Murderer.

Nossoux, aged 37, and Silvio Gull-bault, 35, both of Joliette, Que., the former a conductor of the Canadian National Railway and the latter a fireman were killed this morning near Lachepreviere station on the Montreal-Quebec line when the locomotive on which they were riding fell over the embankment on a sharp curve. J. L. Lachepreviere, the engineer, had time to jump and only received scalds on both legs that are not considered dangerous.

BRAVE MOTHER DIES AT TRURO

TRURO, N. S., April 19.—Death relieved from her sufferings last night Mrs. Thomas Harrington, who yesterday struggled in vain to rescue her two children from an explosion of a acetone lamp. Mr. Harrington, the bereaved husband and father, who also was badly burned and had his both legs broken when he jumped from the upstairs window is expected to recover.

These children were burned to death in a fire which destroyed the Harrington home at the corner of Prince and Dominion streets. The fire resulted from a gasoline explosion when her husband, who is a painter, was lighting an acetone lamp. He jumped from a window, breaking his legs. Mrs. Harrington was taken to the hospital, fatally burned, while attempting to get her children to safety. Shortly after admission she gave birth to a child.

The dead children are: Thomas, 12; Kathleen, 8 and Edith, 2. Kathleen was found sitting on the floor behind a bed in the ruined house with her doll in her arms; Edith was in a sitting position in bed, and Thomas was huddled in a corner behind a door. The building damage is estimated at \$15,000. The loss to the Farmers' Store, managed by J. E. Davison, on the lower floor, is estimated at \$25,000. Other business occupants and losers are: G. C. ISLANDER IS MURDERED IN SEATTLE, WASH.

Daniel McDonald, Late of Tracadie Found Buried in Gravel Pit. Lawyer is Sought as Important Witness. No Clue Yet as to Murderer.

LYNN, April 4.—Discovery of a body of a slain man buried in a shallow grave near Ronald Station, Seattle, Wash., who was identified as Daniel McDonald, has caused considerable concern here.

According to reports received by John J. MacDonald, brother of the slain man, a gang in Seattle had quarrelled with his brother and because of fear of exposure of some of their plans, murdered him in Seattle and then conveyed the body to Ronald Station, where they dug a shallow grave and buried the body.

Letters received by the Lynn man indicated that a quarrel had taken place with a so-called gang in Seattle and the murdered man had often referred to this gang as murderers.

Motive for the murder which, according to the coroner, occurred Wednesday, March 15, some time near midnight, has baffled police authorities of Seattle. One clue followed by police inspectors led to the discovery that a man named Graves, who lives at Ronald, said that he had seen three men standing about a bonfire in a gravel pit where the body was buried, on or about March 15.

A man in cotton gloves which would not fit the dead man were found near the grave, but the weapon used in the tragedy has not been found. It is probable, according to the Seattle police, that a hand ax or a wrench was used to kill McDonald.

Left Insurance Policy. A life insurance policy, made out to his estate, was found in the dead man's trunk in a room at the Rex Hotel at 27 King St. J. J. MacDonald, when interviewed today by a Globe reporter, said: "I will do everything possible to run down the murderers of my brother, to avenge his death and bring to the bar of justice the men responsible for the cold and heartless crime. My brother was a conservative type of man and the only motive for the murder must have been robbery or perhaps the assassins might have feared the strong arm of justice, knowing that my brother knew some of their treacherous deeds."

The victim owned property valued at \$12,000, which he sold a few days before the crime. He was known to have had this sum in his possession. H. H. Guth, a Seattle attorney, with whom the dead man had been associated, explained to the police that he had owed McDonald \$500, which he borrowed to start a chicken ranch. Guth claimed that he had repaid McDonald. The police claim that Guth was to have met McDonald the day after the murder to settle this debt. A note signed "Guth" was found in the dead man's pocket, but it was so poorly written that the contents could not be deciphered.

Lived in Far West, 16 Years. Daniel A. MacDonald, aged 40, was born in Tracadie, Prince Edward Island, the son of Mr. and Mrs. Augustine B. MacDonald. He was educated in the Prince Edward Island High Schools and later attended a Western university. He has resided on the Western coast for the past 16 years. He was engaged in business for himself as an architectural draftsman and accumulated a sum of money with which he bought real estate.

The body was positively identified by Mrs. Anna MacDonald, sister-in-law. A cousin, Peter A. MacDonald, of Seattle, Washington, is in charge of the investigation. A Seattle paper bearing on the murder, says:— Indicated in notes found in the luggage of Daniel Alexander MacDonald, found murdered near Ronald Station yesterday as being one of the last men who had dealings with the murder victim, H. A note, believed to have been signed by Guth's reading, "Please come over to the Court House, Department No. 1, third floor," was found among effects of the dead man stored with the People's Transfer Company.
