It is estimated that the number of children among the children, in almost every one of the tents, there is sickness of some kind, owing to the lack of proper accommodation during the wet weather. Last week the Building Committee was arranging to provide homes for the new arrivals as the cash contributions would allow. Investigation shows that about six hundred destitute people will have to be assisted in the building of houses and supplying of food for the winter. Even if only \$100 is spent on each of these families from now until next spring it would necessitate a sum of \$60,000 and as yet only \$45,000 has been contributed up to last Saturday when several large subscriptions were received. In order to provide the bare necessities of life to the population, at least \$100,000 will be needed.

Sergeant Harold Wheeler, of the local militia was accidentally wounded yesterday by a comrade handling an automatic revolver. The bullet lodged in his abdomen necessitating Wheeler's removal to the temporary hospital.
