Former Ch'town Railway Official Dies At Moncton

MONCTON, N.B., Aug. 22 - A well-known figure in railway circles in the Maritimes, J.H. Corcoran, retired district passenger agent of the Canadian National Railway, was suddenly stricken last night and passed away a short time later.

The late Mr. Corcoran was born in Charlottetown, P.E.I. on September 18, 1872, and commenced his railway career as a clerk in the mechanical department of the railway at Moncton in October, 1890.

Two years later, he was transferred to the general passenger agents office in that city and continued in that department until July, 1911, when he joined the service of the Grand Trunk Railway as travelling passenger agent at Moncton and in April, 1918, was named general agent upon the incorporation of the Grand Trunk into the Canadian National system, he was made general travelling agent in that department at Moncton in December, 1921.

Upon the appointment of steamship agent with headquarters at Halifax throughout the winter season and at Quebec during the summer. He was appointed district passenger agent at Moncton in August, 1930 and retired in Sep., 1938. During the First World War, he was stationed at Halifax where he was engaged in the movement of troops overseas and later in their repatriation home. In the Second World War, although still retired, he acted as railway traffic representative on troop and hospital trains.

Surviving are his widow and two sons, three grand children, two daughters and three nephews of whom James and Frank reside in the Maritimes.

Funeral services will be held at 10 o'clock Saturday morning from St. Bernard's Church.

Slavs Do Not Fear To Have Dispute Brought Before U. N. Council

PARIS, Aug. 22 - (CP) - An official spokesman for the Yugoslav delegation to the European peace conference said today his country does not fear to have its dispute with the United States over the shooting down of American planes brought before the Security Council of the United Nations.

Reuters News Agency said the spokesman, a high official in the delegation, asserted that the incident was provoked by the United States which he termed an attempt to influence the course of the peace conference in favor of the same subject.

Reuters said the official, known to be in close touch with Edward Kardelj, Yugoslavian vice-premier, emphasized that his remarks, expressed in an interview, represented only his own opinions. They were not the official views of the Yugoslav Government.

Two United States army transport planes were forced down by gunfire from the Yugoslav air force, one last Aug. 9 and the second Monday, prompting a heated diplomatic row. The Yugoslav government said the latter country last night sent a telegram to the United States, demanding the release of the crews of the planes, which were shot down Aug. 9.

Of the Aug. 9 incident, the Yugoslav spokesman said it was shot down near Ljubljana over Yugoslav territory while a popular demonstration in favor of

interned after the downing of one plane near Ljubljana Aug. 9 and another shot down in flames last Monday near Bled.

There were indications, however, that none of the five Americans aboard the second transport may have survived the Monday crash. There was no official word of their fate.

Mr. Patterson began his conference with Tito about 2:30 p.m. The liberated crew members and passengers arrived in Trieste tonight. They were transported by motor and not by plane.

The released men were described as being in perfect physical condition. They were held in a hotel at Ljubljana just under two weeks.

The crew members, with the exception of the pilot, said after their release that the airplane was not fired upon after it was on the ground. Their statement was corroborated by the passengers.

There still was no word concerning the original Yugoslav protest note about American planes flying over Yugoslav territory and the text of the recent speech in which he said Yugoslavia wanted peace but "not at any price."

Yugoslav control of disputed Trieste was in progress. "This does not look like a coincidence," he said. "We shall stand by our rights under international law before the council or anywhere else."

Shoving the immediate problems of the peace conference into the background, State Secretary Byrnes the United States held a series of conferences, meanwhile with his advisers on the Yugoslav situation. Russia's foreign minister, V. M. Molotov, had a talk with Kardelj, perhaps on the same subject.

Informed quarters said Mr. Byrnes was greatly concerned over the circumstances surrounding the holding of the airman following the Aug. 9 incident, and the possible killing of five others when another aircraft was shot down last Monday.

The American State Secretary has conferred with Mr. Kardelj and with Maj.-Gen. H. R. Bull, chief of the United States army of occupation in Europe. He also has held protracted long distance telephone conversations with President Truman about the recent Yugoslav ultimatum.

The note released Wednesday night demanded only the release of the occupants of these planes now in your custody.

Officials said privately this will pose two problems. 1. Redress for the lives of American Army crew members killed in the crash of the plane on Aug. 19 and compensation for property damage involved in the downing of both the Aug. 9 and Aug. 19 planes.

The working out of some arrangement which would prevent such a crisis may be avoided in the future.

In this connection, American officials have given some thought to the possibility of using American fighter planes to protect un-armed transports whose routes might bring them close to the Yugoslav borders with Austria and Italy.

Informants said that any use of fighters would be limited to non-Yugoslav territory against the possibility that Yugoslav fighter planes might stray over the boundaries of their country and into areas where they have no legal right to be.

WASHINGTON, Aug. 22 - American officials tonight weighed a demand for full redress from Yugoslavia for the casualties and property damage suffered in attacks on two United States Army transport planes.

It all the occupants of a second plane, fired upon Aug. 19, have been killed, as indicated in the Belgrade dispatches - the release of the nine occupants of the first plane would represent full compliance with the ultimatum.

Today's violence led to the arrest of at least one man whom police said would be charged with assaulting a constable. At least four men were questioned at some length. Two of them were released.

Nine men arrested yesterday during picket-line clashes were remanded until tomorrow. They face charges of obstruction, intimidation and willful damage. The trucks which tried to enter the plant today were preceded in each case by police but the strikers turned back each vehicle. Police advised a fourth driver to turn back of his own accord. Earlier the pickets gave free passage to an automobile carrying workers out of the plant and a car was allowed to enter.

Truman Will Spend Vacation In Bermuda

HAMILTON, Bermuda, Aug. 22 - (CP) - President Truman arrived in this sequestered island today, day, liked what he saw and decided to spend the remainder of his vacation here.

This is what he has been looking for," his press secretary, Charles G. Ross, told reporters who followed the President here aboard the navy ship Welles.

The president's yacht, the Williamsburg, anchored this morning in the American naval operating base at the south end of Little Sound, about 30 minutes by small boat from Hamilton. Here, Mr. Ross said, the President will spend the "several" days swimming, walking and sunbathing.

Mr. Ross scoffed at questions as to whether the President might meet high American or foreign officials here, as suggested in London dispatches.

"There is no political significance whatsoever to the President's being in Bermuda," Mr. Ross said. "This is a vacation, pure and simple."
