In the afternoon a splendid address on mission work in India was given by Mrs. A. R. Gibson who spent some years in the work there. She spoke of the importance of the work done by the little Indian girls who attended the mission school. They learned, along with their general education, memory verses of Scripture, Christian hymns and the story of Christ, these they brought to their homes. She spoke of the devotion of the Indian women who accepted Christianity and of their eagerness to give it to their friends. She told also of the terrific need of the millions of blind and lepers and the thousands of tubercular people in India. She stated that there was only one doctor to 450,000 people; adding that if Prince Edward Island were put on the same basis there would be one-fifth of one doctor or one doctor for ten weeks in the year.

The address in the evening was given by Rev. G. C. Webster of Zion Church. He spoke of the command of Christ to His disciples to go into all the world and preach the Gospel beginning at home—Jerusalem. This command of Christ's, he said, was laid on Christ's disciples of today just as much as on those in the early days. He urged that those who have the Gospel today share it with those who have it not. The musical numbers rendered at the afternoon and evening services were especially good. Mr. Hibbert objected, maintaining that the brakeman's story of having placed torpedoes had not been altogether disproven. There was no rule, he said, governing the length of time a stalled train must be flagged. The weather was below zero and the brakeman could not be expected to stay outside indefinitely.

Mr. Mitchell, representing the Railway Engineers, presented a brief stressing the difficulty of seeing objects in front when a snow-pow was coupled ahead of the engine.
