Mr. Langlois declares that the archbishop has descended from his high office to become an electoral agent for the nationalist party, and had taken as a stand that the liberal press did not dare protest against his maneuvers.

TWELVE INJURED IN WRECK

SARATOGA, N. Y., Dec. 17.—Nearly a dozen passengers were injured on the Hudson Valley Railroad north of Schuylerville early when two freight cars broke from an electric engine and crashed into a passenger trolley which was followed closely. The motor man was unable to stop the train and the passengers and none escaped injury, although there were no fatalities. The wreck caught fire from a coal stove in one of the freight cars and the three cars were destroyed.

FACTORY FIRES FATAL IN N. YORK

Special to The Guardian. NEW YORK, Dec. 20.—Two fires in the upper part of New York City resulted today in the death of one man, serious injury to a fireman and property damage estimated at \$350,000.

The fiercest fire was in a six story factory building, East 124 St., occupied by Xenas & Co, brass manufacturers. Eight months ago a fire swept throughout its interior, leaving little but the heavy walls.

The second fire was in a five story factory building, Morningside Avenue. The chief danger was that the fire might communicate with the adjacent dying and cleansing establishment, where several hundred gallons of gasoline were stored.
