

# WITHDRAWAL OF ITALIANS UP TO FRANCO

ROME, Feb. 16.—(AP)—Italy's blackshirts fighting with the Spanish Insurgents in Spain, Information Diplomatica announced today, until General Franco "makes known that their task is finished."

The Foreign Office service also asserted that British and French moves for winning favor with the Insurgents failed to "take into account the strong Italian ties in Franco as a result of Italy's aid in men and war material in the civil war."

Diplomatic circles attributed the statement in part to Italian irritation over French press statements that Spaniards soon would come to realize that their best friends were the French.

## Resent "Interference"

"The noisy vociferation which rings in the breasts of the so-called democracies on the problem of recognizing the Government of Burgos (Insurgents)," the statement said, "is followed with absolute tranquility in responsible Roman circles."

Both British and French had been disturbed by the suggestion of Virginia Canada, authoritative English editor, on Feb. 5 that the Italians would remain in Spain until Franco had won "complete political victory" as well as military victory. The Earl of Perth, the British Ambassador at Rome, made inquiries and received a reply from Foreign Minister Galeazzo Ciano that Ciano's assertion did not represent the Fascist Government's policy.

Information Diplomatica's announcement today therefore was expected to give them fresh concern lest ultimate withdrawal of the Italians be made a bargaining point in settlement of Fascist claims on France for colonial expansion.

# ENJOYABLE CONCERT BY MISS BRANCATO

The second of this season's Community Concerts in Prince of Wales College Auditorium presented Rosemarie Brancato, coloratura soprano, assisted by Harold Dart as accompanist.

Miss Brancato, who has sung with the Chicago City Opera on many occasions, possesses a voice of rare quality. Her tone is of a flute timbre and her range in the

upper register of the voice phenomenal. Technically there did not seem to be any vocal feat of which she was incapable.

Most pleasing to the audience was her rendition of old English songs, Thomas Arne's setting of Shakespeare's immortal "The Beggar's Opera," John Barlett's "With A Suck of My Sweetheart" and Sir Henry Bishop's "Love Has Eyes". Miss Brancato was ably assisted by Harold Dart, who besides his sympathetic and capable accompaniments, performed a group of piano solos, Rondo in A of Haydn, Romanza by Schumann, the Waltz, Op. 34, and the "Winter Wind", Etude of Chopin. As an encore he played a delightfully rhythmic Cuban dance tune.

leader said he could not follow Prime Minister Mackenzie King's argument about the International Trade Agreement. He said that it should be judged on its merits as a business transaction and that was the way the British government regarded it.

President Roosevelt's statement at Washington, that the United States would not stand idly by if Canada were invaded had nothing to do with trade. It related to the defence of the United States and the same action would be taken if Mexico were invaded as if Canada were.

The Conservative Leader drew applause from all sides in the House when he hit out at critics outside Parliament who he said knew little about public affairs. ## Defends Patriotism

Dr. Manion listed his objections to the treaty as follows:

8. It will probably lessen Canadian employment in many Canadian industries.
9. It will probably increase unemployment in many Canadian industries.

United States producers and others interested were given an opportunity to appear before a committee of experts to express their views before a trade agreement negotiated. They were given information as to the intention to negotiate and there was no such publicity or consultation in Canada where the negotiations were being secret.

# Hitler Against Speed Fiends In Germany

BERLIN, Feb. 17.—Reichsfuehrer Hitler set 50 miles an hour today as the proper top speed for good Nazis on German highways and called reckless driving a "crime against the nation."

Opening the 1939 automobile show he also announced: "That 'raw materials we used to import from abroad no longer are necessary to us even if they are unrestrictedly at our disposal,' because of successes in the four-year plan for self-sufficiency."

Appointments of Colonel Adolf Von Schell as chief of the motor car industry with power to tell manufacturers what types to produce. He assigned Von Schell to reduce passenger types in 1939 from 55 to 23 and trucks from 110 to 14 to attain greater uniformity.

Germany's auto roads are not, as so many believe, built for a speed of 120 or 140 kilometers (74 1/2-90 miles) an hour, but for a speed of 50 kilometers (30 miles) an hour."

Instead of fixing an outright speed limit, however, Hitler relied on his expressed opinion of a 50-mile-an-hour speed to do the trick.
