THE CANADIAN MINER.—The S. S. Canadian Miner, of the Canadian Government Merchant Marine arrived in port on Sunday night on her second trip to this port and is now loading a full cargo of general produce and live stock for St. John's, Nfld. She will likely sail sometime today.

BACK FROM TRIP.—Mr. William Kerr, manager of Canadian Farm Products, Inc., has returned from attending a meeting of the Giant Potato Growers' Association of New Jersey, which was held June 19th. Mr. Kerr reports that he saw 200 acres of potatoes planted with P. E. Island seed in New Jersey and the crop looked excellent and was about two weeks in advance of other crops planted in other districts. Mr. Kerr says the prospects look good for opening up a large potato seed trade with the southern growers, provided the results of this year's experiment are satisfactory at digging time. If everything goes well P. E. Island growers will have a tremendous market, as the South will absorb at least \$200,000 worth of our seed annually—and will pay any reasonable price. Mr. Kerr urges that the P. E. I. Department of Agriculture arrange to co-operate with the southern experimental stations and to send sample lots of Island seed, in order to secure an official standing, and to enable Island growers to learn just what kind of seed is in greatest demand.

NEW MACHINE SHOP.—Good progress is being made on the new machine shop for Bruce Stewart & Co., Ltd., of which E. E. Parkman & Son are the contractors. The walls are all up and the building is being roofed in. This building measures 125 x 60 feet with an ell 30 x 20 feet. It is being built with special care as to permanence. WASHINGTON, June 30.—

Bids on former German liners offered for sale recently were opened today by the United States Shipping Board. Only two bids were received. It was stated, France and Canada Steamship Corporation bid \$3,000,000 on the Leviathan and the American Ship and Commerce Corporation bid \$800,000 on the Deckalb. Announcement on the disposition of bids will be made later it was stated.

VERA CRUZ, June 30.—There's another revolution in Mexico. General Carras Osuna, who is stationed near Victoria City in the state of Tamaulipas, revolted yesterday against the De la Huerta government, giving as his reason that he is not in agreement with General Obregon and has therefore taken up arms against him. Obregon has ordered General Arnuero Gomez and Porfirio Gonzalez with sufficient troops under their command to pursue Osuna.

LONDON, June 30.—Mystery still surrounds the locality of the hiding place to which the Sinn Feiners have taken Brigadier General Lucas, captured while on a fishing trip in Ireland. The Evening News however prints a story tonight to the effect that a friend of the general has received a letter from the prisoner delivered in secrecy, in which he says he is being well treated. The general also declared that it looks as though he will be held a prisoner for several weeks.

PARIS, June 30.—The International financial conference to be held at Brussels was postponed because the allies have not reached a definite agreement regarding the exact amount of indemnity to be exacted from Germany. Leon Bourgeois declared in a letter to Premier Millerand made public today, that an indemnity was necessary for Europe's economic stability as well as for the success of economic discussions of the League of Nations council.

ST. JOHN, June 30.—At the monthly meeting of the New Brunswick Division of the British Red Cross Society held here today a handsome certificate from the joint committee of the British Red Cross Society and the Order of St. John of Jerusalem, was presented to the Provincial Red Cross Society in recognition of its valuable services. The certificate was signed by Queen Alexandra, President of the British Red Cross, Prince Arthur of Connaught, and F. Davies, Secretary of the Red Cross.

BELGRADE, June 30.—The newspaper Pravda Susub correspondent telegraphs today that violent fighting had taken place between Albanian and Italian in Valona. The Albanians stormed Albania, the correspondent said, and captured the entire Italian garrison. The Italian and Albanian insurgents have been fighting in the region of Valona and Avlona for several weeks. The city has been held by Italians in accordance with the tentative decision of a peace conference awarding Southern Albania to Italy. It is one of the principal Albanian seaports with a fine harbor.

HALIFAX, June 30.—Chief detective Kennedy arrested two men today and charged them with 22nd and burglary. On May 22nd, Miss Edith Taylor's summer camp for girls at Petit Riviere was destroyed by fire. Circumstances were suspicious and the Attorney General for Nova Scotia has caused the services of the chief detective to investigate the case. Today he arrested Percy Cruz, aged thirty at Italy Cross, and Ernest Herman, aged 48, at New Cumberland. Both are married men and residents of Lunenburg. The detective also reported two truckloads of goods catalogued to have been stolen from the camp. The prisoners were taken to Bridgewater for trial.

WINNIPEG, June 30.—Manitoba's political future tonight is clouded in much the same uncertainty as prevailed in Toronto when Ontario had voted last fall except that the largest single group which will sit in the next legislature of this province will be adherents of the Norris second, and farmers, in third place. Whether or not Norris will continue as leader of the government is a matter which cannot be stated tonight with definiteness. It does not appear at a late hour tonight that the government is unable to win any amending concessions from the entente. This view may be thought to bear the flavor of propaganda. It is held in certain official quarters having the greatest interest in maintaining the present government and there is the same feeling among other politicians as outlined in our columns.

MONCTON, June 30.—A sensational jail breaking episode was reported from Dorchester last night when word reached this city that William Vanbuskirk, Joseph Adams, George MacDonald and another prisoner named Smith, knocked jailer Sweeney on the head and made their get-away, some time between 3:30 and 10:30 o'clock. Particulars of the jail break were meagre last night but it is understood that the three or four young men making their escape seriously injured jailer Sweeney before doing so.

VERA CRUZ, June 30.—Sanitary officials today noted progress in the campaign to stamp out the death was reported and no new bubonic plague here. Only one death was reported and no new cases had developed.

LONDON, June 30.—The Greek advance in Asia Minor has been halted to permit the consolidation of present positions according to a Smyrna dispatch today. The Polish forces were forced to retreat in the Ukraine before a Bolshevik attack according to a Moscow wireless received here.

ROME, June 30.—Efforts of the radicals to call a general strike throughout Italy have failed. Nearly every shop in the country is open and the vast majority of the men are working. The only real strikers thus far are the tramway men and the stone masons.

NEW YORK, June 30.—Beginning tomorrow the price of the Evening Telegram will be three cents. Frank A. Munsey the owner announced today. The high cost of labor and newsprint paper was given as the reason for the raise. The Evening Sun also a Munsey publication will go to three cents on July 1st.

WASHINGTON, June 30.—Senator Harding and Governor Coolidge have agreed to base the presidential campaign on a plea for restoration of party government as a substitute for personal government, Harding said today. This announcement followed a conference attended by republican candidates for president and vice-president.

LONDON, June 30.—Polish representatives here have approached Sir Eric Drummond, Secretary General of the League of Nations in an effort to obtain the League's offices toward a settlement of the quarrel between Poland and Soviet Russia, it was learned today. Drummond was reported to have been told that unless action was taken immediately Poland faced both internal and external dangers, over which her leaders felt great apprehension.

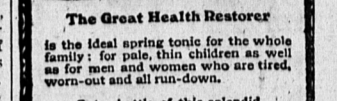
