Horse Races Thursday, Aug. 27th 1914

The management intend holding their annual horse race meeting on above date.

There will be the following classes: 2.19 Class Trot and Pace, mile heats, purse \$200.00; 2.24 Class Trot and Pace mile heats, purse, \$100.00; 3 minute Class Trot and Pace mile heats, purse, \$100.00.

Entrance fee, 5 per cent. with entry, and 5 per cent. from winners, entries close August 20th. Five or more horses to enter and three or more to start in each class. Best three or five. All races to end at end of fifth heat.

Two or more horses by the same owner or trained in the same stable may start in any race. Any horse distancing the field entitled to first money only.

The management reserve the right to change programme, postpone, or declare off, any race, for any good cause. The rules of the National Trotting Association to govern except where they conflict with above conditions.

Arrangements will be made to have special trains from Vernon, Charlottetown and Summerside and reduced rates on other lines, particulars of which will be printed later.

QUARTERLY SESSION, GRAND DIVISION, S. OF T. OF P. E. I.

The third quarterly session of the Grand Division, Sons of Temperance, was held at Hartsville on Friday last, with a good attendance, increase of membership, while none report any decrease.

The Report of the Committee on the State of the Order was thorough and two of its clauses became the important subjects of debate at the afternoon session. The first had reference to the purpose of the Temperance Alliance, of making Temperance a special issue at the next Provincial election. To this the Grand Division gave a unanimous and hearty endorsement.

The second clause recommended the employment of a special permanent organizer. As this will involve heavy financial cost, the question of ways and means was the principal feature to be grappled with. A decision was unanimously reached, and a programme adopted, which it is expected will provide for the Order this necessary boon.

A resolution was passed asking the assistance and co-operation of Subordinate Divisions to this end. The Committee on Ordinances reported resolutions having reference to the life work, and the death of the late Brother A. W. Tanton, P. G. W. A., which was adopted by a standing vote.

The enterprise of Union Division, in organizing and carrying out so successfully the big temperance picnic, was highly commended, and their example recommended to other Divisions of the Order.

A special feature of the gathering was the official visit of the newly elected Most Worthy Patriarch of the National Division of North America, the Rev. R. H. Stavert. We have the position of honour of having this high birth, and a brother of Island, and a splendid local campaigner, upon Island soil.

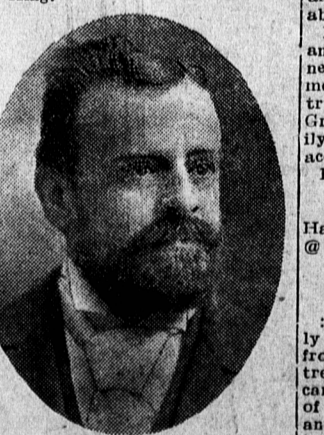
He was received in our impressive ritual form, and gave an encouraging and helpful address.

In the evening the usual public meeting was held in Hartsville Hall, presided over by the Grand Worthy Patriarch, Brother L. P. Tanton. The officers of the Grand Division, in full regalia, and a splendid local choir from Hantsville Division occupied the platform. The address of the Most Worthy Patriarch, the Rev. R. H. Stavert, was one of the most and most eloquent listened to upon an Island platform for many years.

To the large audience, filling the hall and standing outside at doors and windows, he presented a powerful and scathing arraignment of the liquor traffic with its concurrent evils, white slavery, poverty and want, public political and personal crime, insanity degradation and murder, and earnestly pleading with the people as an act of kindness to the saloon keeper to send him to prison to arrest him from his sin, and to wipe out the stains of the liquor curse from our fair land.

The following programme was splendidly executed, after which a vote of thanks, moved by Brother J. A. Lawson, B. G. W. P. and seconded by Brother J. C. Clarke, P. G. W. P., to the Most Worthy Patriarch for his visit and inspiring address, to the choir for their excellent music, and to the good people of Hartsville for their splendid hospitality. In the larger fields of temperance energy and moral reform there is a growing spirit of optimism to which the man-crowning victories in our progressive campaigns, lead a helpful inspiration. In both Canada and the United States, the silver clouds of Local Option, Prohibition, and License Restriction, are spreading their powerful influences to protect and to save the wife, the boy, and the home. Concurrent with this the falling off of National Revenues from Excise Sources, due to decreased consumption of Spirits, is convincing the manipulators of governments that the forces of temperance is one of those growing powers in the land to whose demands they will be compelled to give recognition. In our own Province there has been apparently less of intoxication than during the previous quarter. Whether this is due to a better enforcement of our Prohibition Act, or to a saner self-respect amongst drinking people, I would not undertake to determine. Both perhaps contribute to these pleasing conditions. We have before us in the immediate future the prospect of imperative demands for the most energetic and persistent work. Next year the National Division of the Order will hold its annual session in our Island Capital. We now have the proud distinction of having the largest membership, pro rata to population, of any branch of the Order on the continent. Let us not only maintain this place of advantage, but by the diligent effort of every Division, and of every member in our jurisdiction, to increase our membership and expand our beloved Order, that we may find our organization powerful and efficient and well in harmony with those other distinctions which has made our sea girt Province attractive to the outer world. I understand that it is the purpose of the Temperance Alliance and its allied institutions, to bring temperance into prominence as an issue at the polls when the Government next appeals to the people. This is a further incentive to greater activity in every society interested in the moral welfare of our people, and no effort should be spared to complete our equipment so that in the day of conflict our labours may be crowned with success. At the invitation of the good brothers of Union Division, I had the pleasure of attending a grand picnic and temperance gathering at Springfield, which was participated in also by a number of surrounding sister Divisions. We had a grand time. Short addresses were delivered by the chairman, Brother Thos. Haslam, the Rev. W. D. Wilson, Rev. Leonard Haslam, Brothers J. F. Proffitt, J. C. Clarke and your Grand Worthy Patriarch. Our work in the field of temperance is not all dry and formal. We have our pleasures and our recreation, and in this the members of Union Division have set a splendid example. In the death of my dear Brother, Past Grand Worthy Associate, Arthur W. Tanton, my own family circle has been under the heavy hand of bereavement. Victoria Division too, of which he was a most active and consistent member will miss his helpful presence, and our Grand Division one of its devoted past officers. In storm or calm, even in physical weakness he would come from his distant home, across Hillsborough Bridge, to attend to Division duty as an Officer. His work in the Division, as in private occupation, was always accurately and efficiently performed. He leaves us for our comfort and help, the example of a pure life and a character above reproach. Looking forward to greater work and grander triumphs let us put on new energy, making each days labour more effective than the last, and trusting in the guidance of the Great Patriarch above, move steadily forward until our purposes are accomplished. 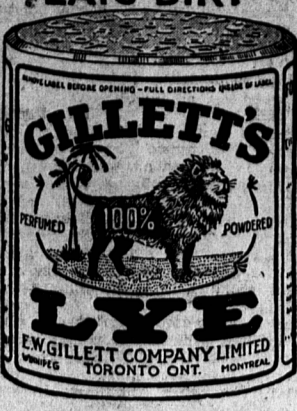

CLOSING STOCK LETTER

New York, July 27, 1914. The opening was staidier than expected today and then came an hour or two of liquidation and selling which produced a reaction of a point or two. As the day wore on, advices from Europe became more reassuring and the market closed in general at about the opening figures. The European war crisis over-shadows everything else and attention has been exclusively centered on it. The market developed so suddenly from Austria's Ultimatum to Serbia that it took everybody completely by surprise and a bad scare, especially on the European Bourses, has been the result. That no declaration of war has actually been made yet, and that England and Germany both seem earnestly working for peace, or at least to localize the difficulty, is the reassuring feature in the situation. Foreign gold engagement of over \$5,000,000 have been made for export while the rate of exchange has jumped to an entirely abnormal point. On the whole, matters worked through today remarkably well and there is much encouragement in the fact that each day we get goes by without a general diplomatic smash-up in Europe is just so much to the good towards a peaceful solution. London settlement began today. Considerable pressure in Canadian Pacific, which shows loss of over five points in London.

Austria and Serbia actively engaged in preliminary war movement. Europe awaiting action of Russia, on whose attitude general European war of peace depends.

Report from Vienna that Austrian Troops have crossed Danube and occupied Belgrade. Secretary McAdoo offers crop loan of \$4,000,000. Funds available at once at 2 per cent interest.

Imports from United States by Canada fell off \$40,000,000 last year, compared with the preceding year.

Carbajal to proceed with Huerta's finance plans and will float \$60,000,000 6 per cent loan at once.

Austria has handed the Serbian Minister his passports and he has left Vienna. 12 industrialists declined .04 per cent; 20 roads advanced .11 per cent.

NEW BISLEY RULES A BAR TO SHOOTING.

LONDON, July 24.—Voiferous cheers greeted the speech of Colonel Merritt, Commandant of the Australian team, at the general meeting on Tuesday night when he said Australia would have nothing of the new conditions which the War Office sought to impose on Australia for Bisley.

He said he was charged to intimate this in the strongest possible way that the adoption of such conditions would mean the destruction of rifle shooting in Australia. Colonel Ross disclaimed any authority to speak for the Minister of Militia of the Dominion Rifle Corps, but personal knowledge convinced him that Canadian marksmen would not have the aspirations to visit Bisley if new restrictions were imposed.

Rifeman Barnett, of Ulster, urging the Council of the National Rifle Association to work independently of the War Office, remarked that if his Province could raise a million pounds sterling for a contingency which he prayed would never arise, surely the National Rifle Association could raise five thousand pounds yearly to be able to get along without War Office assistance.

Lord Cheylesmore, the chairman, asked the overseas commandants to give him a written statement conveying their objections to be put before the War Office. The Bisley Camp without a Canadian contingent would be unthinkable.
