REVENGE WAS MOTIVE FOR BRUTAL CRIME

Thousands of Men Comb Los Angeles District for Trace of Marian Parker's Murderer—Accomplice is Held in Jail.

LOS ANGELES, Dec. 21.—Defying capture at the hands of the greatest force of officers ever assembled for a man-hunt in the West, William Edward Hickman, identified as the kidnapper and slayer of Marian Parker, 12 year old school girl, was still at large late today.

Spurred on by the positive identification of Hickman as the youth responsible for the abduction and killing of the child, and the arrest of another youth, Milton Jakowsky, believed to have been an accomplice, police in Los Angeles and Southern California pressed forward the hunt relentlessly.

Eight thousand men combed Los Angeles and its environs while others thousands prosecuted a search through the Pacific southwest for the killer on whose head a reward of \$100,000 has been placed.

Held Accomplice
In the arrest of Jakowsky, authorities believed they had found the man who gave Hickman information concerning the Parker family during the kidnapper's ransom negotiations with Perry M. Parker, bank official and father of Marian.

Jakowsky, in the belief of the investigators, acted as an intermediary for Hickman, who graduated as an honor student at Central High School in Kansas City in 1926 and is said to be 19 years of age.

Police said Jakowsky came to Los Angeles five weeks ago from Washington, D. C., where he is believed to have been a government employee. Jakowsky is known to have been friendly with both the Parkers and Hickman. His age was given as 25 and he was said to be single. Earlier in the day it was reported Jakowsky was from Kansas City.

Attempted Escape
Jakowsky attempted to overpower guards at the city hall this morning, but was subdued by four men and locked in another cell, while crying that he would take his own life.

A heavy guard was maintained about the jail because of threats voiced on the streets against the prisoner. Although taken into custody last night, his name was withheld until noon today.

Announcement that Hickman had been identified as the youth who lured the girl away from school last Thursday and on Saturday night delivered her torso to her father in exchange for a ransom of \$1,600, was made after police had compared finger prints from those in Hickman's police record. His photograph from the police files was identified by Mrs. Mary Holt, teacher, who was tricked into permitting Marian to accompany the kidnapper by his story that her father had been injured.

Hickman was employed as a messenger in the office of which Mr. Parker is assistant cashier. He was arrested on a forgery charge last summer, but was paroled.

Was Head Of Salvage Service During War

LONDON, Dec. 21.—Sir Frederick Wilken Young, expert in raising sunken submarines, died here yesterday at the age of 51. One of his most thrilling exploits was the raising of the British submarine K-15. He saved the lives of 43 members of the crew after they had been imprisoned for 56 hours on the floor of the sea off the coast of Scotland. The submarine sank while being tested. He also was the first to raise a sunken German U boat.

During the war Sir Frederick was head of the British Admiralty's salvage service. Under his direction 400 ships were salvaged for the Allies. These included the battleships Conqueror, Britannia and Lion, numerous cruisers and merchant vessels which were victims of the German submarine campaign. The Daily Express figured that during his career Young had salvaged hulls and cargoes stated at roughly \$250,000,000.

Prosperity Is Approaching, He Says

TORONTO, Dec. 21.—"The essential things that we can predicate our policies, sound business policies, on a period of continued prosperity, the length of which it would be foolish to prophesy except that it is not a temporary condition." This was the reassuring message in an interview today, of S. J. Moore of Toronto, who has just been elected president of the Bank of Nova Scotia.

He added, "I would consider the present as a most auspicious moment in Canada's history. I would be inclined to say that the high tide of her prosperity is approaching, rather than that it is here." "Have confidence," was his counsel to Canadians.

Col. Powell To Retire On May 1st

OTTAWA, Dec. 21.—Major-General H. D. B. Ketchen, present district officer commanding Militia District Number 10 at Winnipeg is to be appointed district officer commanding Military District Number 8 at Halifax, N. S., to replace Colonel Commandant A. P. H. Powell who will retire on pension. The change was announced today by Colonel the Hon. J. L. Ralston, Minister of National Defence, and will become effective May 1st, 1928.

Revenge Motive

Police expressed the belief that Hickman erroneously thought Parker had opposed his application for parole and had killed the bank official's daughter out of revenge. Parker did not oppose the parole, it developed today.

Police in their scouring search of the city located in the Bellevue Arms apartments a bathroom spattered with blood in which they discovered Marian Parker's body had been dissected. The proprietress identified Hickman's picture as the young man who rented the apartment under the name of Evans.

From a waste basket in the room there came a thin strand of thread which investigators pointed out matched perfectly the thread used to tie up four gruesome parcels found Sunday morning in Elysian Park and containing the forearm, legs and viscera of the slain girl.

Other Clues
The same waste basket gave up a part of a broken Brazil nut, the other half of which police said they found in the little pocket of the dress which covered the body of the slain girl when it was delivered to the father.

Other clues in the apartment included towels bearing stains said by investigators to be blood, and a shirt similarly marked. The tub, wall and floor of the bath room showed more stains. The floor was littered with newspapers bearing Los Angeles and Kansas City, Mo., date lines. The latter is the home town of the fugitive.

On a desk blotter was the imprint of the name "Marian."

Police identification of Hickman as the slayer received added strength from telegraph company employees at Alhambra, who identified his photographs as that of the man who sent ransom telegrams to Marian's father.

Death Of French Racing Owner

President Will Not Visit Canada

DUBLIN, Dec. 21.—President William T. Cosgrave of the Irish Free State will not visit Canada in connection with his proposed visit to the United States. James K. Walsh, Minister for Posts and Telegraphs in the Cosgrave government informs the Canadian Press that President Cosgrave regrets his inability to visit the dominion because of the lack of time at his disposal.

Man Who Gave up Law to Go Into Boot- legging Says He Will Spend the Rest of His Life to Stifle the Insult on the Statutes Known as the Prohibition Act.

CINCINNATI, Dec. 21.—George Remus, who forsook a legal practice in Chicago to become the operator of one of the most extensive bootlegging businesses in the United States, late today was found guilty by a jury here of the murder of his estranged wife, Imogene Holmes Remus. The verdict was based solely on the ground of insanity.

Nineteen minutes of deliberation sufficed for the two women and ten men of the jury to do all they possibly could toward freeing the former "king of bootleggers," two days less than 11 weeks after he shot and killed his wife while she was en route to court to divorce him.

Under the charge as given to the jury by Judge Chester H. Shook, Remus was denied a verdict of outright acquittal and his case automatically was certified to the probate court for a sanity hearing.

Within 30 minutes after the acquittal the papers were laid before Judge William B. Lueders, but he declined to act until tomorrow morning. Meanwhile Remus was forced to remain in jail, because the law permitted no bail for a person held for a sanity test.

In his jail quarters Remus was host to a merry anti-Christmas party. There rushed at least four of the jurors, and there was a constant stream of well-wishers hurrying to congratulate the man whose life had been in jeopardy only a few minutes before.

"You know what I said in the jury room," Robert E. Hosford, painting contractor, juror No. 12, remarked to a cheering group gathered about Remus in the jail.

"I said, 'Let's go out and give him his Christmas present, let's make him happy on Christmas.'"

Hosford said that if the court had permitted, the jury would have returned a verdict freeing Remus outright.

In his jail cell Remus hurriedly dictated a message of thanksgiving to his secretary, Vernon R. Chumb-broth (Kansas) Penitentiary, brought here as a possible witness.

"Thank God for a verdict that lifts the greatest burden man must ever stand," it ran. "God alone knows the thing that is within my heart at this moment."

The rest of my life I will dedicate to stifle the insult that is upon our statutes, known as the National Prohibition Act.

STILL NINETY LITTLE ONES TO BE PROVIDED FOR

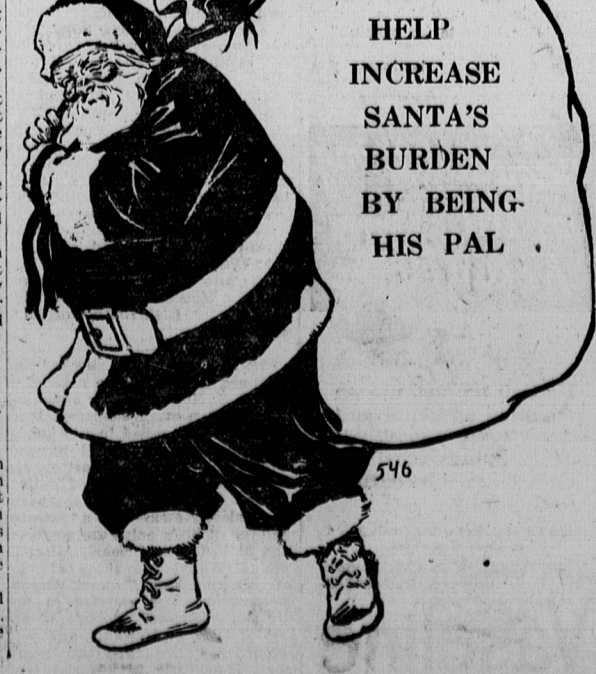

Four Drowned In Montreal River

Two divers who were lowered today failed to find the vessel up to 4.15 o'clock.

OTTAWA, Dec. 21.—The match business of the E. B. Eddy Co., Ltd., of Hull, Que., of which Hon. R. B. Bennett, Conservative leader, is a large stockholder, is to be taken over by a new company under the Presidency of George W. Paton of London, England, Chairman and Managing Director of Bryant and May, British Match Manufacturers. This announcement was made today by George H. Millen, President of the E. B. Eddy Co., Ltd.

Mr. Millen's announcement says: "Eddy Match Co., Ltd., has recently been incorporated and organized under the company's act, the charter having been granted last week from the office of the Secretary of state for Canada, for the purpose of acquiring the match business of the E. B. Eddy Co., Ltd., Hull, Que., the Dominion Match Co., Ltd., Deseronto, Ont., the Canadian Match Co., Ltd., Pembroke, Ont., the World Match Corporation, Ltd., Dorchester, Que., A. C. Woodruff of the Canadian Match Co., Ltd., will be the new general manager of the new company."

Mr. Paton, President of the New Company, is also chairman of the British Match Corporation, Ltd., a company having a capital of approximately thirty million dollars and whose operations extend to various parts of the British Empire.

Mr. Millen's announcement adds: "The E. B. Eddy Co., Ltd., has not disposed of any of its buildings or real estate, but pending the visit of Mr. Paton to Canada next year when the definite plans of the new company will be formulated, arrangements have been made with our company by which the new match company will continue to operate on the premises at 1 Hull at which we have so long carried on our match manufacturing business. The new match company will make no public issue of securities."

Campaign Not To Be Instituted This Year

TORONTO, Dec. 21.—The campaign to have voters use their franchise privileges is not to be instituted this year as there has been no appropriation for advertising. In previous years of operation the "vote as you like, but vote" campaign was made possible through voluntary contributions totalling approximately \$500. This year the official explanation is that there has been no particular issue to face and the sponsors will forego efforts and watch the effect of previous years of work to get more people to the poll, but it is probable that in the near future the campaigners will try to have election date changed to a later day.

French Naval Program Passed

(Special to the Guardian)
PARIS, Dec. 21.—The French naval program for 1927 to 1931, which was declared to be fully in accord with the Washington agreement, was passed by the chamber of deputies at a special session this morning. The voting was by a show of hands, the socialists abstaining.

The program for 1927 which must be completed before June, 1928, included one cruiser of 10,000 tons, six destroyers, five submarines of the first class, one other submarine, a mine layer and two despatch boats.

A sum of 18,000,000 francs (about \$720,000) was set aside for work to be done during the next two weeks. The expenditures for other years were: For 1928, 150,000,000 francs; for 1929, 250,000,000; for 1930, 250,000,000 and for 1931, 135,000,000 francs.

Three Appointed To Legislative Council

QUEBEC, Dec. 21.—Three appointments to the legislative council of Quebec were made at today's meeting of the Provincial cabinet. As a result two by-elections will follow, one in Quebec and the other in the Magdalen Islands. Two of the appointments were expected.

The other one, that of Hon. J. E. Carron, Minister of Agriculture, came as a bombshell in political circles.

The appointees and the seats they represent are as follows:—Louis Letourneau of Quebec, Division of LaSalle-Raoul Grotte of Montreal, Division of Salaberry Hon. J. E. Carron, Division of Kennebec. There is still one other vacancy in the legislative council, that of the Division of Lanaudiere.

Hon. Philippe Paradis, who has been appointed a member of the Senate of Canada, resigned from the Quebec legislative council today and he is succeeded by Mr. Letourneau. Mr. Grotte succeeds Sir Homer Gouin in the Salesberry Division, and Hon. Mr. Carron in Kennebec, takes the place of the late Paul Tourigny.

NOVA SCOTIA REFUSED TO PAY BILL

Responsibility For Payment of Troops to Be Decided by the Supreme Court.

(Special to the Guardian)
OTTAWA, Ont., Dec. 21.—Three references will be made by the government to the Supreme Court when the senior judicial body of the dominion meets again after Xmas, first, responsibility for the payment of troops called out in the Nova Scotia mine strike in 1925; second, the right of women to sit in the Senate; third, the demarcation of the federal and provincial rights of control over aviation.

The first reference deals with a definite situation. The Attorney-General of N. S., requested that troops be sent when the situation became crucial. This was done and after the troops were withdrawn the federal government sent the bill to the Nova Scotia government amounting to about \$130,000. Nova Scotia refused to pay the bill, whereupon Ottawa deducted the sum from the annual federal subsidy.

The second reference involved an interpretation of the British North America Act which defines what "persons" may sit in the Senate and the question has arisen as to whether a woman is a "person" within the meaning of the act and thus eligible for admission to the Senate.

The aviation question has been precipitated by the refusal of the Province of Quebec to recognize federal control of aviation within the confines of the position. In all other countries federal jurisdiction of aviation is an accepted principle but the Quebec government has refused to acknowledge this right and has flouted it.

Appointed To The Senate
