launched his reform programme earlier than it was for election purposes. He declared that his sentiments with respect to reforms which he now advocates had been expressed not only in the House of Commons in 1928 when he gave warning of the stock market crash which came five months later, but when he made his first speech in the Dominion Parliament.

"If we had attempted these reforms in 1930-1931-1932 or 1933, we would not have survived," Mr. Bennett declared. "Last year we commenced," he continued, mentioning the central bank, farm debts adjustment and marketing acts.

"Now it was not because of the election," the Prime Minister added, "and I am bound to say I have thought less of the election than I should."

People would say that "Bennett and his associates cannot bring these reforms," the Prime Minister warned his listeners. But most of the reforms recorded in history had been brought by those whom the people had said could never succeed.

Independent

With respect to himself Mr. Bennett said he was glad that he was in a little better position to serve than some others, "because I am independent."

When he outlined his reform policies, Bennett went on, "I put stated what was in the mind of every decent, thoughtful person in Canada. If you don't want socialism or communism—then reform the capitalist system. It was his objective that every young man and woman be given a fair chance to succeed. If there was no reform there would be anarchy."

"God has been good to me," Mr. Bennett said, referring to his personal success in attaining wealth and position. "I would like to show some sense of gratitude." His life in the past five years had been full of difficulties and hard work.

"If you can tell me what is in the mind of the people," Mr. Bennett exclaimed, "Why should I be the target for every man who desires to abuse me? Democracy is the poorest master in the world. It expects everything of its servants and the defendant's very evils it brings upon itself."

"But to the extent to which I may contribute to the happiness of my fellow citizens, I am happy to do so. This government desires to do so," Mr. Bennett told his listeners that speeches and applause would not win elections, "although they are useful. But you must organize and work."

Mr. Massey said the 20th century had demanded a leader. "Less and true" who would be the "great emancipator in Canada." Seven years ago at Winnipeg, Mr. Bennett had declared himself "the enemy of social injustice," and had dedicated himself to social reform, "conscientiously and with a fidelity of purpose he has accepted the challenge of his credo." Mr. Massey declared, "and is driving for the goal he then set."

TWO DAYS LATE

The Hamburg-American liner New York, arrived in New York two days late Sunday due to storms which carried away one of her ventilators and broke several windows on her boat deck. Capt. Eberhardt Friedel declared he had seen worse storms in his experience, but very few. Tons of water at times submerged the bow of the giant liner, effectively stopping her headway.

The storms encountered by the New York appeared to have been wide world, for two ships were driven aground off the Delaware coast, besides the four in difficulty in the Bay of Biscay.

Ice also hindered shipping near shore. The United States coast guard ice cutter AB 24 sank in Great South Bay, off Long Island, today when ice floes thrust a great hole in her side. Her crew escaped.

Upper House Will Discuss Patent Laws

Plans Underway For Canada-wide Organization.

(C. P. By Guardian's Special Wire)

OTTAWA, Feb. 24.—Senators will take off their coats this week to iron out the contentious patent laws of the country. With this government measure withdrawn from the Commons for initial consideration in the Upper House, the elder statesmen plan to clear up the Canadian laws on inventions as they did insurance and shipping legislation in the two previous sessions.

Reconvention of the Senate Tuesday is primarily for this purpose. The House of Commons' Insurance Act is not expected to be handed over to the Commons until later in the week.

Official views of the proposed changes in the Patent Act and regulations to make revisions of industry in opposition will be heard by the Banking and Commerce Committee. Secretary of State C. H. Gahan will appear before the committee on Tuesday morning.

B., Feb. 24.—A change of government will not solve the five serious problems with which Canada is faced today because world-wide conditions center completely into the situation that no government of any one country can control world finances and markets, declared Premier L. P. D. Tilley, on New Brunswick, in an address here tonight under the auspices of the Young Men's Canadian Club of Montreal.

"To state that the financial and commercial life of the country, at the present moment is perfectly sound, would be a fallacy," Hon. Mr. Tilley admitted. "There are many bright and encouraging spots, but there are serious problems yet to be solved. For example:

Debt Question

"The growing debt of the Dominion and provinces; the railway situation; the marketing of Canadian wheat; the low rate of prices especially in regard to farm produce, and our fish supplies and national unemployment relief."

After stating that "these five problems alone are sufficient to make a man in public life, and our citizenship generally, stop and ask where, when, and how will they be solved?" The speaker declared that a change of government would not remedy the situation, adding "the British Empire containing nations within a nation, is our best hope."

Of the Dominion and provincial debts, Premier Tilley had this to say: "There is no need of growing panic over the public debt, provided the increase does not continue much longer. Our annual revenue should, at least, keep pace with our debt interest and sinking fund and, at the same time, pay current expenses; but, at present, they don't. We are beginning to wake up to the fact that times are better; the nation, as a patient, is now convalescing. When fully recovered, will she be able to pay the doctors' bills?"

Wheat Situation

Discussing the wheat situation, he said that Argentine wheat is selling at 27 cents a bushel less than the Canadian pegged price, therefore, Canadian producers sold wheat in the British market at Argentine prices there would be a heavy loss to the producer. Pondering the question, should Canada continue her present wheat policy, or compete with the Argentine in the open market? Mr. Tilley thought it might be advisable to adopt the latter plan and take the resultant loss "until the Argentine realizes that it is high time for her to acquiesce in quota and prices for world wheat."

Price Spreads

Price spreads, he thought, are "the most important and vital question before the Dominion and provincial governments at the present time. A remedy must be provided so that goods and products are sold at fair, or adequate prices, he said, "even if governments have to go so far as to step in and peg selling prices."

With the unemployment situation "still with us, though in some localities much less than heretofore," Premier Tilley stated he believed the program of such vital importance that a conference between the provincial governments, and the Dominion government, could, with beneficial effect, be held at annual or semi-annual periods.

Budget

The budget is expected in about four or five weeks. Tariff experts have been busy for some time on proposed changes and it is believed there will be some alterations by mutual agreement in the Canada-United Kingdom agreement. The usual flock of delegations to await upon Finance Ministers, E. N. Rhodes during budget preparations, have been descending upon Ottawa.

Much interest attaches to forthcoming trade negotiations with United States and there is a possibility that the Easter recess will be utilized by some members of the Government to confer with Washington authorities, although a report already published that Prime Minister R. B. Bennett would go to Washington then has been semi-officially denied.

Preparation of the report of the mass buying commission upon which further reform legislation will be based, is proceeding slowly. The report to Parliament is not expected for another two weeks.

Police Nip Kidnap Plot

BETHLEHEM, Pa., Feb. 24.—State police reported today the arrest of four men on robbery charges apparently nipped a kidnap plot which had marked Eugene G. Grace, Bethlehem Steel Company President, and two public officials as victims.

While the authorities guardedly traced the outlines of the bizarre scheme reported to them, Trooper, Marshall Wolheim said one of the quartet revealed Grace was to be held for \$250,000 ransom.

The other intended victims, he said were named as Mayor Robert Pfeiffer of Bethlehem, and Nicholas C. Northampton county commissioner living in Bethlehem. Wilhelm said the ringleader of the conspiracy is at large.

The four, held for a series of robberies, including two bank hold-ups, are Barlow Orlando, 26, and Angelo Bonmarita, 21, both of Detroit; Frank Repynck, 26, Bethlehem, and Louis Kutzur, of Hellertown.

With the unemployment situation "still with us, though in some localities much less than heretofore," Premier Tilley stated he believed the program of such vital importance that a conference between the provincial governments, and the Dominion government, could, with beneficial effect, be held at annual or semi-annual periods.

Budget

The budget is expected in about four or five weeks. Tariff experts have been busy for some time on proposed changes and it is believed there will be some alterations by mutual agreement in the Canada-United Kingdom agreement. The usual flock of delegations to await upon Finance Ministers, E. N. Rhodes during budget preparations, have been descending upon Ottawa.

Much interest attaches to forthcoming trade negotiations with United States and there is a possibility that the Easter recess will be utilized by some members of the Government to confer with Washington authorities, although a report already published that Prime Minister R. B. Bennett would go to Washington then has been semi-officially denied.

Preparation of the report of the mass buying commission upon which further reform legislation will be based, is proceeding slowly. The report to Parliament is not expected for another two weeks.

Police Nip Kidnap Plot

(A. P. By Guardian's Special Wire)

BETHLEHEM, Pa., Feb. 24.—State police reported today the arrest of four men on robbery charges apparently nipped a kidnap plot which had marked Eugene G. Grace, Bethlehem Steel Company President, and two public officials as victims.

While the authorities guardedly traced the outlines of the bizarre scheme reported to them, Trooper, Marshall Wolheim said one of the quartet revealed Grace was to be held for \$250,000 ransom.

The other intended victims, he said were named as Mayor Robert Pfeiffer of Bethlehem, and Nicholas C. Northampton county commissioner living in Bethlehem. Wilhelm said the ringleader of the conspiracy is at large.

The four, held for a series of robberies, including two bank hold-ups, are Barlow Orlando, 26, and Angelo Bonmarita, 21, both of Detroit; Frank Repynck, 26, Bethlehem, and Louis Kutzur, of Hellertown.
