Escape of Prisoners

Life and property such as we have enjoyed in our civilization, is eternal vigilance: it is that Juries and Courts shall see that the law is enforced; that the Crown officers shall see that offenders are brought to justice, that when they are under trial they shall be safely held there, and when condemned that they shall not escape. Otherwise our civilization will very quickly go to pieces.

The Grand Jury's Duty

There is something that you gentlemen can do in regard to this. Not too much must be expected, but when you come to investigate charges of escape it will be your duty to examine very carefully indeed what has happened. This of course goes only a certain distance, but you will do your duty and go as far as you can in looking into the reason why those people were allowed to effect their escape and in what direction if any, the clues will lead you so that you may bring before the Grand Jury for the Crown any information that might help in connecting in any way the parties who have been guilty in this case in any respect.

In following up your clues as to the escape of these prisoners, if they point even with suspicion to accomplices you must bring the matter before the Crown officers, if you need any assistance in the drawing up of a bill of indictment or in the procuring of further witnesses I will assure you, you will receive that readily and efficiently from the Acting Attorney General.

In conclusion His Lordship called attention to the duties of the Grand Jury with respect to visiting the Jail and to the appointment of fence viewers. Rather than hasten through their work he asked that they would be prepared, if necessary to take another day upon bringing down their report.
