SOLD EFFECTS OF BOSTON BOY BROKER.

BOSTON, Dec. 12.—More than 400 men and women today thronged the sales rooms of the Roxbury Storehouse to attend the auction of the personal effects of Robert L. Davis, the "Boy Broker," who recently disappeared, leaving behind him many victims of his alleged high finance methods. Bidding was lively for most of the articles offered, and a seven-passenger touring car which Davis presented to his mother about a year ago, was knocked down to "H. I. H.," for \$100. These initials are said to represent H. I. Harman, of Newton, to satisfy whose mortgage for \$11,500 the sale was held.

ISSUED WORTHLESS CHECKS ON THE BANK OF N. B.

BOSTON, December 10.—The Montreal authorities believe that "H. I. H.," the Montreal banker who was arrested yesterday at New Haven, Conn., by the Boston police, on a charge of passing worthless checks, is L. S. Peppard, for whom the Montreal police have been searching. It is alleged that Peppard issued worthless checks on the Montreal branch of the Bank of New Brunswick, which he passed at Aberdeen, South Dakota.
