Exceptional sorrow entered the hearts of Mrs. Patrick McCaffrey, on the evening of Wednesday, Aug. 30, when Mrs. McCaffrey passed from her earthly abode at the advanced age of seventy years.

The late Mrs. McCaffrey was an ideal wife and mother, admired and respected for her excellent traits of character; an edifying member of the Catholic Church from which source she derived spiritual consolation during her illness.

The appreciation of a truly good woman was evidenced by the funeral cortege that followed the remains to St. Anne's Church, where requiem mass was celebrated by Rev. Dr. Curran, and when the final absolutions were given, interment took place in the adjoining cemetery.

Takes Blame For Wilhelm's Flight

BERLIN, Sept. 16.—The reactionary Der Tag tonight publishes a letter from Hindenburg, July 28, obviously intended as a complete whitewash of the ex-kaiser's flight to Holland. The letter is as follows: "Most Exalted, All-Mightiest Kaiser. Most Gracious Kaiser, King and Lord: "For the decision which Your Majesty made on the ill-fated November 9, based on the unanimous recommendations of all your competent advisers, I bear my share of responsibility. Grave danger threatened that Your Majesty's person would be seized by mutineers and delivered into the hands of internal or external enemies. Such shame and disgrace had to be spared the Fatherland under all circumstances.

"For this reason, in making my report to Your Majesty on the afternoon of the 9th, in the name of us all, I recommended crossing over into Holland as a last extremity, a measure which, moreover, I considered merely as a temporary expedient. That I urged an immediate departure on the night of the 9th is an error which recently, against my will, was mentioned publicly.

"For me there is no doubt that Your Majesty would not have gone off if your All-Highest self had not believed that I, as chief of the General Staff, regarded this step as imperative in the interest of Your Majesty and the Fatherland. In the protocol of July 27, 1919, it is already stated that I received the news of Your Majesty's departure only after it was completed.

"In conclusion, I beg to assure Your Majesty most humbly that all my life long I have maintained and always will maintain my undiminished loyalty to my Kaiser, King and Lord, and am therefore also willing always and everywhere to bear my full share of the responsibility for the decision of November 9.

"With the deepest awe and greatest thankfulness, I remain always Your Imperial and Royal Majesty's alleruntertänigster. "Hindenburg"

ROOM OF POOR HERMIT FOR FATHER VAUGHAN

Father Bernard Vaughan, who has been stricken with paralysis, is one of the most influential figures in the Roman Catholic Church, although he is not so much in the limelight as when he delivered his sensational series of sermons on "The Sins of Society," about sixteen years ago. From the pulpit of Farm Street Church, which is the heart of Mayfair, the smartest and most fashionable district of London, he fired most devastating broadsides on the manners and habits of the "idle rich." Sunday after Sunday his church was packed to the doors by the smart set, who were fascinated by his diatribes against themselves instead of being angry with him. Society lionized him, and he was the draw-card of the season in all the west-end drawing rooms, while the famous Drury Lane drama, "The Sins of Society" was founded on his sermon. Today, when he preaches (which is not very often), the church doors have to be closed early.

The popular view of Father Vaughan is that he not only mixes with the most exclusive people, but end of London doing good among the poor.

The writer had occasion to call on him one day, and when ushered into the great priest's room found—bare walls, kalsomined and tarnished looking; bare boards without even a rug; a small bedstead, such as one uses in camp; a cheap washstand and utensils; a sofa, at which even a junk man might look askance; and one chair, which with its slightly truncated legs gave the visitor a fatherly wobble. As he puffed his cigarette Father Vaughan remarked: "People imagine me living here in the lap of luxury; in a swaggar place with all the comforts of the rich.
