### GERMAN REARMAMENT OPPOSED

France and Italy Will Take United Action If Called Upon To Do So—France Concedes Territory In Africa.

ROME, Jan. 8.—Italy-French determination not to recognize Germany's rearmament was reaffirmed here tonight as Pierre Laval sped back toward Paris carrying with him the agreements he and Benito Mussolini signed during Laval's four-day visit.

An official communique giving details of the new accords which provide for French concessions to Italy in Africa and pledge the two nations to mutual efforts in the cause of Europe's peace—contained this significant paragraph:

"The Italian and French Governments, recalling the declaration of Dec. 11, 1932, in reference to the rights of equality, are in accord in recognizing that no country can modify by a unilateral act her obligations regarding armaments and that in case this eventually arises they will consult with each other."

It was under the declaration of Dec. 11, 1932, that Germany returned to the disarmament conference after her abandonment of it that summer.

She was granted, in this declaration, theoretical equality of armament rights but it was stipulated that this equality should be reached by gradual stages, partly through further disarmament of heavily armed countries and partly through the rearmament of Germany.

The Reich's considerable rearmament, alleged to have been achieved thus far, is therefore, Italy believes, in violation of this declaration, but what France and Italy intend to do about it was hardly made clear.

Well-informed circles here during the past few days have expressed the opinion that France would not recognize Germany's rearmament unless she signed the proposed non-intervention pact to be submitted to Austria and her five neighbors—Italy, Germany, Czechoslovakia, Hungary and Yugoslavia—and returned to the League of Nations.

### Tenders Called For Debenture Issue

MONTREAL, Jan. 8.—The government of the province of Quebec today called for tenders for a \$13,730,000 issue of non-callable sinking fund debentures.

The purpose of the loan was announced as to secure \$9,230,000 for refunding of loans recently matured less that proportion redeemed by sinking fund, and to secure \$4,500,000 to reimburse the consolidated revenue fund for advances made on account of capital expenditures for roads and bridges.

### Prepares Appeal On Behalf Of Sampson

HALIFAX, Jan. 8.—90 more days of life granted his client, Daniel P. Sampson, 49-year-old negro twice convicted of murder, defence counsel O. R. Regan, K.C., tonight prepared an appeal to the Supreme Court of Canada on two additional points that he had not argued in his previous appeal before the Nova Scotia full bench.

Eerie sound of carpenter's hammers building his scaffold could be heard by the condemned prisoner as he was told that Mr. Justice John Doull had granted a stay of execution. He received the news with the same stolidness he had maintained during two trials, although his new lease on life had come only two days before the date set for execution.

The decision almost coincided with a telegram from E. H. Coleman, Undersecretary of State at Ottawa, stating that the Governor-General had decided the sentence could "not be interfered with."

Sampson was first convicted for the murder of Bramwell Hefferman a year ago, almost a year after the dead bodies of Bramwell and his brother Edward were found alongside railroad tracks near Halifax, apparently killed by a long-bladed knife found nearby. The case was appealed last spring but the middle aged negro was again convicted and sentenced to hang January 10.

"JAFSIE" WILL TAKE THE STAND TODAY  
FLEMINGTON, N. J., Jan. 8.—Counsel for Bruno Richard Hauptmann promised "a number of big surprises" for tomorrow when Dr. John F. Condon, the "Jafsie" who paid the Lindbergh ransom money, will be brought to the stand by the prosecution.

"I have no idea as to just what sort of a witness Dr. Condon will make," Chief of Defence Counsel Edward J. Reilly remarked. "The court is going to have a lot of surprises once Dr. Condon gets on the stand, however. There will be a few angles developed which even the press may not have heard about."

### TWO WITNESSES ACCUSED

Sourland Neighbor Of Lindberghs And Taxi-driver Link Accused With Crime.

FLEMINGTON, N. J., Jan. 8.—Two men—one an elderly Sourland neighbor of the Charles A. Lindberghs, the other a Bronx cab driver—laid an accusing hand today on Bruno Richard Hauptmann, on trial for the murder of the kidnapped Lindbergh baby.

Gingerly, 87 year old Amandus Hochmuth, who lives at the entrance of the Lindbergh lane, unexpectedly tapped the stolid carpenter on the shoulder as he identified him as the man, in a "daddy green car" containing a ladder, whom he saw from his porch the day of the kidnapping—March 1, 1932.

Then Joseph Perrone, the cab driver, slapped the same rigid shoulder and almost shouted: "That's the man!" who 11 nights later sent him to Dr. John F. (Jafsie) Condon, elderly kidnap negotiator, with a note.

Hauptmann stiffened. He muttered, almost inaudibly: "You're a liar."

It was another day of swift sensations in the case by which the state of New Jersey hopes to send Hauptmann to the electric chair.

Already the carpenter had been accused by the father of the slain baby himself; already both Charles and Anne Lindbergh and Betty Grogan, the baby's nurse, have told their own stories.

Shortly before the fifth day of the trial ended in the tense atmosphere of the old Hunterdon County courtroom Dr. Condon himself entered.

Regarding as perhaps the state's chief witness, the aging educationist who paid the \$50,000 ransom for a dead baby walked into the courtroom and took a seat near Col. Lindbergh.

Prosecutors expect that when he came tomorrow, he will accuse Hauptmann directly as the man who took the ransom from his hands.

### King Approves Of Marriage

PARIS, Jan. 8.—Former King Alfonso of Spain devoted himself today to preparations for the marriage of his two children as it became known his own marital relations with Queen Victoria were in jeopardy.

Alfonso was said to be planning to give Prince Jaime and the Infanta Beatriz a start toward happiness by presenting them each with incomes of \$25,000 a year on their wedding days. Royalist circles described him as delighted with the prospect of their marriages.

Meanwhile, the same source revealed, he and Queen Victoria are negotiating for a legal separation and division of property. The Queen was said to desire the separation to preserve her own property because Alfonso's expenses so greatly exceeded her own.

Proposals for an annulment, Royalist informants said, had been dropped because of the prominence of the pair.

### Accident Takes Place At Curve Near Tracadie

Injured Passengers Not In Critical Condition—Spread Rails Believed Cause Of Mishap.

Derailment of passenger train No. 51 en route from Charlottetown to Souris yesterday afternoon caused painful injuries to four passengers in a second class coach which with a first class coach turned over on its side when the locomotive and train left the rails about one-half mile west of Tracadie.

Mr. Winston Birt, Mt. Stewart. Bad scalp wound, necessitating nine or ten stitches.  
Mr. Roy Laird, Mt. Stewart. Head and body bruises.  
Mrs. Margaret Coley, St. Andrews. Head and hip bruises, and shock.  
Mr. William Douglas, Mt. Stewart. Slight injuries.

Messrs. Birt and Laird are now in the Prince Edward Island Hospital, Mr. Birt's injuries are believed to be the most severe though not of a critical nature.

Passengers in the remaining two coaches, among whom was Hon. J. A. MacDonald, M. P., were unhurt, but remained upright. The baggage car was partly on its side.

The accident happened at 4.05 p. m. The train, in charge of Engineer Cameron and Conductor P. Hughes, was running at schedule speed when it hit the curve. The cause of the accident was apparently a spread rail. The derailed engine carried all the cars with it off the track. Passengers in the rear coaches felt only a series of unpleasant bumps, but in the second class car and the first class coaches which overturned the shock was severe, all the occupants being badly shaken up.

First aid was promptly rendered to the injured by Dr. T. L. Farmer, and by Mrs. Farmer, Mount Stewart, and Miss Curran, Peakes Station, trained nurses, who were passengers on the train.

The Georgetown train which left Charlottetown twenty minutes after the Souris train arrived at the scene about an hour after the accident, and returned with the passengers to Charlottetown, where they arrived about 7 o'clock. A special train was placed at their service last evening, which left Charlottetown at 10 o'clock and proceeded east by way of Hillsboro Bridge to Lake Verde, thence by way of Mount Stewart to Georgetown and Souris.

A wrecking crew was engaged all last night in repairing the line, which is expected to be ready for traffic sometime today. The rails were torn up for some distance and it is expected that the incoming train from Souris today will have to come by way of Lake Verde.

### Seaman Is Badly Burned

YARMOOUTH, N. S., Jan. 8.—Sprayed with blazing gasoline while cleaning the pilot vessel of the battered motor vessel Dream Girl, Engineer Louis Muse was in hospital tonight suffering from terrible burns.

Dirty and dented after battling the full fury of an Atlantic gale off George's Bank last week, the Dream Girl hobbled into Yarmouth yesterday with seaman Dennis Deviller injured, his arm cut and body bruised from a fall during the storm.

### Fog Paralyzes Traffic On North Atlantic Seaboard

NEW YORK, Jan. 8.—Traffic by ocean and air was paralyzed today along the North Atlantic seaboard by the worst fog in years. It was as thick as pea-soup. With night-fall, it became thicker.

Trains were late. Not a passenger plane moved in the metropolitan New York airports. Ocean liners waited at anchor outside the Boston and New York harbors—some more than a day late at their docks.

In New York only a few tugs ventured forth in the bay or the East and Hudson Rivers. Ferryboat schedules were completely disrupted.

At mid-afternoon the fog over New York Harbor lifted enough to allow several liners to proceed at a cautious pace, with fog horns going constantly, to their piers. Other liners, including the Majestic, were held out beyond quarantine.

In Boston harbor, the conditions prevailed. The White Star liner George left its pier Sunday for Liverpool. The fog forced it to anchor near Spectacle Island in Boston harbor and it still was there.

Mariners said they had experienced fogs more dense but few so protracted. There was no indication of a let-up. The forecast was for continued fog and cloudy weather. The day was unseasonably warm, a contributing factor to the density of the fog.

### 55,000 SILVER FOX PELTS AUCTIONED

Foreign Buying Strong Feature Of Second Day Sale.

MONTREAL, Jan. 8.—Foreign buying was a strong feature of the second day of the fur auction sale of the Canadian Fur Auction Sales Limited, here today. The foreign buyers bought heavily of silver fox pelts. In all, 55,000 silver fox skins were put on the auction block, the pelts coming from Prince Edward Island, Nova Scotia, New Brunswick, Ontario, Alberta, Saskatchewan and British Columbia. A block of 54,000 skins will be put on sale tomorrow.

A report of the day's sales follows: Selected full silvers, 30 percent sold, averaging \$55.70; ordinary full silver, 56 percent sold, averaging \$39.26; 1-8 silvers, 94 percent sold, average price \$23.95; inferior and low grades, 95 percent sold, average price \$27.55.

Total sales turnover for the first two days of the sale was \$405,000.

### Will Discuss Civil Service Cuts, Etc.

OTTAWA, Jan. 7.—Finance Minister E. M. Rhodes and a civil service delegation will get together next Thursday to discuss the 14 percent salary cut, statutory increases and promotions. The meeting will be held in the office of the Minister, and according to preliminary announcements delegates will be given an opportunity to bring up any question they wish. Invitations are being sent to various organizations of the service to send representatives.
