## PEACE TREATY TO BE CONCLUDED WITHOUT HELP OF UNITED STATES

### Present Intention is that Britain, France and Italy Will Put Treaty With Germany Into Effect by Dec. 1st. Without American Co-operation.

(Special to The Guardian.)  
PARIS, Nov. 21.—While the supreme council did not positively decide today to put the peace treaty with Germany into effect on December 1st, its members all agreed it would be desirable to do so. An effort will be made to have all preparations for the enforcement of the treaty completed by that date, and it will probably be put into effect very early in December, regardless of the failure of the United States to ratify the treaty. The American delegates declare themselves still hopeful that a compromise will be arranged in the Senate, but the French and British peace delegates are apparently less optimistic and inclined to prepare to carry out the treaty without American co-operation.

Suggestions that another treaty, more to the liking of the European Allies, be negotiated apparently are not seriously taken.

The French British and Italian delegates to the peace conference seemed to be dazed by the Senate's refusal to approve the treaty and unable to comprehend how the signature of the American peace delegation failed to bind the American government. The American delegates are without instructions as regards their future course. Henry White will continue to sit in the supreme council meetings, and the delegation will function as usual until otherwise instructed.

## PRINCE OF WALES VISIT TO U. S. ENDS TODAY

### Visited Tomb of Roosevelt Yesterday Morning and was Host to 1000 Children on Renown in Afternoon. Sails for Halifax Today.

NEW YORK, Nov. 21.—Edward Albert Prince of Wales, began the last full day of his visit to New York today with a trip to the grave of Theodore Roosevelt at Oyster Bay. The Prince carried a wreath to place on the late ex-President's grave.

This evening he will be the guest at a dinner of the Pilgrims at which a visit to the hippodrome and a reception at the Seventh Regiment Armory, arranged by Mr. and Mrs. Rodman Wannamaker will complete the day's events.

Tomorrow the Prince will end his visit to the United States sailing on the Renown for Halifax.

## England Appreciates U. S. Reception to H.R.H.

## England Will Maintain Order in Egypt

## HALIFAX PROGRAM FOR PRINCE'S VISIT

HALIFAX, Nov. 21.—An official announcement of the program of His Royal Highness the Prince of Wales during his two days' visit here, has not been made pending the arrival of Sir Joseph Pope, Under Secretary of State, who was expected to arrive last night from Ottawa but did not.

It is practically certain that H. M. S. Renown with the Prince on board will arrive in the harbor from New York on Sunday at sunset.

The Dominion Government will entertain His Royal Highness at a dinner at the Halifax Club on Monday evening, and from the club the Prince will go to Government House and be the guest at a dance there.

On Tuesday His Royal Highness will give a luncheon on the Renown, and the ship will sail that evening for England.

## 2400 CANADIANS STILL IN BRITAIN

(Special to The Guardian.)  
LONDON, Nov. 21.—More than a year after the signing of the armistice there are still 2400 Canadian soldiers in Britain awaiting repatriation, apart from the twenty-odd thousand discharged men. While the number is small, it is supplemented by an equal number of dependents, and they have been giving the military authorities much trouble of late through their failure to turn up at a steamer after their passage had been booked.

A recent decision that returned soldiers be allowed free repatriation after six months' delay for family reasons promises to lengthen greatly the work of repatriation now almost concluded. The first party of 25 women immigrants for Canada under the direction of the overseas committee, have sailed on the Metagama from Liverpool. They are mostly denobilized war workers going out as household helps.

## F. W. Sumner of St. John, Soldier's Friend is Dead

ST. JOHN, N. B., Nov. 21.—F. W. Sumner Agent General for New Brunswick in Great Britain, died suddenly yesterday afternoon at the Royal Hotel.

The news spread quickly and was received with many expressions of surprise and grief.

Mr. Sumner arrived from Moncton on the noon train accompanied by his wife, and his daughter, Mrs. McDougall. After lunch at the Royal Hotel he went to the rotunda and sat down in a chair there. Shortly before three o'clock, Mr. Sumner, an engineer of the Northern Electric, and Mr. Nesbitt of the same company, noticed that Mr. Sumner appeared ill. He was at once taken to his room, and Dr. Addy was summoned by telephone. The doctor soon arrived but in spite of all he could do, Mr. Sumner passed away at twenty minutes past three. Death was due to acute indigestion complicated by a cerebral hemorrhage. Deceased had had several serious attacks of illness recently and seven or eight years ago underwent an operation in Montreal.

When Mr. Sumner was taken ill messengers were sent out in search of his wife and daughter who had gone shopping, and they were found in a shop and hurried to the hotel. At a meeting of the Board of Directors of the New Brunswick Telephone Company, which Mr. Sumner had come to St. John to attend, was in progress, and when the Board was notified by telephone of his sudden death it adjourned out of respect to his memory.

The remains were taken to Moncton on the late train last night.

Mr. Sumner was one of the best known business men of the province and had also taken an active interest in its political life for many years. Some years ago he accepted the position of Agent General for New Brunswick in London, stipulating that he was to receive no salary for his work. While his large business interests frequently called him back to Canada, he spent most of the years in London, and as Agent General extended a hearty welcome to New Brunswick soldiers visiting London, as well as to business men and travellers. The work of his office during the war was arduous and important, for he made a point of keeping in touch with the wounded men of the province as far as possible and letting their relatives know how they were getting on. He was frequently called upon by people of the province to undertake special missions on behalf of their soldiers, and his work in this connection was much appreciated.

Besides conducting a large hardware business at Moncton, Mr. Sumner was identified with many important business enterprises. He was president of the Atlantic Underwear Co., Ltd., one of the thriving industries of Moncton; President of the New Brunswick Petroleum Co.; president of the Kent Freestone Co.; president of the New Brunswick Wire Fence Co.; director of the Moncton Tramways, Electric and Gas Company; director of the New Brunswick Telephone and Gas and Oilfields Co., Ltd., and director of the Humphrey's Glass Co., Ltd.

Politically he was a Conservative, and in 1908 he was an unsuccessful

## PREMIER DRURY ADDRESSES MEETING OF BOARDS OF TRADE

### Declares Ontario Needs Not Fear Class Legislation. The Government Assumed the Responsibility in a Spirit of Public Service.

(Special to The Guardian.)  
TORONTO, Nov. 21.—Premier Drury of Ontario and Dr. J. B. Hanna, president of the Canadian National Railways, delivered notable speeches at a memorable meeting of the Associated Boards of Trade of Ontario in the Royal Bank Building last evening. Mr. Drury made his first public utterance since assuming the responsibilities of Prime Minister. He was given a remarkable ovation, and representative business men from all parts of the province enthusiastically assured him that they are determined to give his government more than a fair chance to make good. His remarks made a profound impression. Incidentally he referred to his party as the "People's Party." "You need fear no class legislation," he declared amid an outburst of applause. "The government of this province has been taken over in a spirit of public service. The old party system has outlived its usefulness. The new people's party will go forward with a sincere desire to serve unhampered by the barnacles, the parasites and the hangers-on of the old parties. There will be no thought of class legislation."

Mr. Hanna, who also had a magnificent reception, spoke optimistically of the future of the Canadian National Railways, declaring that he had every confidence in the ability of the largest publicly owned railway system in the world to pay if the people of Canada would see to it that politicians and governments were made keep their hands off the management.

## The Rena McLean Hospital

The Patriot yesterday gave publicity to the rumor that the Rena McLean Memorial Hospital is to be closed. This rumor has been in circulation for some time but has so far lacked official confirmation. It will be remembered that at the height of the war when returned invalided soldiers were arriving in Canada in great numbers the Dominion Government endeavored to provide hospital accommodation in every province to meet the emergency. Here there was no suitable accommodation available for the purpose and a deputation of citizens waited upon the government and urged that Government House be handed over to the Dominion Government for the purpose. The late Lieutenant Governor, McDonald readily acquiesced and volunteered to vacate Old Colony House provided another government house were substituted. Brighton Villa was obtained for this purpose and the Provincial Government then handed over Government House to the Military Department on the understanding that when it was no longer required, as a convalescent hospital, it should be returned to the Provincial Government.

An enormous amount of money has been expended in converting Government House into suitable administrative offices and in the erection of ward accommodation but the early termination of the war has prevented the hospital being utilized to its full capacity or anything like it. At the present time there are only about thirty patients receiving attention and for these the whole administrative and executive staff is to be maintained. This no doubt has given ground for the report that the government intends closing the hospital.

So far the authorities at Ottawa have given no intimation of any such intention and the local government which would likely be the first to be advised in the matter, has not been communicated with. It is sincerely to be hoped that the institution will not be closed and that, if it be not required for its original purpose, the Dominion Government will find other means of utilizing it.

It would make an ideal home, for instance, for incurables and it is regretted that as a result of this war there are a great many of these throughout Canada.

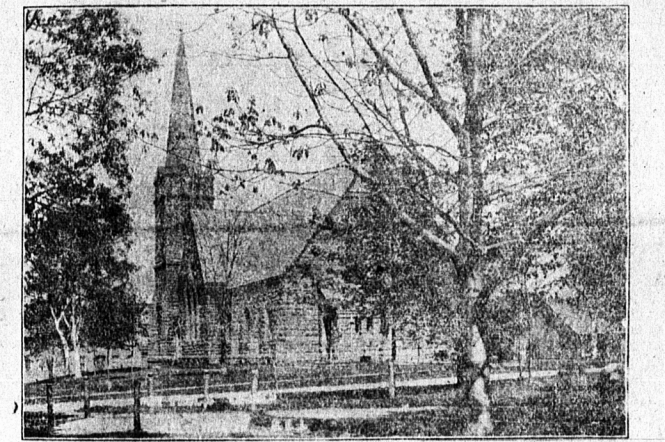
