SPLENDID TRIUMPH AGAIN LAST NIGHT

Miss Darling and the Boston Opera Singers Delighted Their Audience.

Last night's performance was by far the best of all the operas given as yet by the Boston Opera Singers. Miss Darling's singing of Violetta was a revelation as to the marvelous sweetness of her remarkably sympathetic voice. While her acting was equally great, this gifted artist is certainly to be congratulated upon the grand future before her, and it will be many years before Charlottetown will be favored with an opportunity of hearing so delightful and together charming young singer.

Miss Belle Mallette was a delightful surprise in the role of Flora, Violetta's friend. Her sweet clear penetrating voice being heard to great advantage her petite personality added great charm to the role. Miss Richey sang the role of Anna with grace and discretion. Roland Pauli as Alfred Germont, sang in splendid voice, and acted the role with finesse. Mr. Paul's magnificent tenor voice was probably heard to better advantage than on Monday night, while his clever acting and picturesque personality added greatly to the charm of his performance. The one particular gem of the evening, however, was Signor Archille Alberti, who as the father of Alfred, in the second act, sang delightfully and in a manner that will long be treasured as an operatic gem by those who were fortunate enough to hear this great artist's work. Frances J. Boyle sang the small role of Dr. Grenvil with dignity and a musical precision that evidenced this artist's great versatility. His kindly solicitation for the welfare of Violetta being distinctly opposite to that of the fiend incarnate, which he played the previous night.

On Sunday last, upwards of 2000 people assembled in St. Mary's church to be present at the ordination of Rev. John A. McDonald to the priesthood, by His Lordship Bishop MacDonald, who was assisted by Rev. Dougal McDonald, Tignish, James MacDonald of St. Columba, and Rev. Dr. McLellan, of Charlottetown as Master of Ceremonies, while Revs. R. B. McDonald, Dr. Walker, Dr. McMillan, Dr. Curran, K. C. McPherson and R. J. McDonald occupied seats in the sanctuary. After the ordination a forcible sermon was preached by the Rev. Dr. McMillan of Cardigan. At 7 p. m. the newly ordained priest, gave solemn Benediction assisted by Rev. K. C. McPherson of St. Margaret's as Deacon, Rev. R. J. McDonald of St. Dunstan's College as Sub-Deacon, Rev. Dr. McLellan of St. Dunstan's Cathedral as Master of ceremonies, after which His Lordship Bishop MacDonald held a formal reception of the parishioners.

G. Gordon White and C. A. Pendleton again proved their merit by singing small roles creditably, while Joseph Florian's magnificent basso voice was heard to great advantage. This young man is a decided acquisition to the organization and will no doubt prove his worth in the near future. He Had Succumbed to Heart Failure and Faithful Dog at First Refused to Allow Searchers to Go Near His Masters Dead Body.

PORTSMOUTH, N. H., Oct. 28.—Nathaniel Frothingham, a prominent Boston attorney, was found dead of heart disease recently in the woods at Rye Beach, where his summer home is located. Mr. Frothingham had been out hunting and when he did not return in the evening a search was made for him. His body was found sitting in an upright position in the woods, with his dog keeping guard. The dog at first refused to allow the searchers to approach the body, but when a servant from the Frothingham cottage arrived the dog recognized him and relinquished his guardianship over his dead master.

CAPTAIN AND MATE WALK THE PLANK

VICTORIA, B. C., Oct. 28.—Having for his mission the prosecution of a pair of pirates who sailed the South Seas in a stolen vessel until they piled her up on a reef, G. G. Alexander, acting attorney-general, for the Fiji Islands, is here en route for Calcutta, Peru to secure evidence. J. Mortelmans, a Belgian and T. Skerret, a boy, are the men in custody. In addition to being held for the piracy of the schooner Nueva Tigre, they must answer to the charge of the murder of the captain and the mate, whom they are believed to have forced to walk the plank.

SHRUBB ISSUES A DEFIANCE

MONTREAL, Oct. 28.—Shrubb states that frequent statements are coming through to him—he is acting as coach of the Harvard track team—that Longboat could beat him. Only a couple of days ago the statement was made in print in Montreal that Longboat could beat him by a mile. "Well, perhaps he can," said Shrubb, "but before I am willing to believe it, I should like to try. Longboat is a great runner—a wonderful runner, and it is not with any feeling of animosity or anything of the kind that I came here to test my time against his. He has run some wonderful races, but my times are better than his. A comparison of them will show that. My record for five miles, for example, is 24 3/5 and Longboat can't touch that, at least he hasn't done so yet. I hold a record of 50.40 3/5 for ten miles, and I don't believe Longboat, wonderful runner and all he is, can touch it. "That's just it: Longboat's managers are over-enthusiastic saying he could beat me. Why don't they give him a chance. "Longboat is running as an amateur, but in no other country in the world would the governing body stand for amateurism of his kind. "This is my last year in running. I am twenty-nine years of age, and will quit the cinder path after this season. "Shrubb thereupon produced the following: "I hereby challenge Tom Longboat to a series of three races at ten, twelve and fifteen miles, or such other distances as may be agreed upon, and I back myself to any amount agreed on to beat him in at least two out of three of the races.

REFUSED A FORTUNE OFFERED AS BRIBE.

DULUTH, Minn., Oct. 28.—The death of Ex-Gov. John Miller, of North Dakota, recently recalled the famous fight against the Louisiana lottery in North Dakota. Mr. Miller led the fight against the Lottery, and the story is told that a representative of the lottery came into Mr. Miller's office and laid down a suit case containing two hundred thousand dollars. "That is yours if you will permit the lottery to enter North Dakota," he said. "My price is higher than that," said Mr. Miller, and he threw him out of the office. They called him "Honest John Miller" in North Dakota. His fight against the lottery was rewarded after that.

GAVE HIS LIFE FOR THE WORK.

TORONTO, Oct. 28.—Under particularly sad circumstances the death occurred recently at the General Hospital of Claude E. Harwood, a fourth year divinity student at Wycliffe College. While ministering to the workers in one of the construction camps of the Grand Trunk Pacific Co on the National Transcontinental Railway, the young man contracted typhoid fever, and although everything possible was done for him, he gradually grew worse and passed away. Deceased was a native of Birkenhead, England.

RECEIVER APPOINTED FOR FOOD CONCERN

QUINCY, Ills., Oct. 28.—It developed that Judge Albert Akers of this city, had appointed John E. McKeown secretary and general manager of the Battle Creek Breakfast Food Co., Ltd., manufacturers of Egg-O-See, with general offices in Chicago, a receiver of the property and business of the company. The action was taken Saturday quietly on the application of B. S. McCoy of Buffalo, N. Y., manager of the Buffalo plant of the company, representing as stated in the petition, the interests involved. Mr. Linehan at once furnished the required bond of \$200,000 secured by Illinois Security Company. The company is a partnership affair organized under the Michigan law Feb. 18, 1902, capitalized at \$1,000,000 with five thousand shares of preferred and the same number of common stock at \$100, par value.

DROWNING MAN HAD WRITTEN MESSAGE

GANANOQUE, October 28.—Two young men of the town, F. Amyot and W. Baker, while fishing about a mile and a half west of the town found a glass bottle corked and with a paper enclosed. They took the paper out and found the following: "John Jenkins and Philip McGraw are drowning off Quintone Island, Sept. 1st, 1908. My wife inherits my savings." (Signed), JOHN JENKINS. No further address was given and whether this was the record of an actual drowning accident, in these waters is not at present definitely known. The writing was with pencil.

The annual meeting will be held on November fourteenth, and within the next week or so notices and invitations will be sent out. It is expected that nearly a hundred delegates will be in attendance, and these gentlemen will be armed with proxies from every amateur organization in the province. From the general interest taken this early in the season, this winter promises to be the greatest ever. With more than one hundred teams affiliated with the O. H. A. in line and all the districts under way by December fifteenth, all will be activity. About February first the districts will have completed their schedules and play-offs in the various divisions will take place.

THE DEATH OF REV. H. MCKEOWN

FREDERICTON, N. B., Oct. 28.—The large number of friends of Rev. H. McKeown, formerly pastor of the Methodist church, in this city, were saddened to hear on Saturday of the sudden death of that gentleman at Sussex. His remains were interred at St. John yesterday.

Rev. Mr. McKeown was born at Nictaux, Annapolis county, N. S., and was educated at the Wesleyan University of Middletown, Connecticut, entering the ministry about 30 years ago, and was aged 57 at his death. Two of his brothers are Methodist clergymen, Rev. S. McKeown and Rev. Dr. A. McKeown of Portland, Me. He married Miss Harrison, sister of Dr. Harrison of the New Brunswick University, who survives him, as do his two sons and three daughters, the eldest the wife of Rev. J. M. Campbell, a member of the N. B. and P. M. Conference.
