over the wharf and saw no other wet place. There was oil on the surface of the water. The car truck seemed to go pretty straight. McCoubrey was wet. Peters was dry. He had on no coat, sweater nor cap. When he took McCoubrey back to his house he was cold and shivery. Somewhere the names of the drowned man were mentioned. Both the men were in a state of excitement. McCoubrey had a mark over the eye on the forehead. He was swollen. He told us about being wounded in the war and showed us the place on his shoulder where he was scalded a few weeks before. Mr. Burke noticed no blood marks.

John Bradley (sworn). I live in the Southport. I remember 17th of July. I was disturbed 25 minutes to 3 Sunday morning. I looked at the back door at the west end of house. They were kicking the door and cursing. They kicked the doors and then said "Let us in." I stayed in bed. I was alone and unsuspected. They said "Open the door and let us in." I waited and sat on the side of the bed. After a time they went away. I got up. lit the light. They went through the gateway and I turned towards the wharf. I didn't notice their dress then but later on I did. One was dressed in dark. The other had a white shirt on. They asked McGarry what they wanted and who they were. He said "I wish I did know. I went into my bedroom and then two men went up the road toward Burke's Corner. Then I shut the door and went to bed. Sometime after that I put the window blind up and saw two policemen (and others). I got dressed and went up to Burke's Corner. When I got up there, there was a man standing. I saw two policemen, George McDonald, Peters and McCoubrey. Peters and McCoubrey were bare-headed. McCoubrey had a black coat on. Peters had his sweater then. Then they started to the wharf. On the way down we got ropes and block and went to the wharf, and hitched the gear to the car. In pulling on the rope the rope broke. I was present when the first body was brought up. I heard Peters tell about the car. He said "The car belongs to me. I was too drunk and couldn't run the car. I gave it over to McCoubrey and he made a mistake. I heard McCoubrey say "I would like to know where that man lives." "We broke his window and we will pay him for the damage." Peters was staggering on the wharf after 8 o'clock.
