Annual Thank Offering Service Of W. M. S.

The annual Thank-offering Service of the Women's Missionary Society of the Kensington Presbyterian Church, was held on Oct. 27th. Meeting was presided over by the Pastor, Rev. Wm. O. Rhoad, who delivered a very appropriate and inspiring missionary address, taking as his text, "But the Spirit said to Phillip, 'Go and join yourself to this chariot.'" Acts 8:29.

"Here we have an account of a little missionary work. It was not carried on by a great organization. There was not a large staff of missionaries. There were not many mission stations ministering to many people. "Here we have but one evangelist sent by the Spirit to preach to one man! Yet this small missionary work was the work of God. "The evangelist was the instrument which God was using. The man to whom the evangelist preached had been prepared by God to hear the message. He had been preparing to receive the message by his religious background; by the fact that he had been to Jerusalem, and by the fact that he was there at the time that Phillip came to him) reading a portion of the prophet Isaiah, which spoke of the death and resurrection of Christ. "God used this missionary work, carried out in a small way, and great results followed. The land of Ethiopia was prepared for his gospel. "God often uses small things for the carrying on of His work. "Happenings which for us seem to be unimportant, may be doors opening into great opportunities. "Individuals in whom we see no promise, may be used of God to bring countless souls to the foot of the Cross. "Efforts which seem feeble in the light of the work to be accomplished, may be used under the blessing of God to overcome the greatest of obstacles. "So one should not be discouraged because we can do little, it may be used by God to do something great. We should not have our mind on the smallness of the thing we can do, but rather we should do what we can, whether great or small, for the glory of God. It is a great sin when we can do little, to be discouraged and do nothing. The servant who was given the one talent was supposed to use it, and he sinned greatly in not using it. Remembrance Day At Kensington

Remembrance Day was fittingly observed in Kensington, by a parade of the Great War veterans, at 10:45 a.m. They arrived at the King George Hall to find the citizens of the town awaiting them in thoughtful silence. Following them came the school children in regular marching order marshalled by the principal, Mr. Norman McDonald and the other teachers.

The Mayor of the town, Mr. J. M. Leard, acted as chairman. At 10:50 the school children gave the Flag Salute, followed by Rev. Mr. Rhoad reading the names of the fallen comrades.

At 11 o'clock there was two minutes solemn silence, while all reverently stood to commune in prayer and in tribute to those valiant souls who gave all, and have gone on before—that we might have peace and liberty. "In Flanders Fields" was effectively given by Rev. Mr. Pream, and the singing of "O Canada" was led by the fresh young voices of all the school children.

Rev. Father Reginald McDonald of Indian River, was then called upon to give an address. He spoke of the debt we owe to those fallen heroes who gave their lives; and not alone to them, but to those, equally heroic, who went forth, not knowing the manner or condition, of their return.

MONTHLY MEETING TOWN COUNCIL

The regular monthly meeting of the Summerside Town Council was held last night in the Council Chamber, Mayor Lidstone presiding. All Councilors were present with the exception of Coun. Carruthers.

After reading of minutes of previous meeting the bills for the month were submitted and approved as follows: Town paid bills \$2,738.58, unpaid bills \$271.81. Electric light paid bills \$300.47, unpaid bills \$730.92. Coun. J. M. Nicholson in reporting for the Finance Committee showed that there was a decrease in expenditure for this year as compared with last year of \$1,026.59. The expenditure from January 1934 to Oct. 31, 1935 was \$60,464.16. Expenditure from Jan. 1935 to Oct. 31, 1935, was \$59,437.47. Coun. Nicholson was also pleased to report that there was an increase in property assessments. This year's assessment for property to Oct. 31st amounted to \$30,521.11. Corresponding period last year was only \$29,019.08. Making an increase of \$1,502.08. The collection of poll tax collected up to October 31, 1934 was \$1879.50, up to October 31, 1935, was \$1892.50. Councilor MacKay in moving the adoption of the finance report, stated he considered it a very favourable and encouraging one.

The police report submitted by Coun. Bishop showed 25 arrests for drunkenness, thefts 10, vagrancy 2, females arrested for street walking 2. Total of 49 arrests. Fines collected \$122.00. Three persons arrested for theft were sent up to Supreme Court and the other seven are serving jail sentences. One female sentenced to one month in jail and the other case adjourned for one week.

An application from Assistant Comm. E. J. Hallett of the Boy Scout Association asking that the Boy Scouts may be allowed to sell apples on "Apple Day" Nov. 16th was granted unanimously. Coun. MacNeill gave an excellent report for the electric light committee. Coun. MacKay reported for parks. Coun. Bishop reported for streets and Coun. Grady for property and fire. Meeting adjourned.

Abbott, formerly of Yarmouth, N. S., is accused of having failed to give proper instructions to subordinates. In addition, he is charged with having left the vessel in cabofat no one.

Cabofat is charged with permitting negligence and violations of law on the part of the company and the officers of the boat. The company is charged with negligence resulting in loss of life on the high seas.

Conviction on all counts of the seven indictments would carry maximum penitentiary sentences of 10 years each for the three men, plus \$10,000 fine each. In the case of the corporation the maximum penalty would be a \$10,000 fine.

Officers on MORRO CASTLE ON TRIAL

(A. P. By Guardian's Special Wire) NEW YORK, Nov. 12—Two officers of the ill-starred Morro Castle went on trial in federal court today charged with criminal negligence in connection with the fire that raked the vessel from stem to stern causing a loss of 124 lives in Sept., 1934.

In addition to the officers, acting Captain William F. Warms and Chief Engineer Eben S. Abbott, the defendants included Henry E. Cabofat, executive vice president of the New York and Cuba Mail Company, and the company itself.



OTTAWA NOT CONCERNED WITH PROTESTS

(C. P. by Guardian's Special Wire)

OTTAWA, Nov. 12—Prime Minister Mackenzie King conferred at length this afternoon with his Ministers of Finance, National Revenue and Trade, presumably with respect to the Canada-United States trade agreement to be signed later this week.

No date has been fixed for signing the treaty but that ceremonial will probably take place Friday or Saturday. The Prime Minister will leave for Washington, it is expected, tomorrow afternoon, arriving in the United States capital Thursday at noon. If there should be any delay in preparation of the treaty text Mr. King will postpone his departure.

Details of the treaty remain a complete secret outside of Government circles, but apprehension as to what it contains has resulted in a considerable volume of protests and appeals for information from many in Canada who fear their interests may be prejudiced.

Officials in Ottawa displayed no concern over the reported move of the United States to challenge the constitutionality of the legislation giving President Roosevelt authority to negotiate treaties such as that with Canada. Some Ministers admitted they had received protests from various interests who were worried by fears the treaty would injure their business, but would not divulge any details of these protests. No answer could be given because of the determination to keep the treaty details from the public until the signatures have been affixed.

Products in Treaty

It is understood these will cover Canadian exports of rough lumber, live cattle, milk products, seed potatoes, fish, nickel and some other commodities in the raw, while the maintenance is guaranteed of the present access to the United States market for pulp and newsprint. The \$3 a thousand duty imposed by the United States on rough lumber is supposed to come off. Similarly, concessions are said to be promised on whiskey such as will enable Canadian distillers to get rid of millions of gallons of those types to which the American palate is particularly accustomed—rye and bourbon.

At this end, the intermediate tariff is believed to be extended to the States on an extensive line which includes iron and steel products, certain textiles, electric and mining machinery, radios, motor car parts and, at least as regards the limitation of discounts, motor cars.

To the agreement neither the consent of Parliament nor of the United States Senate is required. The Government here for years has been empowered to lower duties without reference to Parliament but it cannot raise them save with such sanction. At Washington, the President can make reciprocal agreements for three years, which limitation will make the present agreement unavoidably tentative. While it will go into effect immediately, opportunity for discussion in Parliament will be available even if formal approval is not called for.

Following the ceremony of signing the treaty in Washington Prime Minister King will go to a seaside resort in Georgia or Florida for a week's rest, before returning to Ottawa.

POLICE REPORT

To His Worship the Mayor and City Councilors.

Gentlemen:—I have the honor to submit to you the Police report for month ended October 31st, 1935.

Fifty six arrests were made within the City limits during October under the following classified offences:

Assault on female (wife beating), arrests 1, convictions 1, total 1, 30 days imprisonment.

Drunk in charge of motor vehicle, arrests 2, convictions 2, total 2, 7 days imprisonment and 15 days imprisonment.

Drunk and disorderly, arrests 3, convictions 3, total 3.

Drunk and incapable, arrests 31, convictions 29, dismissals 2, total 31.

Escape from lawful custody (Jail break), arrests 2, convictions 2, total 2. Two years each Dorchester Penitentiary.

Operating motor vehicle while suspended, arrests 1, convictions 1, total 1.

Theft, arrests 2, convictions 2, total 2, 60 days imprisonment and 30 days imprisonment.

Unlawful possession of intoxicating liquor, arrests 1, convictions 1, total 1. \$200 and costs or 3 months.

Taking motor vehicle without consent of owner, arrests 2, convictions 2, total 2, 3 months imprisonment and 30 days imprisonment.

Vagrancy, arrests 10, convictions 8, dismissals 2, total 10.

Operating motor vehicle to common danger, arrests 1, convictions 1, total 1. \$50 or 30 days imprisonment.

Totals: arrests 56, convictions 52, dismissals 4, total 56.

In addition to the above mentioned arrests there were two prosecutions and convictions under the Prohibition Act for unlawful sale or possession of liquor; four for common assault with three convictions and one dismissal; three convictions under the Sanitary By-Law five for non-payment of Dog Tax; one under the City Traffic By-Law for breach of Parking Regulations, and one for abusive language.

On October 22nd the Force collected thirty six samples of milk from Licensed Vendors, delivering same to the City Analyst for test. In connection with the September 1st collection of samples, three of which were found to be two prosecuted vendors from whom three samples were collected appeared before His Honor the stipendiary Magistrate on October 7th, charged under the By-Law respecting Milk and Milk Vendors. A fine of \$5 and costs was imposed in each case. 39 amounts collected in fines and costs during October are as follows:
