—LOADING CARS FOR WESTERN CANADA—The districts of Sherbrook, Linkletter Road, Travellers Rest, Summerside and vicinity are loading a car of vegetables at the east end siding, Summerside, for the dried out areas of Western Canada. The districts of Bedeque and vicinity are loading a car at Read's Corner. There was a big response to the call for help from the West.—S.

—SEA WALLS COMPLETED—The construction of the sea walls at the eastern and western approaches to Summerside are now complete. The work was undertaken by the Summerside Town Council in conjunction with the Provincial and Federal governments as an unemployment measure. The work gave employment to a number of men and has given the sea front a very fine appearance. The work was under the supervision of Mr. Rankin, well known contractor.—S.

—WARREN PAVING CO. COMPLETE WORK—The Warren Paving Company has completed their work for this season both in Summerside and Miscouche. The last piece of paving to be laid by them in Summerside was at the west end and this was completed last Thursday. The paving project between St. Eleanor's and Miscouche has been stopped for the winter months. The Company will be closing their office very shortly until next spring. They have been the means of giving employment to some hundreds of workers this summer as the men have taken turn about. About 90 men were kept employed all the time.—S.

—C. N. R. CASES INVESTIGATED—Mr. A. F. Steeves of Moncton, special investigator for the C.N.R., is on the Island looking into several complaints with regard to rowdiness at different stations. On Friday Mr. Steeves was in Alberton to prosecute some cases which came before Mr. Wilfred Tanton, J.P. There were six young men up before Mr. Tanton charged with creating a disturbance in the railway station. The ringleader, who had been up before the Magistrate before on a similar charge, was fined \$5 and costs. The other boys were let off with a warning and severe reprimand. On Monday morning at Summerside Mr. Steeves prosecuted a number of boys, who had been using the Wellington station in an unlawful manner. These cases came before Magistrate Darby. The lads were each fined \$2.00 and costs or 7 days. Two other cases for a similar offense were adjourned.—S.

—EXCISE CASES—The Summerside detachment of the R.C.M.P. prosecuted several excise cases over the weekend. On Saturday two Summerside parties appeared before Magistrate Darby charged with offences against the excise act. Both were found guilty; one was fined \$25.00 and costs or one month, the other \$35.00 and costs or three months. On Monday morning another Summerside man was found guilty of an offence against the Excise Act and received a twenty-five dollar fine or two months.—S.

Mr. Perry was a native of Summerside and most highly respected in the community. He has always been hardworking and thrifty and says any one can make a living on the land if he wishes. He does not believe in the dole. He thinks it is undermining the morale of the youth of today. Before trapped workers in the factory had time to run for their lives, the Gendarmes said, a shower of flaming shrapnel struck the roofs of other storehouses and the factory itself, causing quick successive explosions.

Flaming Ruins
Within a few minutes the buildings were a pile of flaming ruins. Chimneys were knocked down and windows were shattered all over the town. Rescuers dug into the wreckage dragging out body after body as the little town in a few hours was turned into one large hospital. Victims included Pierre la Rocque, manager of the factory, and several powder experts.

Mayor Injured
Among the injured was the Mayor of Saint Chama, struck by hurtling debris 200 yards from the scene. Thousands of curious were kept a mile away from the scene by Gendarmes. The Mayor said a watchman first discovered fire in one of the storehouses in which special explosives were stored. For quickly spread to the factory itself, while two miles away workers in the powder works office building were trapped in debris when the ceilings caved down from the force of the explosion.

Death Stays Hand Of Writer

CAMBRIDGE, Mass., Nov. 16.—(47)—Illuminating gas cut short a Harvard graduate student's letter to his parents today as he recorded the numbing effects of what he did not suspect was death itself.

John R. Meltzer, 23, of Chicago, was found slumped in a chair in his room, the unfinished letter before him and two gas jets in a nearby stove open. Over one of the jets was a pan of skin milk, on the other a pan of bacon. A medical examiner said death was accidental.

Meltzer had begun his letter: "Dear Folks—My apartment is very nice except there always seems to be an odor of gas about... this a. m. I feel very sleepy and can hardly stay awake to finish this letter. I am very happy and content here and inclined to be a bit gay."

Major Heridge told the Canadian Club, "to abate their material woes, will play with that which through the long past they fought so hard to gain—their freedom." Poverty and discontent obeyed one law. "We are mad to think that Canada lies beyond the scope of it. We will follow where Europe leads if poverty and discontent continue here. The price of freedom is our capacity now to recognize this fact."

Co-operation by the state, which he termed "the modern counterpart of free competition," is Major Heridge's alternative to radical or reactionary dictatorship. We would make democracy serve this end and so survive. There were two schools of thought on the issue of recovery through economic reform. The first believed in laissez-faire, the old internationalism, the invariability of the monetary system, unregulated business, non-intervention of government.

Those of the second group believed that under the methods of "the old economy" the industrial machine could not operate effectively now, that in its rapid development the principle of free competition has been left behind, the old checks on prices, wages, costs, left behind.

"I belong definitely to the second group," said Major Heridge. "I believe that the principle of laissez-faire has served its purpose well and that with appropriate acknowledgements we should bid it good-bye."

The old remedy of export trade for an afflicted domestic economy was not now available. Trade should move therefore in obedience

Girl Guides in Summerside

A very interesting and enthusiastic meeting was held in St. Mary's Hall, Summerside, on Wednesday evening, November 11th, when Miss Mona Wilson, secretary-treasurer of the Girl Guides Association, along with Miss Fry from Charlottetown, gave a short talk on the Girl Guide movement, which started in England in 1907, with Lord Baden-Powell; the Girl Guide Association being formed in 1910 with Miss Agnes Baden-Powell as its first President.

There are now over one million, four thousand Girl Guides in the world, and forty-five thousand in Canada alone—girls of all nationalities, creeds and types, and yet one and all, sisters through the Guide Law.

While Miss Fry explained some of the Girl Guide work to prospective Guides, the local association was formed with Miss Carrie Holman President, and Mrs. Thane Campbell Secretary, and Mrs. George Hogg, Miss Mary Hunt and Mrs. Alex Home as executive.

The Girl Guides Association is for girls from the ages of twelve to sixteen, and it is also anticipated that a group of "Rangers"—a class for girls over sixteen years of age, will be formed in the near future.

This is a wonderful movement and it is hoped that the Company in Summerside will be well organized within the next two weeks with Miss Rosamond Richardson, Captain, and Miss Adele Parkman, Lieutenant.—S.

SMALL DEATH CASE AGAIN BEFORE COURT

Attempt Made To Show Widow's Complicity in Disappearance

(C. P. by Guardian's Special Wire)
TORONTO, Nov. 16.—Battle for the \$2,000,000 estate of Mrs. Theresa Small developed an open declaration on one side today that an attempt will be made to prove Mrs. Small conspired to cause the death of her husband, Ambrose Small, wealthy Toronto theatre owner who disappeared in 1919. While the presiding judge himself remarked it was the dead Mrs. Small who was on trial, an action opened in non-jury sittings before Mr. Justice Nicol Jeffrey to prevent distribution of the estate, bequeathed to charity and the Roman Catholic Church upon Mrs. Small's death a year ago. Mary Florence Small, contending her brother's estate was obtained by Mrs. Small through fraud and perjury and that therefore the widow had no right to it, would share the original estate with her sister in the event the present action was successful. Before adjournment was made until tomorrow, two witnesses testified they were approached shortly before Small's disappearance by John Doughty, the theatre magnate's secretary, and invited to join a plot to murder Small. Both said they refused and one said he considered the proposal a joke at the time. When Frederick Osborne, caretaker of the Grand Opera House, Small's principal theatrical property, started to relate how Doughty invited him into a plot to murder the owner, Mr. Justice Jeffrey ruled his evidence could link Doughty with an offence and could not indirectly link Mrs. Small. Osborne said he quit his job refusing to have anything to do with the plot. Doughty, he said, admitted being "intimate" with Mrs. Small. Thomas Shields, 70 years old, said he witnessed "quite an argument" in the Grand Opera House basement the night before Small was reported missing. He had gone there with James Cowan, manager of the theatre, for a drink. Doughty and Small, he testified, argued heatedly, Doughty threatening to throw Small in the furnace. "He repeated it two or three times," he said. Fred T. Deville testified he didn't take it seriously when Doughty "made a proposition to me to do away with Mr. Small." Money wasn't mentioned, Deville said he had program privileges at the Grand Opera House. A newspaper reporter, Roy Greenaway of the Toronto Daily Star, said he interviewed Mrs. Small five years before her death regarding her theory of her husband's death or disappearance. Britain To Protect Home Manufacturers

LONDON, Nov. 16.—British manufacturers of coronation goods will be protected from foreign competition by the imposition of 100 per cent ad valorem duties between Dec. 15 next and July 31, 1937. The import duties advisory committee, in issuing the order, stated the tariff would apply to articles of all kinds suitable for use in connection with the coronation or as souvenirs.

PROPOSE BAN ON UNIFORMS

LONDON, Nov. 16.—The proposed ban on the wearing of political party uniforms in Britain is not aimed at the British Fascist Party alone. Home Secretary Sir John Simon declared today in moving the bill's second reading in the House of Commons. The measure was approved on second reading after several hours of debate.
