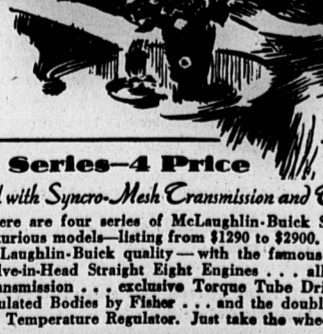

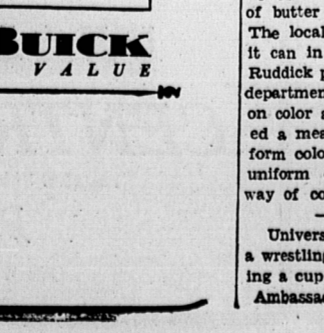

DOMINION OF CANADA Income Tax Returns Due April 30th

All persons residing, employed or carrying on business in Canada, are liable to a tax on income, subject to the following exemptions:

- (a) \$3,000 in the case of a married person or head of household, or any other person who has dependent upon him any of the following persons: (i) a parent or grandparent; (ii) a daughter or sister; (iii) a son or brother under 21 years of age or incapable of self-support on account of mental or physical infirmity.
