taken to the police.
Another three-motored plane
two hours later struck a rock near
the Swedish town of Uddevalla and
burst into flames.
On land, the Germans were said
to have scored small advances on
the southern tip of Norway.
The towns of Fredrikstad,
Sarpsborg and Halden.
Halden is on the Swedish border
and was reported to have fallen
under German control. The Ger-
mans were said to have entered
the town of Alesund, half way
up the Norwegian coast from
Bergen to Trondheim, which was
reported between six British warships
and German planes. The British
ships were said to have entered
the port of Alesund without suffer-
ing damage.

The Narvik Battle

Here is the Admiralty's calmly
worded story of the Narvik battle:
"Since the attack upon German
destroyers in Narvik on Wednes-
day by the second destroyer flotilla,
this flotilla, with reinforcement
of British destroyers, has been
keeping the German fleet in the
vicinity of Narvik fjord.
"This morning, about noon
H. M. S. Warspite, accompanied
by a strong force of destroyers
using minesweeping and other ap-
pliances, advanced up the fjord to
attack the German destroyers,
some of them already damaged,
who were sheltering in the har-
bour, and also to engage any shore
batteries which might have been
erected.
"According to reports which have
been received from the command-
er in chief, Vice Admiral Whit-
worth, hoisting his flag in the
Warspite, the German attack,
which was extremely successful,
"Enemy opposition was not found
to be remarkably severe.
"A field howitzer which had
been mounted ashore was put out
of action by the fire of H. M. S.
Cossack.
"Four German destroyers were
sunk and sunk in Narvik bay.
"One of the German destroyers,
a small inlet, eight or nine miles
behind Narvik town.
"These also were pursued and
destroyed.
"At the moment of issuing this
communiqué, the Admiralty is not
precisely informed as to condi-
tions in Narvik town.
"Parties of men, possibly Ger-
man soldiers, have been seen es-
caping from over the hills and
further details are awaited.
"This destruction of seven of
the enemy destroyers was not
achieved without some loss. Three
British destroyers were damaged
in the fight, but not seriously.
The British loss of life is believed
to have been very small.
"An estimate can be made at
present of German losses in per-
centage of the seven destroyers
sunk must have counted over 1,
600 men."

Admiral Congratulated

"The admiralty has signalled con-
gratulations to commander-in-chief
Admiral Sir Charles Forbes, and
Vice Admiral Whitworth, and to the
officers and men engaged in this
victorious, daring and skilfully con-
ducted operation, which will tend
to clarify the situation on this part
of the Norwegian coast."
"Operations are still proceeding."
An admiral's report said
that two officers and 14 men were
killed when the crew of the destroy-
er Hardy landed from their disab-
led and beached ship.
The first battle of Narvik last Wednes-
day, two other men were missing
and believed drowned and six men
were wounded.
Captain B. A. W. Warburton-Lee,
who led the flotilla to the attack,
was reported killed.
The Hardy was disabled by Ger-
man guns and was run ashore by her
own crew before they landed.
While the laying of the Baltic

OTTAWA, April 14—(CP)—
Humor rises high with Canada's
soldiers and if there are those who
doubt it the proof lies in the breezy,
regimental publications on file at
Defence Headquarters, some of them
carrying covers from 1914-18 and others
struggling young sheets born of this
new war.
That historians of the future may
check back and find that the soldier
of today has his light-hearted mo-
ments and moods, the Canadian Active
Service Force newspapers are filed in
the Defence Department. They con-
tain poems, stories and cartoons, all
designed to break the monotony of
soldiering.
Typical of these is the "Last
Post", published by the 7th Field
Company, Royal Canadian Engi-
neers, at Toronto. Its "Snooping Re-
porter", a regularly featured writer,
became so candid the column finally
was topped with the note: "The edi-
tor cannot accept responsibility for
any items appearing in the Snoop-
ing Reporter, starting with this issue."
"The Dial Sight," a clever 30-
page paper, mimeographed by the
Westminster Regiment of New
Brunswick, concentrates on the
more of cartoons and poetry. A

signed "Soldier's Dream" depicts
