**INCOME TAX RECEIPTS**—Income tax revenue paid by citizens of Charlottetown last year, according to figures published in the National Revenue Review, amounted to \$40,314.46.

**RETURNED FROM BOSTON**—Mr. Joseph Higgins of Kensington returned from Boston on Friday night. While on his visit to the grand old city, Mr. Higgins visited many of the places of interest, not the least among which was the great fish pier and tower 535 ft. in height at South Boston. **AYRSHIRE CLUB**—The P. E. Island Ayrshire Breeders' Club, which has always been working in the interest of the breed, intend to go a step further than usual this year. They are asking that all pure bred Ayrshire cattle which their owners wish to dispose of, be listed with the club so they can be in a position to give intending purchasers the information they require. Large numbers of pure bred cattle have been sold off this Island during the last two years. Many of these could have been introduced into new herds here as foundation stock. The breeders who have been disposing of their surplus stock feel that this is an injustice, to the breed here as well as to the Island by shipping these animals to the United States where the majority of them go. The cattle were sold at a reasonable figure and most farmers desirous of improving their herds, could well afford to have purchased such stock. The club desires to assist all breeders of pure bred Ayrshires to dispose of their surplus stock and to assist intending purchasers to secure the best stock procurable. **DEATH OF WELL KNOWN SUMMERSIDE LADY**—The death occurred on Friday night of Miss Elizabeth Katherine Clark (known to her many friends as Miss Libbie) at the home of her sister, Mrs. George Warren. Miss Clark had been in failing health for some time, but did not take to her bed until a few days before her death. She was the daughter of the late Mr. and Mrs. John Clark of Tryon and is the last but one of seven sisters; four brothers also predeceased her. The deceased had been a resident of Summerside for forty years, removing with her aged mother and her sister, Miss Eliza Clark, from Tryon after the death of their father. In Summerside they opened up a boarding establishment which they carried on very successfully for many years and through her kindness and consideration for others Miss Clark endeared herself to a very large number of friends and acquaintances. She was a consistent member of the Methodist Church in Canada, taking an active part in the different societies of the Church. Miss Clark was present at the dedication and laying of the Corner Stone of the Methodist Church, Summerside. Until quite recently she had held important offices in the Missionary Society of Trinity United Church and was also a member of the W. C. T. U. There remains to mourn, one sister, Mrs. George Warren of Summerside, to whom The Guardian extends its sincere sympathy. The funeral took place on Monday afternoon, a short service being held at the house, Rev. J. P. C. **REV. DR. JOHNSON'S DEPARTURE**—Rev. Dr. Johnson, of Knox Church, Ottawa, who came here on Thursday to visit his old friend, Rev. W. Bruce Muir, of St. James Church, and Mrs. Muir, left yesterday morning on return home. While in the city Dr. Johnson, who was the guest at the Manse, went through a full programme, and created a very fine impression wherever he was seen and heard. On Sunday morning he occupied most acceptably St. James Church pulpit, preaching an eloquent sermon which gave help, encouragement and comfort to a large congregation. In the evening he preached to another crowded congregation in Zion Church, and later addressed a crowd of young people in the Y. M. C. A., his addresses being timely and greatly appreciated by the congregations.

**TORONTO, Jan. 13**—Horace H. Beer, aged 65, United Empire Loyalist, descendant and native of Charlottetown, P. E. I., died at his home here tonight following a lingering illness.

He was a former commercial traveller and was known from coast to coast. Surviving are his widow, one son, George B. Beer, three brothers, Col. Louis H. Beer, Ottawa, Arthur L. of Vancouver, and E. H. Beer, of San Diego, California.

(The late Mr. Beer was a son of the late George R. Beer of Charlottetown. He was for many years a resident of Summerside though his calling of commercial traveller, took him to many parts of Canada. For a number of years he had been making his home in Toronto and travelling through the province of Ontario. Over a year ago he was severely injured in an automobile accident in Toronto and his death no doubt, was hastened by that accident.)

Mr. Beer was a man of fine qualities and a very wide circle of friends both within and without this province will learn with regret of his passing.)

A telegram from Vancouver, announces the death Tuesday morning of Frederick Perkins, formerly of Charlottetown. Mr. Perkins was in his 81st year and up to a few months ago, was in the enjoyment of excellent health.

A member of an old Charlottetown family, Mr. Perkins was the son of the late Hugh Perkins who was for some time a coal merchant in this city. At an early age Mr. Perkins, with his brother, the late C. B. Perkins established about 1870, the business of Perkins Bros. On the retirement of his brother, the late Mr. A. W. Sterns joined Mr. Perkins, and for many years they carried on, with conspicuous success, the dry goods business of Perkins & Sterns, taking into partnership in 1888, Mr. G. M. Moore, now President of Moore & McLeod Ltd., finally in 1893 selling out to Messrs. Moore & McLeod.

Some years later, the business was re-established on the north side of Queen Square, with the erection of the building now occupied by Messrs. Holman's Limited. After some years Mr. Perkins and family removed to Edmonton where associated with his son Charles, a very successful mercantile establishment was conducted, until for reasons of family health a further removal was made to Vancouver, where he resided until his death today.

Mr. Perkins' wife was Miss Jane Duncan who died some years ago. To them were born two sons, Charles and Sydney, who have passed away, four daughters, Ella, Alice,

Winnie and Jean now resident in Vancouver.

Mr. Perkins was for many years a member of the Presbyterian Church. While resident in Charlottetown he was a useful worker and generous supporter of St. James. He was a man of many warm friendships, a keen aggressive business man, honorable in all his dealings, of bright intelligence, wide interests, a gracious kindly Christian gentleman.

**DOMESTIC SCIENCE SHORT COURSE**—The Domestic Science short course conducted by the Women's Institutes began yesterday in Prince of Wales College with twenty young ladies from all over the province attending each of the day and night classes. The teaching staff is as follows:—Miss Katie Flynn, millinery; Miss Ferguson, sewing; Misses McPhail and Hazard, cooking; Miss Mona Wilson, home nursing.

**MONTAGUE CHILDREN INOCULATED**—On Wednesday afternoon in the Montague School a clinic for inoculating the pupils against diphtheria was organized by Miss Vickerson, Red Cross nurse. Drs. McIntyre and Grant gave the first inoculation to 127 school and 12 preschool children. This represents a splendid proportion of the pupils, being 79% of the number enrolled. Miss Mary Martin and the teachers were of great assistance during the clinic.

Col. H. C. Sparling, D. S. O., Halifax General Staff Officer for Military District No. 6, who arrived in the city yesterday to inspect the school of artillery, states with regard to the recent statement that Maritime Units may drill in Charlottetown in 1930, that the proposition is premature as all previous examinations show that there is no suitable area on the Island on which to carry out tactical military training, and no definite plans have been made. The camp grounds at Aldershot are several miles long, and even there, larger space could be utilized to good advantage. The Island Units will train in Charlottetown, beginning probably on June 30th, Col. Sparling says, but it is very unlikely that any units will come over from Nova Scotia or New Brunswick.

The annual meeting of St. Peter's Cathedral was held in the Schoolroom on Monday, Jan. 20th.

The report of the Priest Incumbent showed that 1929 had been marked with some very interesting events. The Diamond Jubilee of the Cathedral was held in July, the closing services of the Church Army Crusade were held at St. Peter's in July. In November a ten day's Mission was preached by Rev. Father Turney, S. S. J. E., and the Rev. W. J. Phillips of Alberton Parish was ordained to the Priesthood by His Grace, the Archbishop of Nova Scotia. The first ordination service to be held in the Province for 25 years.

The report of the Warden and Treasurer showed the Cathedral to be in a good condition financially, over \$8,000.00 having been raised for all purposes.

All the officers were re-elected. Votes of thanks were tendered to the various officers and especially to the ladies.

**HALIFAX, N. S., Jan. 22**—The steamer Hochelaga has been given a long term contract by the Federal Government to operate on the Picou-Charlottetown route, her owners announced today. The Hochelaga has been engaged in the Island service during the navigation season for the past six years. Improvements costing \$40,000 will be completed before the steamer resumes the route in May.

The death of Mr. Augustus Hurry occurred at his residence, West Royalty on Sunday morning last after an illness of several months duration. He was still a comparatively young man, a most progressive farmer and was known as a hard and indefatigable worker. He is survived by his widow, formerly Miss Minnie Stockman of Highfield, and a family of the children Pearl, Charles, Stanley, Hazel, Lillian, Lorne, Laura, Henry Mildred and Bertha. Mr. Henry Hurry of Central Royalty and Mr. Jas. Hurry of West Royalty are the only surviving brothers. An only sister died in California about a year ago. To the bereaved family circle the sympathy of a wide circle of friends is being extended. The funeral services from his late residence in Highfield cemetery were held on Thursday afternoon last and were conducted by Rev. G. A. Grant of the United Church. The funeral proceedings were under the direction of Mr. Neil D. MacLean of Charlottetown and the following acted as pall bearers: Patrick and Joseph Curley, Archibald Duffet, Russell and Frank Bell, Victor McWilliams.
