"Ernst, as he turned toward the squad, cried 'I am innocent!'"

The eye-witness said men with meritorious records were given the privilege, as was Ernst Roehm, of committing suicide, but few, he said, accepted.

Hitler's Alternative "The execution of one storm troop leader named Ehrdt was held up momentarily by the arrival of a man from Chancellor Hitler," he said, "giving him the right to choose suicide or the firing squad."

"Ehrdt, an aviator, held the highest military decoration and for this the Chancellor extended the favor. But Ehrdt refused to shoot himself, proclaiming he was innocent."

Saw Sixty Shot After having seen 60 shot, intimating that many more than that fell in the cadet school, the eye-witness said the strain of the ordeal caused him to leave.

Another eye-witness described the circumstances of General Von Schleicher's death and that of his wife in their home near Babelsberg, the Hollywood of Germany.

This man said a motor bus stopped in front of their home and marched into the house.

"Later," he said, "I heard shots, and shortly after that the storm troopers came out."

The eye-witness who told of the Von Schleicher slaying was an officer of the old army in high command. He too, whispered his story after being reassured that no eavesdroppers were listening and that his story would not be disclosed in Germany.

Epoch - Making Session Of Federal Parliament Now Drawing To A Close

Five Months Of Intensive Activity At Ottawa Resulting In Heaviest Programme Of Advanced Legislation Of Any Session In Canadian History Reviewed By The Canadian Press.

(By C. R. Blackburn Canadian Press Staff Writer) OTTAWA, July 2—Members of Canada's 17th annual parliament since Confederation are relaxing in contemplation of relief from five months of toil that has produced perhaps the heaviest programme of advanced legislation of any session.

New laws and regulations, when proclaimed, will reach deeply into the lives of every citizen of Canada, affecting their mode of conducting business affairs, their franchise and their financial status, and if the hopes of the Government are fulfilled, will bring a measure of prosperity and stability.

The session brought some lightening of taxes for the masses, and some increase for those considered able to bear it, resulting in an estimated surplus of ordinary revenue from ordinary expenditures of \$8,000,000. But this does not take into account extraordinary expenditures such as unemployment relief and railway deficits which contributed largely to the deficit last year of over \$100,000,000.

Important Legislation As a result of legislation passed at the session now ending Canada will possess machinery for the setting up of a Central Bank, privately owned but largely Government controlled; elaborate regulations designed to facilitate the marketing of natural products; farm mortgage debt adjustment legislation based on a common recognition of all concerned that the agricultural producer must be kept on the land in efficient production free from the constant pressure of debts he cannot pay; a \$40,000,000 public works programme for relief purposes; a new and simplified system of compiling voters' lists; a new Companies Act to harmonize the corporation laws of the provinces and the Dominion, imposing amendments to the criminal code, excise and customs acts, and a long list of less important statutory changes and consolidations.

The Senate had its usual crop of divorce bills, nearly 40 for the session, but in addition initiated several important and complicated pieces of legislation including the consolidation of the Canada shipping laws, a monumental task involving the bringing up to date of hundreds of ancient statutes and combining them in one volume. The Upper Chamber also initiated insurance legislation of a highly technical kind and carried out several inquiries in committee.

Tax Burden Lightened A feature of the budget was the cutting in half of the two cents a pound tax on sugar and the application of a tax on gold production to make up the deficiency in revenue. The gold tax is applicable only while the world price of gold remains well above \$30 an ounce as compared with the standard price of \$20.67. Tariff changes were not extensive and amounted comparatively little. Several British preferences were under consideration but changes were made in the schedule as a result of recommendations of the tariff board.

An important decision by the Supreme Court was secured by the Government during the session, the result being that the tariff board was shown of its assumed power to adjudicate points of law. The highest Canadian court found that the board could not settle points of law nor could it over-ride the decisions of the Minister of National Revenue with respect to fixing values for duty purposes. PROVINCE OF PRINCE EDWARD ISLAND ELECTRICAL INSPECTION DEPARTMENT

WARNING TO THE GENERAL PUBLIC

It has come to our attention that several unapproved and sub-standard types of electrical appliances and equipment are being offered for sale in this Province, contrary to the Law.

At present extremely dangerous types of Electric Water Heaters are being sold. These are included in the following list of unapproved heaters and are of two types:

(1) Faucet type, with portable cord, manufactured under the following names: "Tom Thumb Senior," "Tom Thumb Junior," "Alladin," "Hot Shot," "Major," "Vulco."

(2) Immersion type, with portable cord, manufactured under the following names: "Lux-Viel" or "Magic Disc," "Mystool," "Alladin," "Wonder," "Jiffy," "Bestever," "Kwik," "Comer," "Hot Donut."

Persons having purchased any of these types of heaters are requested to advise the Royal Canadian Mounted Police, or the Provincial Electrical Inspector.

To the sellers of unapproved appliances and equipment we draw attention to Rule 4 of the Rules and Regulations of The Electrical Inspection Act 1932:

4. "All electrical equipment used in electrical installations or offered for sale in this Province shall be "approved" within the meaning of the Code, it being understood that such word "approved" means that such equipment has been submitted for examination and test to the Laboratories of the Hydro-Electric Power Commission of Ontario or to the Underwriters' Laboratories of Chicago, or to a recognized Canadian Government Laboratory, and has been approved as suitable for sale and use. Notwithstanding such approval any electrical equipment may be rejected at any time by an Inspector if in his opinion such equipment is below standard, or not used for the specific purpose for which it has been approved."

Persons refusing or neglecting to comply with the provisions of this Rule are offenders and are liable to prosecution under The Electrical Inspection Act 1932.
