Howie Morenz Is Leading Scorer.

HEADS NATIONAL LEAGUE PACK
 WITH SEVEN GOALS AND
 ONE ASSIST

MONTREAL, Que., Dec. 2.—While
 the world champion Canadian hock-
 ey team has not been able to se-
 cure the leadership in the Canadian
 section of the National Hockey League,
 thus early in the race, the title-
 holders can derive some satisfaction
 from the fact that in the first of-
 ficial list of scorers, issued from the
 offices of President Frank Calder,
 their centre-ice ace Howie Morenz,
 is leading the snipers of both sec-
 tions. The meteoric star of the
 French-Canadian club in six games
 has compiled seven goals and an as-
 sist, for a total of eight points.

It is a coincidence that in the Amer-
 ican section the leading sniper
 should come from the Boston Bruins,
 the team which set a series of start-
 ling consecutive-victory records last
 season, and played off with Canad-
 ians at the finish for the world's
 title. "Dit" Clapper, robust right
 wing of the famed dynamite trio of
 the Bruins, is the leader in this sec-
 tion, with five goals and two assists.
 Behind him no less than five players
 are tied with five points each, these
 being Johnny Gottselig, of the sen-
 sational Chicago Black Hawks, Bill
 Cook and "Butch" Keeling, of the
 New York Rangers, Ralph "Cooney"
 Welland of the Bruins, and Herbie
 Lewis, of Detroit Falcons.

THE MARKETS
 (Canadian Press)

OTTAWA, Ont., Dec. 2.—The situ-
 ation on Canadian egg markets
 with respect to fresh eggs is prac-
 tically unchanged, but there is an
 easier tone to the storage market.
 Toronto brokers report sales of local
 fresh eggs at extras 58-60; firsts, 54;
 pullet extras, 47-48; seconds, 30, de-
 livered. Dealers are quoting country
 shippers for ungraded eggs, extras,
 55-58; firsts 50-52; pullet extras, 45-
 48; seconds, 29-30, delivered. Stor-
 age eggs are weak, particularly sec-
 onds with Ontario packers offering
 28 delivered. The poultry market is
 weakening with dealers paying for
 turkeys delivered, 21-28.

MONTREAL.—Egg receipts here
 today were 1,877 cases, as compared
 to 1,119 cases on the corresponding
 day last year. This egg market is
 firm and active under a good de-
 mand. Strictly fresh B. C. eggs are
 selling on spot, extras, 60; firsts, 55;
 seconds, 48, stored. Stocks are sell-
 ing slowly.

ST. JOHN.—Prices on this egg
 market remain about the same, al-
 though receipts are low. Dealers are
 quoting country shippers, extras, 58-
 61; firsts, 48-54; seconds, 34-38.
 Poultry receipts are increasing rap-
 idly, but the market is irregular with
 no set prices established yet.

HALIFAX.—Fresh egg receipts on
 this egg market are light, but show-
 ing an increase over the previous
 week end. There are no changes in
 prices for fresh stock, but storage
 eggs are somewhat easier. Dealers
 are quoting retail for this class
 firsts, 37-39; seconds, 30-35.

CHICAGO.—Spot, 36, Dec. 18th.

MONTREAL, Que., Dec. 2.—Ex-
 ports of cheese from Montreal to
 Newfoundland and the West Indies
 for the season were 885,980 pounds,
 an increase of 241,315 pounds, as
 compared with last year's exports.
 Exports of butter were 296,996
 pounds, a decrease of 53,200 pounds
 from last year. Butter and potatoes

Summerside Supreme Court

(Special to the Guardian)

SUMMERSIDE, Dec. 2.—The case
 of the King vs McDougall charged
 with breaking and entering and
 stealing three silver foxes from the
 ranch of Mr. Alban Strong, was re-
 sumed on the opening of the Sup-
 reme Court at Summerside on Tues-
 day morning. Five witnesses were
 examined for the Crown.

W. A. Hearn who lives in the loca-
 lity of Mr. Strong's fox ranch test-
 ified to having seen the prisoner in
 that vicinity on more than one oc-
 casion. Mr. Ray Tanton was called
 and gave evidence that the foxes ex-
 amined by Mr. George Cameron
 were the foxes that had been taken
 from Mrs. Delaney's ranch and plac-
 ed by the Magistrate in his own
 ranch. He valued the foxes at \$1.5
 a piece.

Officer Linkletter testified to hav-
 ing searched the ranch of Mrs. De-
 laney under a warrant and found
 the foxes described by Strong as his
 own. Mrs. Delaney gave evidence that
 she was with Pritchard when he
 bought the foxes from McDougall.
 She agreed to ranch the foxes for
 Mr. Pritchard on certain terms. Fred
 Pritchard gave evidence that the
 prisoner had brought the foxes to
 his house one night in a bag. He
 wanted \$25 a piece for them, but he,
 the witness, thought they were only
 worth \$25 for the three, and offered
 to give him that much for them and
 a pup in the spring. The prisoner
 finally took \$10 with a promise of
 \$15 later on. Mr. Pritchard then
 took them over to Mrs. Delaney's
 ranch as he had no pen for them.
 That closed the case for the crown.

The prisoner who pleaded not guilty
 at the commencement of the trial
 offered no evidence, thereupon Mr.
 C. D. McCallum acting for the At-
 torney General, who was absent, dis-
 tressed the jury for the Crown. Mr.
 E. H. Strong, K. C., counsel for the
 defense, pleaded for the prisoner.

Mr. Justice Saunders in address-
 ing the jury reviewed the evidence of
 the Crown witnesses. In regard to
 the reference of counsel for the de-
 fense as to the evidence being only
 circumstantial, His Honor said that
 sometimes the evidence was so strong
 that it was as if you had the posi-
 tive evidence. It is not reasonable
 to suppose that the prisoner came
 by the foxes honestly when he was
 willing to sell them for \$25. In sum-
 ming up, the Judge charged the jury
 to give the prisoner the benefit of
 the doubt if they had a reasonable
 doubt in their minds that he was
 not the guilty party.

The jury after being out a short
 time returned a verdict of guilty
 against the prisoner. The court op-
 ens at 11 o'clock this morning when
 the case of Pritchard and Delaney
 will be called.

 Green Mountains were shaded five
 cents a bag on the potato market,

 and \$1.10 for mountains per 90 pound
 bag. The cheese market was un-
 changed. Ontario being 12 to 12 1/2
 cents and Quebec 11 1/2 to 11 1/2
 cents a pound. Receipts were 844 boxes.
 Prices on the cheese markets were
 unchanged. Carlot prices for fresh
 extras were 60 cents, fresh firsts, 55
 cents, and fresh pullet extras 50
 cents. Receipts were 1,877 cases.

—REMOVED TO NEW BUILDING
 Mr. J. E. Dalton, proprietor of Gour-
 lies Ltd., moved into his new quar-

 1916. The fire at that time burned

council was expressed in a letter
 from His Honour read by Mr. Rog-
 ers.

TRUSTEES' REPORT

The following in part is the mem-
 orandum relative to the deciding of
 a site for the new hospital presented
 by Mr. W. K. Rogers, Chairman of
 Trustees:

This meeting has been called ac-
 cording to a resolution passed by the
 Board of Trustees at the beginning
 of the Campaign to raise funds for a
 new hospital.

Two years ago it was decided that
 when the new hospital was built it
 should be erected on our own prop-
 erty near the present hospital. This
 decision was arrived at after every
 opportunity had been given to secure
 a new site at figures within the
 reach of the hospital finances and
 only when a special committee, the
 members of which were all outside
 the Board of Trustees, had made an
 exhaustive study of the situation and
 reported it was not possible to secure
 a new site that would be within our
 means. Since then, the situation has
 changed and a most desirable site is
 now obtainable at a very reasonable
 price.

SPECIAL COMMITTEE APPOINT-
ED

The Trustees wish to as fully as
 possible give to this meeting all of
 the facts bearing on the present sit-
 uation. At the annual meeting of the
 hospital held on May 29th, 1928, it
 was decided that we should build a
 new hospital instead of remodelling
 the old one but that the question of
 the site for such new hospital be left
 to the Trustees and a special com-
 mittee. This special committee con-
 sisted of Mr. W. F. Tidmarsh, Dr.
 Pethick, Dr. Yeo, Mr. Isaac Carter,
 Mr. G. P. Hutcheson, Mr. Justice
 Hazard, and Mrs. J. A. Mathieson.

As the Trustees had previously
 thoroughly canvassed the situation
 they decided that it would be better
 for the special committee to work
 together without assistance or influ-
 ence on the part of the Trustees and
 on July 5th at a special meeting call-
 ed for the purpose this committee re-
 ported back that the only site they
 felt suggesting was the property
 owned by Mr. J. D. Stewart,
 situated on Kent Street, the total
 cost of which would be \$17,500. The
 committee, however, appeared doubt-
 ful about there being enough land
 for our requirements and suggested
 that additional land consisting of the
 Lowe property adjoining might be
 purchased at an additional cost. No
 estimate of the cost of this addi-
 tional property was given. It would
 appear that the committee were not
 unanimous in recommending this
 property because Mr. Justice Hazard
 moved as an amendment that the
 new hospital should be built on the
 site of the old one and, after both
 motion and amendment were thor-
 oughly discussed by the meeting, the
 amendment presented by Mr. Justice
 Hazard was carried with only one
 dissenting vote.

SITE SUGGESTED

There the matter rested until this
 year when the recent Campaign for
 \$250,000 was started and we had not
 gone very far in organizing this
 Campaign before the desirability of
 the site selected was questioned. The
 Trustees have always maintained an
 open mind regarding this question

of site and, when we were informed
 that the situation had changed since
 1928 and that the Provincial Govern-
 ment were now prepared to sell us
 a property consisting of nearly six
 acres facing on Brighton Road and
 at the back of old Government
 House, we at once agreed to re-open
 the whole question of site and sub-
 mit it to a special general meeting
 of those interested in the hospital,
 such meeting to be held immediately
 after the close of the Campaign and
 three weeks' notice of said meeting
 to be given in the press.
