Huben said he had sent the young man to the City Hall where he had been arrested several times, the young man having been arrested on a charge of carrying liquor. He did not expect to make convictions on that money; it was to treat friends at the hotel or on parties. He had no objection to liquor to officers of the law, but had treated one officer of the law with illegal liquor and had also treated a man at the jail to a glass of beer. Questioned concerning notes on a visit to a place late in May the witness said he had the sheets at home. He went to locate them but reported later he could not find the papers. They were destroyed or lost, while the other cases too far back. He had never seen to his knowledge any minister of the Government at a time when he had been in the city. He had seen them at other places where there was liquor. The case was further adjourned. In the afternoon two prohibition cases were heard before Magistrate Tweedy. One was adjourned until October 12 while the other will be continued today. Under cross examination Huben, testifying for the Crown, told that he had destroyed notes in connection with two cases at Summerside. At least he had destroyed some of the notes, declaring they were of no further use as the cases had been dropped. Apparently he had overlooked some of the notes in his book in connection with the Summerside cases, he explained, when asked why some memoranda concerning the cases under discussion still remained.

Dr. George Hilton Honored By Conferees—As tangible tokens of the high esteem and respect of his staff and associates throughout Canada, Dr. George Hilton, V. S. H. A. R. C. V. S., D. V. M., who is retiring from the position of veterinary director general, Dominion Department of Agriculture, on Friday, September 23, was presented with a grandfather clock and a travelling bag and dressing case. The presentation was made in behalf of the staff by Dr. G. S. H. Barton, deputy minister of Agriculture who referred, prior to making the formal presentation, to Dr. Hilton's long, distinguished and unblemished service as head of the health of animals' branch. "Dr. Hilton's outstanding career has been a contribution that has given the Civil Service of Canada an enviable status," said Dr. Barton. Continuing the deputy minister referred to the exacting requirements that were connected with the position of veterinary director general and he said that those who have been associated with Dr. Hilton know of his strong convictions, his fearlessness, his fairness and his good judgment. The health of animals' service is held in high esteem, not only throughout Canada but in many other countries of the world. It is a service that has saved the Dominion millions of dollars, and have given to those countries which have been associated with it an incalculable measure of security and advantage.

FRANCE STILL ANXIOUS FOR RUSSIAN AID

DISCLOSURE OF FLANDIN-HITLER EXCHANGE Causes Uproar in Committee.

PARIS, Oct. 6 (AP)—Foreign Minister Georges Bonnet intimated tonight before the Foreign Affairs Committee of the Chamber of Deputies that France still wants the Soviet Union's big army on her side despite any agreement she may reach with Germany.

It appeared, however, that the French and British governments had ruled against exclusion of Russia.

Lack of British Documents Slows Down Inquiry

OTTAWA, Oct. 6 (CP)—Inquiry into the British War Office's refusal to order for 15,000 Bren light machine guns from the Royal Small Arms Factory at Enfield, England, to 10,000 based upon placing additional educational orders with other sources was passed on to the Canadian D. P. of National Defence by Major James E. Hahn on Dec. 10, 1936.

The letter was one of many passing between Major Hahn and the department in the fall of 1936 which were laid before the Commissioner, Mr. Justice H. H. Davis, today. Over the protest of Lieutenant George D. Hahn, whose magazine article criticizing the British contract led to the inquiry, proceedings adjourned three quarters of an hour early in the hope permission would be received from London to produce additional documents tomorrow.

Adjustment took place as General LaFleche in his story reacquainted the public with the evidence of Lieutenant M. P. Jolley, of the defence department, the first witness, started nearly two weeks ago. That was the admission by Major Hahn of his part in the contract for the Bren gun, the departure on Dec. 23, 1936.

Previous evidence traced the negotiations from that date down to the signing of the contract on March 31, 1937. When General LaFleche took the stand he started with the document's first interest in the Bren gun, about 1932, and in detail from his first meeting with Major Hahn in October, 1936.

It was shortly after that that Major Hahn went to England armed with letters of introduction to Hon. Vincent Massey, Canadian High Commissioner to seek information from the British authorities on the manufacture of the gun.

Examination orders, General LaFleche explained, were orders given to bring a new plant into production and on which experience had to be gained before standard full production was reached. Mr. Justice Davis indicated he expected the British War Office would consent to the use of documents to which it was a party which were relevant to the inquiry. If it did not consent within a few days he proposed to "act quickly" but did not indicate what he would do, if on Oct. 11, Drew Minister Macleod ask Prime Minister Mackenzie King for additional powers.

The Judge said he was entirely satisfied the Canadian Government had made every effort to obtain permission to use the documents and thought there was no necessity of asking additional powers at the moment.

Surviving Mrs. Byrne are a son, Raymond Byrne of Lynn and three grandsons, Raymond, Robert and Norman Byrne.

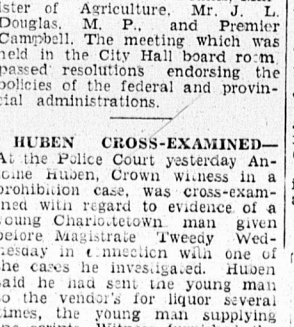
The funeral was held from the A. W. St. Laurent funeral home, 527 Western Avenue, Monday morning at 9 o'clock.

Currencies

NEW YORK, Oct. 6 (AP)—Leading European currencies fell back narrowly in terms of the United States dollar today. In quiet foreign exchange dealings the pound sterling dropped 3-4 of a cent to \$1.39 1/4 and the French franc, .00 1-4 of a cent to 2.08 3-8.

The Canadian dollar dropped 1-32 cent to a discount of 11-16. The guilder lost .04 of a cent and the belga .02 of a cent while the Swiss franc was unchanged.

MONTREAL, Oct. 6 (CP)—The Pound Sterling declined 5-16 cent to \$1.39 1/4 on foreign exchange here today while the French franc, held steady even at 2.70 9-32 cents. The United States dollar advanced 1-16 per cent to 11-16 per cent premium.
