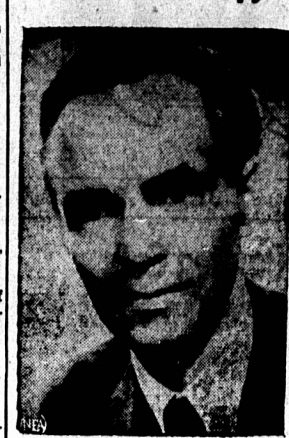

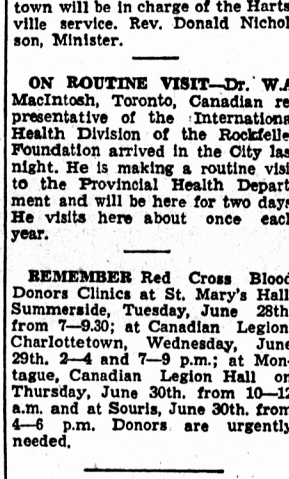

LARGE INCREASE (Continued from Page 1) Charlottetown and Newfoundland ports, particularly pressing old storage facilities on this boat. The Provincial Government, through their newly formed Crown Company, have since purchased a boat and it is now operating with considerable success on this route. Urging the Canadian National Railways, as agents for the Department of Transport to have the two ferries planked on the lower deck to aid in truck transportation. In this request, action was also received and our appreciation goes to those who were responsible. Asking the Department of Transport to strengthen the loading ramps at Cape Tormentine, N.B., and Borden, P.E.I. in order to carry heavy truckloads of freight, and while this has not been acted upon as yet, it would appear that it will be included in the construction of the new loading piers at Cape Tormentine and Borden.
