An important meeting convened by Mr. Adam Andrew, Los Angeles, Calif., was held in the office of the Superintendent of Education for the purpose of organizing the body which is to have charge of the administration, etc., of the proposed "Easy School Library Scheme." The meeting was called to order by Mr. H. H. Shaw, there being present Mr. Andrew, Hon. F. J. Nash, Hon. C. Gavin Duffy, Mr. R. H. Rogers and Mr. J. R. Burnett. Mr. Andrew explained that his objective was to have a scheme in every school, and he himself was prepared to provide the funds to make a beginning. It would be necessary, however, to raise funds for books for all the 400 or 500 schools, and he thought this could be done by appealing to old school boys from each settlement at home and abroad to contribute money to provide the books. He thought the Women's Institutes could be successfully applied to organize for these contributions, and to supervise the local libraries which would be charged to the settlement. Mr. Andrew in order to put the scheme into operation he had asked Messrs. Nash, Duffy and Burnett to form a commission with Mr. R. H. Rogers as secretary-treasurer, and the Superintendent of Education as advisers. This commission would have full power and discretion in giving effect to his wishes in order to make the library scheme a success. On motion it was decided to call the new body "The Adam Andrew Library Commission," and Mr. Nash was elected chairman, Mr. Rogers as secretary-treasurer. After discussion it was decided to wait upon the new government to ascertain what support could be obtained from it in the way of providing uniform books for each school regarding them. Mr. Andrew was heartily thanked for the generous support he had given in inaugurating the scheme, and in reply said he had

from his boyhood days cherished the idea of having some such scheme successfully launched in his native province.

Events following the seizure of the Nellie J. Banks by the Bayfield a short time ago, are following in quick succession. Immediately after the seizure of the vessel Capt. Dicks, owner of the schooner sought legal redress claiming the seizure of the vessel on the high seas was an act of piracy. Last night Chief Preventative Officer Barbour ordered the arrest of the Captain while the latter was attending to the management of the seized vessel at the Marine Wharf. Capt. Dicks had yesterday afternoon obtained papers from the Sheriff giving him charge of the schooner. Yesterday evening Capt. Dicks went down to the Marine Wharf to arrange for the night watch. When he arrived he found the vessel in possession of Preventative Officer Barbour, Prohibition Inspector Bradley and Police Officer Dominic Piro who, it is claimed, were in the process of dismantling her. Capt. Dicks protested this action of the officers and proceeded to board his vessel on the strength of the papers he had received from Sheriff Douglas. Mr. Barbour would not recognize the order and a short altercation took place, resulting in the arrest of Capt. Dicks on the charge of obstructing a Customs Officer while in the discharge of his duties. He was taken to the Police Station where he asked for bail. This was granted about midnight on the arrival of Stipendiary Magistrate Martin, who was sent for at Belle River, where he was spending a holiday. Mr. J. J. Johnson, K. C. was called in by Capt. Dicks on the moment of his arrest, to represent him in the case which will be heard this morning before the Magistrate. It is reported that Capt. Dicks will issue warrants against Mr. Barbour, Mr. Bradley and Police Officer Doyle, for their causing his arrest.
