president reminded the canvassers that the drive should not be looked upon as a work of charity, but as a purely business proposition in which people invest. In a number of cases subscriptions have doubled, while many new subscribers have paid up with still others in prospect. Prowse Bros. have been the largest individual subscribers this year so far paying \$200. This firm has always been one of the largest subscribers increasing in \$50 installments each year. Several others have contributed \$100 while a number of \$75 and \$50 contributions have also been received.

The president expressed his pleasure over the success of the function and expressed his gratitude to Mr. Harry Brown, proprietor of the Queen Hotel through whose courtesy the banquet was made possible. Despite the existence of the new hotel the Queen is always assured of success and will maintain its deserved popularity. The statement, Mr. Justice Arsenault continued, made by a few people to the effect that home coming tourists are spongers on their families is an absolute fallacy. Very few of the tourists are home comers, and those that are homecomers are never spongers, since each and every one of them spend large sums of money while in the province and often buy improved implements for the farms that were once their homes. Ready information, rendered in a pleasant matter, makes the Tourist Bureau in the city one of the best in Canada. The gratitude of many tourists towards the secretary evidenced itself during the Christmas season. It was a compliment to the smallest province of Canada that an Islander was elected president of the Canadian tourist body.

Mr. S. A. MacLeod stated that it is through work as that done by the Tourist Bureau that Charlottetown has the improvements which it has today. "We are getting a new Car Ferry because we have created a business for it. The tourist business is also partly responsible. Better roads and accommodations are necessary. The government will be forced to give better roads. The money must be forth coming. The Rotary Club and Gyro Club have given excellent reports. So far \$1320 have been collected. In every case the same amount or increased amounts have been received. The government will give the same grant as last year.

GRAND JURY'S REPORT

Returning from the inspection of Falconwood Hospital, the infirmary and Queens County Jail at 5 p. m., the Grand Jury through its foreman, reported the asylum in splendid condition. More fire escapes and a new staircase were recommended. Reference to the long and faithful service of Mr. Abraham Bonnell, supervisor, was also made. The infirmary was reported clean and homelike and in excellent condition. The jail was reported over-crowded with thirty-nine prisoners confined whereas there is room for only thirty. Two cases of venereal disease were reported in the institution. The building was as clean as it possibly could be under the circumstances. Six cells in the institution were reported condemned. It is possible, the Grand Jury report added, for conversation to be carried on from the windows of the cells with people outside.

Herman Barrett vs. Elias Nicolas Keys. The case of the Eastern Trust Company, Trustee, vs. W. Philip Billard, an action for debt, was disposed of at the morning session. Mr. J. D. Stewart, K. C., for the plaintiff read the defendant's withdrawal of the plea and confession of judgment for \$74.87. Judgment was given accordingly.

Charge to Grand Jury.

The Chief Justice in delivering his charge to the Grand Jury pointed out that its duties this term would be lighter than those of its predecessors. The placing on the desk of a pair of white gloves by the sheriff was emblematic of the absence of serious crime. Although no bills of indictment have been brought, there remains the duty upon the Grand Jury of bringing to light any serious crime within their knowledge.

The records of former days show that remarkable changes have taken place during the last fifty years. His Lordship continued. In 1880 the Grand Jury brought down three separate presentations of cases not previously charged. The Grand Jury of that time, consisting of twenty-four members, came in on January 13, and were still in session one week later, bringing in the new presentations. As a result sentences aggregating twenty-five years in the penitentiary and two years in the county jail were given. The absence of any serious crime at this term, preceded by another term with a similar record, was worthy of comment. The improvement, it was pointed out, may not be so great as it seemed on the surface, on account of cases being now tried summarily before the magistrate. The jailer reports thirty-nine prisoners in confinement in Queens County Jail at the present time. If the Grand Jurors have any recommendations concerning the jail or its inmates to aid the government or enlighten the public to its advantage they should be made known. It was a Grand Jury. His Lordship said, that many years ago discovered the awful condition of the inmates of the Asylum, and brought about the reform that has continued progressively since that time. A jury is thus a charitable institution.

The Chief Justice stated that last Tuesday he and Mr. Justice Hazard visited Falconwood Hospital and the infirmary. In the former institution there are 268 inmates, the lowest number for fifteen years, showing a decline of forty-nine from the maximum number. In this hospital there is every evidence of cleanliness, orderliness, comfort and efficiency. The latter quality is particularly noticeable in the alert staff.

During the last year the nurses' school has been affiliated with those of the Charlottetown Hospital and the P. E. Island Hospital, a step of the greatest importance, as the nurses have a special interest in mastering their subjects, a pride in their service, and a striving toward a high standard. The staff from the medical superintendent down is doing its duty splendidly. One member of the staff, Mr. Abraham Bonnell, has been in the service forty-six years, twenty-five years of which he has served as supervisor and burser. It would be difficult to find a more capable or competent public servant, but this does not express his highest value. Among the afflicted his service is most beneficent, and after almost half a century of service he has earned and needs a rest. This matter was recommended to the jury for its consideration.

Mr. Justice Hazard stated that the changed condition of Falconwood Hospital over that of some years ago is surprising. The inmates have changed remarkably. One is struck by the absence of any element that would cause irritation to the patients, staff or visitors. Such a degree of contentment is surprising in such an institution, and speaks well of the work of the staff. Special reference was made by Mr. Justice Hazard to the work of Mr. Bonnell, to whom ample recognition should be given on his retirement.

Material from the Convalescent Home has been used for repair work, good hardwood floors being laid in some of the rooms, in most cases by the inmates, the Court continued.

Admitted to Bar.

On the motion of Mr. J. D. Stewart, K. C., Mr. Michael Allan Farmer was admitted to the Bar. Mr. Farmer had secured his degree of B. A. at Laval University, had passed through Dalhousie Law School, studied law in the offices of Mr. J. Augustine McDonald and Mr. J. O. C. Campbell.

Chief Justice Matheson welcomed the newly admitted member to the Bar, commenting on his excellent record at Dalhousie, and expressed the confident hope that he would always be a valuable member. Justices Hazard and Arsenault endorsed the

Late Market News

MONTREAL AND TORONTO IMPORTING U. S. EGGS QUITE FREELY—6,800 MORE BOXES NEW ZEALAND BUTTER ARRIVE—MORE COMING.

(Canadian Press) OTTAWA, Ont. Jan. 14.—Both Montreal and Toronto are now importing United States eggs quite freely. Domestic prices at both points are unchanged, but a decidedly weaker market is reported from the Maritimes.

Toronto.—The egg market here continues easy and unchanged. Some small lots of U. S. fresh are arriving and are costing delivered about extras 54, firsts 53, pile, extras 51 1-2. There have also been two cars of U. S. storage eggs brought in, Montreal. Egg receipts here today were 1,355 cases as compared to 2,844 cases a year ago. The market is steady today as the recent decline. Receipts of American fresh eggs are heavier and two cars arrived today, one from Missouri and one from the Pacific Coast. Fresh eggs are being offered from Chicago today at 38 cents F. O. B. and storage eggs at 35 cents.

St. John.—This egg market is lower under increasing receipts and prices are very irregular. Dealers are quoting country shippers delivered cases returned extras 50-52; firsts 40 42; seconds 30-32. Halifax.—While there has been no change on this egg market over the week end, the undertone is decidedly weaker and lower prices are anticipated shortly. Supplies are coming forward freely and are sufficient for the trade.

MONTREAL, Que. Jan. 14.—New Zealand butter continues to arrive in Montreal, receipts being posted over 6,800 boxes today, each box representing 56 pounds of butter, most is expected tomorrow. With the subsequent drop in prices, dealers are quoting 37 cents a pound for New Zealand finest to the retail trade. So lids are 40 cents and prints 41 cents a pound. No changes are reported in the egg or poultry markets, both remaining firm. Cheese is inactive with prices nominally steady.

The potato market is firm with prices ranging from \$1.95 to \$2.00 per 90 pounds in bulk ex track here for Quebec's and New Brunswick's, and \$2.35 to \$2.45 for Prince Edward Island varieties.

Abegweits Lose To Crystals 5-3

(Special to the Guardian) SUMMERSIDE, Jan. 14.—With an even score in the league series and out for blood, the Abegweits and Crystals met again for the third encounter on a splendid sheet of ice at the Crystal rink, Summerside, tonight, and some dashing breaking taking hockey was given out to the twelve hundred enthusiastic fans in attendance. Jack Wright played with the Crystals for the first time this season and with his body checking and other well known defensive tactics proved more than once the Abegweits undoing. The game throughout was remarkably clean and the penalties were too few to mention. Carroll's coaching was quite in evidence in the Crystals work.

The game started at 8.30 and opened with a bang. Before two minutes remarks of Chief Justice Matheson and added personal congratulations.

Judgments Delivered. Shaw McMillan vs. Daniel McGregor: This case was tried at the last July term of the Supreme Court at Georgetown before Mr. Justice Arsenault and a jury. A verdict was given for the plaintiff. At the last Michaelmas term the defendant moved to set aside the verdict and for a new trial. Mr. Justice Hazard gave judgment dismissing the defendant's motion. The Chief Justice concurred. Messrs. J. D. Stewart, K. C., and N. W. Lowther, for the plaintiff; Mr. J. J. Johnston, K. C., for the defendant.

Jones vs. Horne and Ans.: This case was tried at the last Trinity term in Charlottetown before Mr. Justice Hazard and a special jury, when the verdict was entered for the plaintiff for \$400 damage. At the last Michaelmas term the defendant moved for a non-suit, or in the alternative a new trial. Mr. Justice Arsenault gave judgment declining to grant non-suit, but granting a new trial, with costs reserved. Chief Justice concurred. Mr. J. J. Johnston, K. C., and McPhee for the plaintiff; Messrs. W. E. Bentley, K. C., and Mr. J. D. Stewart, K. C., for defendant.

The final period opened slightly slower than the preceding sessions in that no score was made until after eight minutes of play. Then Siliphant getting by the Abegweits with difficulty, scored the last goal for the Crystals. Then the Abegweits mixed things after this and some minutes later Saunders and Lawlor in a pretty piece of combination work rung the Abegweits second tally. This was almost immediately followed by Lawlor scoring a further goal for the Abegweits who were making a valiant attempt to bring down the Crystal lead.
