GOVERNMENT EXPENDITURE. OTTAWA, Dec 3.—The estimates were brought down last evening. They provide for a total expenditure of \$138,863,290, an increase of \$6,035,575. Of this enormous sum the Consolidated Fund expenditure amounts to \$100,674,627, an increase over the current year of \$5,095,717. The expenditure on Capital account is \$38,188,573, an increase of \$939,858.

The items of capital expenditure, are Railways and Canals, \$33,845,573; Public Works, \$2,763,900; Marine, \$1,580,000. Of the capital expenditure on Railways and Canals, \$1,504,969 goes to the Intercolonial; \$83,863 to the P. E. J. Railway; \$27,000,000 to the Transcontinental; \$2,000,000 to the Quebec Bridge, and 3,156,750 to the Canals.

nary similarity between the majorities and those of last January.

The weather was cold and stormy, this doubtless preventing as large a vote as was expected.

Mr. Churchill was refused hearing at Lincoln yesterday.

Custom forbids speech-making on polling days and the Opposition was so persistent that the Home Secretary was obliged to desist and to give pledges that he would not attempt again to speak.

During the rumpus, there were several free fights in the audience.

In a speech at Walsall, John Redmond, the Irish leader, said the Irish party were willing and anxious that the principle of Home Rule be submitted to a referendum of the British people.

LONDON, December 2.—The few days of discussion in the election campaign leaves it clear that the liberals as a party will reform.

All the liberal leaders, from Premier Asquith and Lord Rosebery, president of the council, down, in their public speeches since the pronouncement of A. J. Balfour, the opposition leader, of his willingness to leave tariff reform to the referendum, have freely deprecated the referendum as being unsuited to Great Britain, and as tending to destroy the responsibility of representative institutions.

Meaning, however, further hamilitarity with the idea has had the effect of uniting the whole unionist party and press in its favor, and Mr. Balfour's courage in adopting it is hailed now as having secured for his party an excellent prospect of victory at elections. It is a curious fact that at the time of the rupture of the recent veto conference an inspired statement in the Times asserted that both sides to the conference had rejected the idea of a referendum.

If that be the case Mr Balfour's decision must have been an afterthought, and it is asserted in well-informed quarters tonight that the first consulted Joseph Chamberlain and secured his acquiescence before proceeding temporarily to shelve tariff reform by urging recourse to the referendum.

which entering the water and in this case no condition of the body is left whereby a doctor may be guided in forming, an opinion as to the cause of death. In reference to the mark on the head he said it was not a fatal injury, any such fatal injury being at all times easily discernable.

As to the probable method of receiving, that would in my opinion from its location, seem to be the result of a blow or a fall, altho it is not likely the latter. It probably was inflicted before death, judging from the bruise which presented no signs of healing. It probably occurred within twenty-four or forty-eight hours of death. The state of digestion of food in the stomach, is gaged by the food itself. Pork required four hours to digest. Beans and potatoes three and one half hours. Alcohol interfered with digestion lengthening the process. Skerry was healthy. I was for fourteen years the physician of him and his family. The process of the digestion of the food in the stomach was nearly completed. He thought in probably three or four hours or longer digestion would be completed, likely between the hours of twelve and two. In this case he could not state definitely there were so many factors to be considered. In death by drowning the lungs

may become filled with water, this is positive evidence. They may become readily empty. In general cases water may be found in the stomach.

Here interrogative by Mr. Bell. Witness described the condition of the lungs, stomach and heart, along the same lines as that contained in his evidence of yesterday and explained certain conditions giving indications of drowning. The wound on the head was likely caused by some blunt smooth object. It might be a bottle. Cross-examined by Mr. McQuarrie.
